A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16n of chapter XVII (MCL 777.16n), as amended
by 2002 PA 321.

CHAPTER XVII

Sec. 16n. This chapter applies to the following felonies
