SUBSTITUTE FOR

HOUSE BILL NO. 4656

A bill to amend 1954 PA 116, entitled "Michigan election law,"

(MCL 168.1 to 168.992) by adding section 931a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 931A. (1) NOTWITHSTANDING ANY PROVISION OF LAW TO THE
- 2 CONTRARY, AND EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (2), THE
- 3 NAME OF AN ELECTED OR APPOINTED OFFICIAL OF THIS STATE OR A
- 4 POLITICAL SUBDIVISION OF THIS STATE SHALL NOT APPEAR ON ANY BALLOT-
- 5 RELATED MATERIAL THAT IS PROVIDED TO AN ELECTOR. AS USED IN THIS
- 6 SECTION, "BALLOT-RELATED MATERIAL" INCLUDES ANY OF THE FOLLOWING:
- 7 (A) ANY MATERIAL PROVIDED TO AN ELECTOR WITH AN ABSENT VOTER
- 8 BALLOT.
- 9 (B) ABSENT VOTER BALLOT INSTRUCTIONS.
- 10 (C) AN ENVELOPE USED TO MAIL TO AN ELECTOR AN ABSENT VOTER
- 11 BALLOT OR ANY OTHER BALLOT MATERIAL.

- (D) AN ABSENT VOTER BALLOT RETURN ENVELOPE. 1
- (2) ANY BALLOT-RELATED MATERIAL PRINTED OR PREPARED BEFORE THE 2
- 3 EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS SECTION THAT
- CONTAINS THE NAME OF AN ELECTED OR APPOINTED OFFICIAL OF THIS STATE 4
- OR A POLITICAL SUBDIVISION OF THIS STATE MAY BE USED IF THE ELECTED 5
- OR APPOINTED OFFICIAL WHOSE NAME APPEARS ON THE BALLOT-RELATED 6
- MATERIALS IS NOT A CANDIDATE AT THE ELECTION IN WHICH THOSE BALLOT-7
- RELATED MATERIALS ARE BEING USED. 8
- (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A 9
- 10 MISDEMEANOR PUNISHABLE BY A FINE OF NOT MORE THAN \$100.00 FOR A
- 11 FIRST OFFENSE AND IS GUILTY OF A MISDEMEANOR PUNISHABLE BY A FINE
- 12 OF NOT MORE THAN \$250.00 FOR A SECOND OR SUBSEQUENT OFFENSE.
