SUBSTITUTE FOR

HOUSE BILL NO. 5135

A bill to amend 2008 PA 549, entitled "Michigan promise zone authority act," by amending sections 7 and 15 (MCL 390.1667 and 390.1675).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 7. (1) A promise zone authority created under section 5
- 2 shall prepare a promise zone development plan.
- $\bf 3$ (2) The $\bf A$ promise zone development plan shall include, but is
- 4 not limited to, all of the following:
- 5 (a) A complete description of the proposed promise of
- 6 financial assistance. The proposed promise of financial assistance
- 7 shall include, but is not limited to, a promise of financial
- 8 assistance to all **ELIGIBLE** students residing within the promise
- 9 zone and who graduate from a public high school or nonpublic high

- 1 school located within that promise zone, IN AN AMOUNT ESTABLISHED
- 2 BY THE BOARD TO REFLECT THE AMOUNT AVAILABLE FOR DISBURSEMENT TO
- 3 ELIGIBLE STUDENTS AND INCLUDED IN THE ANNUAL BUDGET UNDER SECTION
- 4 15. The AMOUNT OF proposed promise of financial assistance shall,
- 5 at a minimum, provide funding EQUAL OR EXCEED THE AMOUNT THE BOARD
- 6 DETERMINES IS sufficient to provide PAY FOR THE TUITION NECESSARY
- 7 FOR an eligible student the tuition necessary to obtain an
- 8 associate degree or its equivalent at A CERTIFICATE FROM a
- 9 community or junior college in this state, or combination of
- 10 community or junior colleges in this state and, at most, provide
- 11 funding sufficient to provide an eligible student the tuition
- 12 necessary OR TO COMPLETE A VOCATIONAL PROGRAM, AND SHALL NOT EXCEED
- 13 THE AMOUNT THE BOARD DETERMINES IS SUFFICIENT TO PAY FOR THE
- 14 TUITION NECESSARY FOR AN ELIGIBLE STUDENT to obtain a bachelor's
- 15 degree or its equivalent at a public postsecondary institution in
- 16 this state or combination of public postsecondary institutions in
- 17 this state, subject to any limitations authorized under this
- 18 section. The proposed promise of financial assistance may also, at
- 19 most, provide funding for an eligible student to attend a private
- 20 college in this state in an amount not to THAT DOES NOT exceed the
- 21 average tuition necessary to obtain a bachelor's degree at all
- 22 public universities in this state. The proposed promise of
- 23 financial assistance may also authorize the expenditure of funds
- 24 for educational improvement activities designed to increase
- 25 readiness for postsecondary education at public schools located in
- 26 the promise zone. AS USED IN THIS SUBDIVISION, "VOCATIONAL PROGRAM"
- 27 MEANS AN EDUCATION OR TRAINING PROGRAM INTENDED TO TEACH A TRADE,

- 1 OCCUPATION, OR VOCATION AND OFFERED BY A PUBLIC OR PRIVATE
- 2 POSTSECONDARY INSTITUTION IN THIS STATE.
- 3 (b) A complete description of any limitation on the promise of
- 4 financial assistance, ; if INCLUDING, BUT NOT LIMITED TO, ANY OF
- 5 THE FOLLOWING:
- 6 (i) IF the promise of financial assistance will be prorated
- 7 based on the number of years the student has resided within the
- 8 promise zone. ; if
- 9 (ii) IF the promise of financial assistance will be restricted
- 10 to students who have resided within or attended a public high
- 11 school or nonpublic high school within the promise zone for a
- 12 minimum number of years. ; if
- 13 (iii) IF the promise of financial assistance is predicated on
- 14 the student maintaining a minimum college grade point average and
- 15 carrying a minimum college credit hour classload. ; or if
- 16 (iv) IF the promise of financial assistance is restricted to
- 17 attendance at 1 or more public or private postsecondary
- 18 institutions in this state.
- 19 (v) IF THE PROMISE OF FINANCIAL ASSISTANCE IS LIMITED TO
- 20 STUDENTS WHOSE CUMULATIVE HIGH SCHOOL GRADE POINT AVERAGE EXCEEDS A
- 21 SPECIFIED MINIMUM. HOWEVER, A BOARD MAY REVISE, ESTABLISH, OR
- 22 ELIMINATE A HIGH SCHOOL GRADE POINT AVERAGE REQUIREMENT FOR
- 23 STUDENTS AFTER IT SUBMITS A PROMISE ZONE DEVELOPMENT PLAN TO THE
- 24 DEPARTMENT OF TREASURY AND IS NOT REQUIRED TO AMEND THE PLAN OR
- 25 OBTAIN APPROVAL FROM THE DEPARTMENT OF TREASURY FOR THAT CHANGE.
- (c) A requirement that graduates of a public high school or
- 27 nonpublic high school exhaust all other known and available

- 1 restricted grants for tuition and fees for postsecondary education
- 2 provided by a federal, state, or local governmental entity, as
- 3 determined by the board.
- 4 (d) How the funds necessary to accomplish the promise of
- 5 financial assistance will be raised. Any amount received under the
- 6 state school aid act of 1979, 1979 PA 94, MCL 388.1601 to 388.1772,
- 7 388.1896, shall not be included as a method of raising the
- 8 necessary funds. The promise zone development plan shall be
- 9 financed from 1 or more of the following sources:
- 10 (i) Donations.
- 11 (ii) Revenues.
- 12 (iii) Money obtained from other sources approved by the
- 13 governing body or otherwise authorized by law.
- 14 (e) An actuarial model of how much the proposed plan is
- 15 estimated to cost, based on actuarial formulas developed by the
- 16 department of treasury.
- 17 (3) The proposed promise of financial assistance under
- 18 subsection (2) shall not include funding for attendance at a public
- 19 or private postsecondary institution not located in this state.
- 20 (4) The board shall submit the promise zone development plan
- 21 to the department of treasury promptly after its adoption. The
- 22 promise zone development plan shall be published on the website of
- 23 the eligible entity that established the promise zone.
- 24 (5) The department of treasury shall review the promise zone
- 25 development plan submitted under subsection (4). Not more than 60
- 26 days after receipt of a promise zone development plan submitted
- 27 under subsection (4), the department of treasury shall either

- 1 approve the promise zone development plan or provide a written
- 2 notice of deficiencies. If the department of treasury does not
- 3 approve a promise zone development plan submitted under subsection
- 4 (4) or provide a written notice of deficiencies within 60 days, the
- 5 promise zone development plan shall be considered approved. If a
- 6 promise zone development plan is approved, the department of
- 7 treasury shall certify that the promise zone development plan meets
- 8 all requirements under this act and is sustainable.
- 9 (6) The department of treasury shall review any proposed
- 10 amendments to a promise zone development plan. Not more than 60
- 11 days after receipt of proposed amendments to a promise zone
- 12 development plan, the department of treasury shall either approve
- 13 the proposed amendments or provide a written notice of
- 14 deficiencies. If the department of treasury does not approve
- 15 proposed amendments or provide a written notice of deficiencies
- 16 within 60 days, the proposed amendments shall be considered
- 17 approved. If proposed amendments are approved, the department of
- 18 treasury shall certify that the amendments meet all requirements
- 19 under this act.
- Sec. 15. (1) The director of the authority shall submit a
- 21 budget to the board for the operation of the authority for each
- 22 fiscal year before the beginning of the fiscal year. The budget
- 23 shall be prepared in the manner and contain the information
- 24 required of municipal departments. After review by the board, the
- 25 budget shall be submitted to the governing body. The governing body
- 26 must approve the budget before the board may adopt the budget.
- 27 Unless authorized by the governing body, funds of the eligible

- 1 entity shall not be included in the budget of the authority.
- 2 (2) THE BUDGET DESCRIBED IN SUBSECTION (1) SHALL INCLUDE THE
- 3 AMOUNT THE AUTHORITY INTENDS TO DISBURSE TO EACH ELIGIBLE STUDENT
- 4 IN THE FISCAL YEAR COVERED BY THE BUDGET. SUBJECT TO THE MAXIMUM
- 5 AMOUNTS DESCRIBED IN SECTION 7(2)(A), THE BOARD SHALL ESTABLISH THE
- 6 AMOUNT OF THE ANNUAL PAYMENT TO ELIGIBLE STUDENTS AND, IN MAKING
- 7 THAT DETERMINATION, SHALL CONSIDER THE FINANCIAL RESOURCES
- 8 AVAILABLE TO THE AUTHORITY FOR DISBURSEMENT TO THOSE STUDENTS.
