SENATE SUBSTITUTE FOR HOUSE BILL NO. 5103

A bill to amend 1961 PA 236, entitled

"Revised judicature act of 1961,"

by amending sections 8121 and 8123 (MCL 600.8121 and 600.8123), as amended by 2011 PA 300.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 2 Livonia, is a district of the third class, and has 2 judges.
