SENATE SUBSTITUTE FOR HOUSE BILL NO. 5125

A bill to amend 1909 PA 283, entitled

"An act to revise, consolidate, and add to the laws relating to the establishment, opening, discontinuing, vacating, closing, altering, improvement, maintenance, and use of the public highways and private roads; the condemnation of property and gravel therefor; the building, repairing and preservation of bridges; maintaining public access to waterways under certain conditions; setting and protecting shade trees, drainage, and cutting weeds and brush within this state; providing for the election or appointment and defining the powers, duties, and compensation of state, county, township, and district highway officials; and to prescribe penalties and provide remedies,"

by amending section 6 of chapter IV (MCL 224.6), as amended by 2009 PA 39.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 CHAPTER IV

2 Sec. 6. (1) Except as OTHERWISE provided BY LAW AND under

- 1 subsection (4), or (5), (7), OR (8), in a county where the county
- 2 road system is adopted, a board of county road commissioners
- 3 consisting of not less than 3 members or more than 5 members shall
- 4 be elected by the people of the county. The initial road
- 5 commissioners shall be appointed by the county board of
- 6 commissioners or elected at a general or special election called
- 7 for that purpose, as determined by the county board of
- 8 commissioners. The county board of commissioners may by resolution
- 9 provide for staggered terms of office for the road commissioners
- 10 under this subsection so that not more than 2 road commissioners'
- 11 terms of office expire in the same year.
- 12 (2) If the road commissioners are appointed, they shall hold
- 13 office only until January 1 of the first odd numbered year

- 17 of commissioners, giving the number and terms of the office of the

- 20 (3) The regular election of county road commissioners shall be
- 21 held at the general election on the first Tuesday after the first
- 22 Monday in November. The term of office of an elected county road
- 23 commissioner shall commence on January 1 in the year following his
- 24 or her election. The notice of the election shall be given at the
- 25 time notice is given of the general election of county officers.
- 26 (4) The election of county road commissioners shall not be
- 27 mandatory in any county that contains all or part of 12 surveyed

- 2 Except as provided under subsection (5), in a county under this

- 14 charter. In a county having a population of 750,000 or more with a
- 15 charter commission proposing a charter under 1966 PA 293, MCL
- 16 45.501 to 45.521, the powers and duties that are otherwise provided
- 17 by law for a board of county road commissioners may be reorganized
- 18 under the charter if, at the election considering the approval of
- 19 the charter, the voters approve both the charter and a separate
- 20 ballot question presented by the charter commission to reorganize
- 21 the board of county road commissioners. Funds provided to the
- 22 county under 1951 PA 51, MCL 247.651 to 247.675, shall only be
- 23 expended for the purposes provided under 1951 PA 51, MCL 247.651 to
- **24** 247.675.
- 25 (6) If the county board of commissioners proposes to alter the
- 26 number of county road commissioners as allowed under this act, the
- 27 county board of commissioners shall hold not less than 1 public

- 1 hearing on the proposed change to the road commission. The county
- 2 board of commissioners shall give notice as required under the open
- 3 meetings act, 1976 PA 267, MCL 15.261 to 15.275, of the time and
- 4 place of the public hearing not less than 28 days before the
- 5 hearing. The county board of commissioners shall also provide
- 6 written notice of the hearing to the county road commission and, if
- 7 available, by posting the notice on the county's website. The
- 8 county board of commissioners may vote on whether to alter the
- 9 number of county road commissioners at the meeting noticed under
- 10 this subsection.

- 22 (8) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (5) AND SUBJECT
- 23 TO THE REQUIREMENT PROVIDED IN SUBSECTION (9), BEFORE JANUARY 1,
- 24 2015, THE COUNTY BOARD OF COMMISSIONERS IN A COUNTY WITH AN ELECTED
- 25 BOARD OF COUNTY ROAD COMMISSIONERS MAY, BY A RESOLUTION AS ALLOWED
- 26 UNDER SECTION 11 OF 1851 PA 156, MCL 46.11, SUBMIT TO THE QUALIFIED
- 27 AND REGISTERED ELECTORS OF THE COUNTY AT THE NEXT REGULAR ELECTION

- TO BE HELD IN THE COUNTY THE QUESTION OF TRANSFERRING THE POWERS, 1

- 12 (9) BEFORE ADOPTING A RESOLUTION UNDER SUBSECTION (7) OR (8),
- 13 THE COUNTY BOARD OF COMMISSIONERS SHALL CONDUCT, AT A MINIMUM, 2
- 14 PUBLIC HEARINGS ON WHETHER TO TRANSFER THE POWERS, DUTIES, AND
- FUNCTIONS OF THE BOARD OF COUNTY ROAD COMMISSIONERS TO THE COUNTY 15
- BOARD OF COMMISSIONERS. 16
