## HOUSE SUBSTITUTE FOR SENATE BILL NO. 461

A bill to amend 1998 PA 386, entitled
"Estates and protected individuals code,"
by amending sections 2802, 2803, 2804, 5314, 5315, 5316, 5410,
5422, and 5423 (MCL 700.2802, 700.2803, 700.2804, 700.5314,
700.5315, 700.5316, 700.5410, 700.5422, and 700.5423), section 5314
as amended by 2000 PA 469, section 5316 as amended by 2000 PA 54,
and section 5423 as amended by 2005 PA 204, and by adding section
5306a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2802. As used in this section and sections 2803 and 2804:
- 2 (A) "ABUSE, NEGLECT, OR EXPLOITATION" MEANS AN ACT, THE
- 3 COMMISSION OF WHICH IS A FELONY, UNDER ANY OF THE FOLLOWING:
- 4 (i) AN ACT THAT CONSTITUTES CHILD ABUSE UNDER SECTION 136B OF

- 1 THE MICHIGAN PENAL CODE, 1931 PA 328, MCL 750.136B.
- 2 (ii) A CRIMINAL ACT THAT IS AN OFFENSE UNDER CHAPTER XXA OF THE
- 3 MICHIGAN PENAL CODE, 1931 PA 328, MCL 750.145M TO 750.145R.
- 4 (iii) A VIOLATION OF SECTION 174A OF THE MICHIGAN PENAL CODE,
- 5 1931 PA 328, MCL 750.174A.
- 6 (iv) A CRIMINAL ACT THAT IS AN OFFENSE INVOLVING DOMESTIC
- 7 VIOLENCE AS THAT TERM IS DEFINED IN SECTION 27B OF CHAPTER VIII OF
- 8 THE CODE OF CRIMINAL PROCEDURE, 1927 PA 175, MCL 768.27B.
- 9 (v) A CRIMINAL ACT THAT CONSTITUTES ABUSE, NEGLECT, OR
- 10 EXPLOITATION AS THOSE TERMS ARE DEFINED IN SECTION 11 OF THE SOCIAL
- 11 WELFARE ACT, 1939 PA 280, MCL 400.11.
- 12 (B) (a) "Disposition or appointment of property" includes, but
- 13 is not limited to, a transfer of an item of property or another
- 14 benefit to a beneficiary designated in a governing instrument.
- 15 (C) "FELON" MEANS THE INDIVIDUAL WHO WAS CONVICTED OF
- 16 COMMITTING THE ABUSE, NEGLECT, OR EXPLOITATION.
- 17 (D) (b) "Governing instrument" means a governing instrument
- 18 executed by the decedent.
- 19 (E) (c) "Revocable" means, with respect to a disposition,
- 20 appointment, provision, or nomination, one under which the
- 21 decedent, at the time of or immediately before death, was alone
- 22 empowered, by law or under the governing instrument, to cancel the
- 23 designation in favor of the killer OR FELON, whether or not the
- 24 decedent was then empowered to designate himself or herself in
- 25 place of his or her killer OR FELON and whether or not the decedent
- 26 then had the capacity to exercise the power.
- Sec. 2803. (1) An individual who feloniously and intentionally

- 1 kills or who is convicted of committing abuse, neglect, or
- 2 EXPLOITATION WITH RESPECT TO the decedent forfeits all benefits
- 3 under this article with respect to the decedent's estate, including
- 4 an intestate share, an elective share, an omitted spouse's or
- 5 child's share, a homestead allowance, a family allowance, and
- 6 exempt property. If the decedent died intestate, the decedent's
- 7 intestate estate passes as if the killer OR FELON disclaimed his or
- 8 her intestate share.
- 9 (2) The felonious and intentional killing OR THE CONVICTION OF
- 10 THE FELON FOR THE ABUSE, NEGLECT, OR EXPLOITATION of the decedent
- 11 does all of the following:
- 12 (a) Revokes all of the following that are revocable:
- 13 (i) Disposition or appointment of property made by the decedent
- 14 to the killer OR FELON in a governing instrument.
- 15 (ii) Provision in a governing instrument conferring a general
- 16 or nongeneral power of appointment on the killer OR FELON.
- 17 (iii) Nomination of the killer OR FELON in a governing
- 18 instrument, nominating or appointing the killer OR FELON to serve
- 19 in a fiduciary or representative capacity, including a personal
- 20 representative, executor, trustee, or agent.
- 21 (b) Severs the interests of the decedent and killer OR FELON
- 22 in property held by them at the time of the killing, ABUSE,
- 23 NEGLECT, OR EXPLOITATION as joint tenants with the right of
- 24 survivorship, transforming the interests of the decedent and killer
- 25 OR FELON into tenancies in common.
- 26 (3) A severance under subsection (2)(b) does not affect a
- 27 third party interest in property acquired for value and in good

- 1 faith reliance on an apparent title by survivorship in the killer
- 2 OR FELON unless a writing declaring the severance has been noted,
- 3 registered, filed, or recorded in records appropriate to the kind
- 4 and location of the property that are relied upon, in the ordinary
- 5 course of transactions involving that type of property, as evidence
- 6 of ownership.
- 7 (4) A provision of a governing instrument is given effect as
- 8 if the killer OR FELON disclaimed all provisions revoked by this
- 9 section or, in the case of a revoked nomination in a fiduciary or
- 10 representative capacity, as if the killer OR FELON predeceased the
- 11 decedent.
- 12 (5) A killer's OR FELON'S wrongful acquisition of property or
- 13 interest not covered by this section shall be treated in accordance
- 14 with the principle that a killer OR FELON cannot profit from his or
- 15 her wrong.
- 16 (6) After all right to appeal has been exhausted, a judgment
- 17 of conviction establishing criminal accountability for the
- 18 felonious and intentional killing OR THE ABUSE, NEGLECT, OR
- 19 EXPLOITATION of the decedent conclusively establishes the convicted
- 20 individual as the decedent's killer OR AS A FELON, AS APPLICABLE,
- 21 for purposes of this section. In WITH RESPECT TO A CLAIM OF
- 22 FELONIOUS AND INTENTIONAL KILLING, IN the absence of a conviction,
- 23 the court, upon the petition of an interested person, shall
- 24 determine whether, under the preponderance of evidence standard,
- 25 the individual would be found criminally accountable for the
- 26 felonious and intentional killing of the decedent. If the court
- 27 determines that, under that standard, the individual would be found

- 1 criminally accountable for the felonious and intentional killing of
- 2 the decedent, the determination conclusively establishes that
- 3 individual as the decedent's killer for purposes of this section.
- 4 (7) THIS SECTION DOES NOT APPLY IF THE FORFEITURE, REVOCATION,
- 5 OR SEVERANCE WOULD OCCUR BECAUSE OF ABUSE, NEGLECT, OR EXPLOITATION
- 6 AND THE DECEDENT EXECUTED A GOVERNING INSTRUMENT AFTER THE DATE OF
- 7 THE CONVICTION EXPRESSING A SPECIFIC INTENT TO ALLOW THE FELON TO
- 8 INHERIT OR OTHERWISE RECEIVE THE ESTATE OR PROPERTY OF THE
- 9 DECEDENT.
- 10 Sec. 2804. (1) Except as otherwise provided in this section, a
- 11 payor or other third party is not liable for having made a payment
- 12 or transferred an item of property or another benefit to a
- 13 beneficiary designated in a governing instrument affected by an
- 14 intentional and felonious killing OR BY ABUSE, NEGLECT, OR
- 15 EXPLOITATION, or for having taken another action in reliance on the
- 16 validity of the governing instrument, upon request and satisfactory
- 17 proof of the decedent's death. A payor or other third party is
- 18 liable for a payment made or other action taken 3-10 or more
- 19 business days after the payor or other third party actually
- 20 receives written notice of a claimed forfeiture or revocation under
- 21 section 2803. A payor or other third party is not obligated to
- 22 determine whether the decedent was the victim of felonious killing
- 23 OR ABUSE, NEGLECT, OR EXPLOITATION or to seek evidence relating to
- 24 such a killing OR ABUSE, NEGLECT, OR EXPLOITATION even if the
- 25 circumstances of the decedent's death are suspicious as to the
- 26 beneficiary's participation in such a killing OR IF THERE IS
- 27 EVIDENCE THAT WOULD RAISE SUSPICIONS THAT THE DECEDENT WAS THE

- 1 VICTIM OF ABUSE, NEGLECT, OR EXPLOITATION BY THE BENEFICIARY. A
- 2 recipient who incorrectly receives a payment, transfer of property,
- 3 or other benefit is liable for the payment or transfer received,
- 4 whether or not written notice of the claim is given.
- 5 (2) Written notice of a claimed forfeiture or revocation under
- 6 subsection (1) must be mailed to the payor's or other third party's
- 7 main office or home by registered or certified mail, return receipt
- 8 requested, or served upon the payor or other third party in the
- 9 same manner as a summons in a civil action. Notice to a sales
- 10 representative of a payor or other third party does not constitute
- 11 notice to the payor or other third party.
- 12 (3) The written notice under subsection (1) must include ALL
- 13 OF the FOLLOWING INFORMATION:
- 14 (A) THE decedent's name, the AGE, AND DATE OF BIRTH, AND 1 OF
- 15 THE FOLLOWING:
- 16 (i) THE LAST 4 DIGITS OF THE DECEDENT'S SOCIAL SECURITY NUMBER.
- 17 (ii) THE DECEDENT'S LAST KNOWN ADDRESS.
- 18 (B) THE name of the person asserting an interest. , the
- 19 (C) THE nature of the payment, item of property, or other
- 20 benefit. , and a
- 21 (D) A statement that a claim of forfeiture or revocation is
- 22 being made under section 2803.
- 23 (E) IF THE CLAIM IS BASED ON A CONVICTION FOR ABUSE, NEGLECT,
- 24 OR EXPLOITATION, A COPY OF THE JUDGMENT OF CONVICTION.
- 25 (4) Notice in a form or service in a manner other than that
- 26 described in this section does not impose liability on a payor or
- 27 other third party for an action taken in accordance with a

- 1 governing instrument.
- 2 (5) (4) Upon receipt of written notice of a claimed forfeiture
- 3 or revocation under this section, a payor or other third party may
- 4 pay an amount owed to the county treasurer of the county of the
- 5 court having jurisdiction of the probate proceedings relating to
- 6 the decedent's estate or, if no proceedings have been commenced, to
- 7 the county treasurer of the county of the decedent's residence.
- 8 With a payment under this section, the payor or other third party
- 9 shall file a copy of the written notice received by the payor or
- 10 other third party. A payment made to the county treasurer
- 11 discharges the payor or other third party from a claim for the
- 12 value of an amount paid to the county treasurer.
- 13 (6) (5) The county treasurer shall not charge a filing fee for
- 14 a payment to the county treasurer under this section. The county
- 15 treasurer shall hold the money in accordance with section 3917 and,
- 16 upon the court's determination under section 2803, shall disburse
- 17 the money in accordance with the determination.
- 18 (7) (6)—The provision for payment to the county treasurer
- 19 under this section does not preclude a payor or other third party
- 20 from taking another action authorized by law or the governing
- 21 instrument.
- 22 SEC. 5306A. (1) AN INDIVIDUAL FOR WHOM A GUARDIAN IS SOUGHT OR

- 7 (D) TO HAVE LEGAL COUNSEL OF HIS OR HER OWN CHOICE REPRESENT
- 8 HIM OR HER ON THE PETITION TO APPOINT A GUARDIAN, AS PROVIDED IN
- 9 SECTIONS 5303, 5304, AND 5305.
- 10 (E) IF HE OR SHE IS NOT REPRESENTED BY LEGAL COUNSEL, TO THE

- 3 POWERS ARE ALREADY HELD BY A VALID PATIENT ADVOCATE, AS PROVIDED IN

- 5 (U) TO PERIODIC REVIEW OF THE GUARDIANSHIP BY THE COURT,
- 6 INCLUDING THE RIGHT TO A HEARING AND THE APPOINTMENT OF AN ATTORNEY
- 7 IF ISSUES ARISE UPON THE REVIEW OF THE GUARDIANSHIP, AS PROVIDED IN
- 8 SECTION 5309.
- 9 (V) TO, AT ANY TIME, SEEK MODIFICATION OR TERMINATION OF THE
- 10 GUARDIANSHIP BY INFORMAL LETTER TO THE JUDGE, AS PROVIDED IN
- 11 SECTION 5310.
- 12 (W) TO A HEARING WITHIN 28 DAYS OF REQUESTING A REVIEW,
- 13 MODIFICATION, OR TERMINATION OF THE GUARDIANSHIP, AS PROVIDED IN
- 14 SECTION 5310.
- 15 (X) TO THE SAME RIGHTS ON A PETITION FOR MODIFICATION OR
- 16 TERMINATION OF THE GUARDIANSHIP INCLUDING THE APPOINTMENT OF A
- 17 VISITOR AS APPLY TO A PETITION FOR APPOINTMENT OF A GUARDIAN, AS
- 18 PROVIDED IN SECTION 5310.
- 19 (Y) TO PERSONAL NOTICE OF A PETITION FOR APPOINTMENT OR
- 20 REMOVAL OF A GUARDIAN, AS PROVIDED IN SECTION 5311.
- 21 (Z) TO WRITTEN NOTICE OF THE NATURE, PURPOSE, AND LEGAL
- 22 EFFECTS OF THE APPOINTMENT OF A GUARDIAN, AS PROVIDED IN SECTION

- 24 (AA) TO CHOOSE THE PERSON WHO WILL SERVE AS GUARDIAN, IF THE
- 25 CHOSEN PERSON IS SUITABLE AND WILLING TO SERVE, AS PROVIDED IN

- 27 (BB) TO CONSULT WITH THE GUARDIAN ABOUT MAJOR DECISIONS

- 1 AFFECTING THE INDIVIDUAL, IF MEANINGFUL CONVERSATION IS POSSIBLE,
- 2 AS PROVIDED IN SECTION 5314.
- 3 (CC) TO QUARTERLY VISITS BY THE GUARDIAN, AS PROVIDED IN
- 4 SECTION 5314.
- 5 (DD) TO HAVE THE GUARDIAN NOTIFY THE COURT WITHIN 14 DAYS OF A
- 6 CHANGE IN THE INDIVIDUAL'S RESIDENCE, AS PROVIDED IN SECTION 5314.
- 7 (EE) TO HAVE THE GUARDIAN SECURE SERVICES TO RESTORE THE
- 8 INDIVIDUAL TO THE BEST POSSIBLE STATE OF MENTAL AND PHYSICAL WELL-
- 9 BEING SO THAT THE INDIVIDUAL CAN RETURN TO SELF-MANAGEMENT AT THE
- 10 EARLIEST POSSIBLE TIME, AS PROVIDED IN SECTION 5314.
- 11 (FF) TO HAVE THE GUARDIAN TAKE REASONABLE CARE OF THE
- 12 INDIVIDUAL'S CLOTHING, FURNITURE, VEHICLES, AND OTHER PERSONAL
- 13 EFFECTS, AS PROVIDED IN SECTION 5314.
- 14 (GG) TO PARTIALLY SELF-MANAGE HIS OR HER PROPERTY TO ENCOURAGE
- 15 SELF-RELIANCE AND INDEPENDENCE, AS PROVIDED IN SECTION 5316.
- 16 (2) A GUARDIAN AD LITEM SHALL INFORM THE WARD IN WRITING OF
- 17 HIS OR HER RIGHTS ENUMERATED IN THIS SECTION. THE STATE COURT
- 18 ADMINISTRATIVE OFFICE AND THE OFFICE OF SERVICES TO THE AGING
- 19 CREATED IN SECTION 5 OF THE OLDER MICHIGANIANS ACT, 1981 PA 180,
- 20 MCL 400.585, SHALL PROMULGATE A FORM TO BE USED TO GIVE THE WRITTEN
- 21 NOTICE UNDER THIS SECTION, WHICH SHALL INCLUDE SPACE FOR THE COURT

- 25 Sec. 5314. Whenever meaningful communication is possible, a
- 26 legally incapacitated individual's guardian shall consult with the
- 27 legally incapacitated individual before making a major decision

- 1 affecting the legally incapacitated individual. Except as limited
- 2 TO THE EXTENT A GUARDIAN OF A LEGALLY INCAPACITATED INDIVIDUAL IS
- 3 GRANTED POWERS BY THE COURT under section 5306, a legally
- 4 incapacitated individual's THE guardian is responsible for the
- 5 ward's care, custody, and control, but is not liable to third
- 6 persons by reason of that responsibility for the ward's acts. In
- 7 particular and without qualifying the previous sentences, a
- 8 guardian has all of the following powers and duties, except as
- 9 modified TO THE EXTENT GRANTED by court order:
- 10 (a) To the extent that it is consistent with the terms of an
- 11 order by a court of competent jurisdiction relating to the ward's
- 12 detention or commitment, the guardian is entitled to THE custody of
- 13 the person of the guardian's ward and may THE POWER TO establish
- 14 the ward's place of residence within or without this state. A
- 15 ward's THE guardian shall visit the ward within 3 months after the
- 16 guardian's appointment and not less than once within 3 months after
- 17 each previous visit. The guardian must SHALL notify the court
- 18 within 14 days of a change in the ward's place of residence OR A
- 19 CHANGE IN THE GUARDIAN'S PLACE OF RESIDENCE.
- 20 (b) If entitled to custody of the ward, the quardian must DUTY
- 21 TO make provision for the ward's care, comfort, and maintenance
- 22 and, when appropriate, arrange for the ward's training and
- 23 education. The guardian shall secure services to restore the ward
- 24 to the best possible state of mental and physical well-being so
- 25 that the ward can return to self-management at the earliest
- 26 possible time. Without regard to custodial rights of the ward's
- 27 person, the guardian must—SHALL take reasonable care of the ward's

- 1 clothing, furniture, vehicles, and other personal effects and
- 2 commence a protective proceeding if the ward's other property needs
- 3 protection. If a guardian commences a protective proceeding because
- 4 the guardian believes that it is in the ward's best interest to
- 5 sell or otherwise dispose of the ward's real property or interest
- 6 in real property, the court may appoint the guardian as special
- 7 conservator and authorize the special conservator to proceed under
- 8 section 5423(3). A guardian shall not otherwise sell the ward's
- 9 real property or interest in real property.
- 10 (c) A quardian may THE POWER TO give the consent or approval
- 11 that is necessary to enable the ward to receive medical or other
- 12 professional care, counsel, treatment, or service.
- 13 (d) If a conservator for the ward's estate is not appointed, a
- 14 guardian may THE POWER TO do any of the following:
- 15 (i) Institute a proceeding to compel a person under a duty to
- 16 support the ward or to pay money for the ward's welfare to perform
- 17 that duty.
- (ii) Receive money and tangible property deliverable to the
- 19 ward and apply the money and property for the ward's support, care,
- 20 and education. The guardian shall not use money from the ward's
- 21 estate for room and board that the guardian or the guardian's

- 24 care, and education. The guardian shall account to the conservator
- 25 for the amount expended.
- Sec. 5315. (1) A-TO THE EXTENT GRANTED BY THE COURT UNDER
- 27 SECTION 5306, THE guardian of an individual for whom a conservator

- 1 also is appointed controls the ward's custody and care and is
- 2 entitled to receive reasonable amounts for those services and for
- 3 room and board furnished to the ward as agreed upon between the

- 4 NOT NECESSARY.
- 5 (2) A BOND FURNISHED UNDER THIS SECTION SHALL BE conditioned
- 6 upon faithful discharge of all duties of the CONSERVATOR'S trust
- 7 according to law, with sureties as the court specifies. Unless
- 8 otherwise directed, the bond shall be in the amount of the
- 9 aggregate capital value of the estate property in the conservator's
- 10 control plus 1 year's estimated income minus the value of

- 6 (j) Enter for any purpose into a lease as lessor or lessee
- 7 with or without option to purchase or renew for a term within or
- 8 extending beyond the term of the conservatorship.
- 9 (k) Enter into a lease or arrangement for exploration and
- 10 removal of a mineral or other natural resource or enter into a
- 11 pooling or unitization agreement.
- 12 (l) Grant an option involving disposition of estate property or
- 13 take an option for the acquisition of property.
- 14 (m) Vote a security, in person or by general or limited proxy.
- 15 (n) Pay a call, assessment, or other amount chargeable or
- 16 accruing against or on account of a security.
- 17 (o) Sell or exercise stock subscription or conversion rights.
- (p) Consent, directly or through a committee or other agent,
- 19 to the reorganization, consolidation, merger, dissolution, or
- 20 liquidation of a corporation or other business enterprise.
- 21 (q) Hold a security in the name of a nominee or in other form
- 22 without disclosure of the conservatorship so that title to the
- 23 security may pass by delivery. However, the conservator is liable
- 24 for an act of the nominee in connection with the stock so held.
- 25 (r) Insure the estate property against damage or loss or the
- 26 conservator against liability with respect to third persons.
- (s) Borrow money to be repaid from estate property or

- 1 otherwise.
- 2 (t) Advance money for the protection of the estate or the
- 3 protected individual, and for all expense, loss, or liability
- 4 sustained in the estate's administration or because of the holding
- 5 or ownership of estate property. The conservator has a lien on the
- 6 estate as against the protected individual for such an advance.
- 7 (u) Pay or contest a claim; settle a claim by or against the
- 8 estate or the protected individual by compromise, arbitration, or
- 9 otherwise; and release, in whole or in part, a claim belonging to
- 10 the estate to the extent that the claim is uncollectible.
- 11 (v) Pay a tax, assessment, conservator's compensation, or
