THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

TITLE

An act to establish career and technical preparation
enrollment options for certain students; enrolled in Michigan
schools; to prescribe certain duties of public schools, CERTAIN
NONPUBLIC SCHOOLS, and certain postsecondary institutions; to

- 2 (a) Approve 1 or more readiness assessments that may be used

- 23 the school district has paid money for the course OR, IF THE
- 24 STUDENT ENROLLS IN AN ELIGIBLE COURSE FOR POSTSECONDARY CREDIT ONLY
- 25 AND THE STUDENT DOES NOT SUCCESSFULLY COMPLETE THE ELIGIBLE COURSE,

- 13 apply to a student who does not complete the course due to a family

- 16 (10) FOR AN ELIGIBLE STUDENT WHO IS ENROLLED IN A STATE
- 17 APPROVED NONPUBLIC SCHOOL, OR IS A HOME-SCHOOLED CHILD, AND WHO
- 18 ENROLLS IN AN ELIGIBLE COURSE UNDER THIS ACT, IF THE STUDENT DOES
- 19 NOT COMPLETE THE ELIGIBLE COURSE OR, IF THE STUDENT ENROLLS IN AN
- 20 ELIGIBLE COURSE FOR POSTSECONDARY CREDIT ONLY AND THE STUDENT DOES
- 21 NOT SUCCESSFULLY COMPLETE THE ELIGIBLE COURSE, AS DETERMINED BY THE
- 22 CAREER AND TECHNICAL PREPARATION PROGRAM, AND IF THE DEPARTMENT OF

- 27 NONCOMPLETION OF THE COURSE. IF APPLICABLE, THE CAREER AND

- 1 TECHNICAL PREPARATION PROGRAM SHALL THEN REFUND TO THE STUDENT ANY
- 2 FUNDS THAT ARE REFUNDABLE DUE TO NONCOMPLETION OF THE COURSE AND
- 3 ARE IN EXCESS OF THE AMOUNT PAID BY THE DEPARTMENT OF TREASURY FOR
- 4 THE COURSE ON BEHALF OF THE STUDENT.
- 5 (B) THE STUDENT SHALL REPAY TO THE DEPARTMENT OF TREASURY ANY
- 6 FUNDS THAT WERE EXPENDED BY THE DEPARTMENT OF TREASURY FOR THE
- 7 COURSE THAT ARE NOT REFUNDED TO THE DEPARTMENT OF TREASURY BY THE
- 8 CAREER AND TECHNICAL PREPARATION PROGRAM. THIS SUBDIVISION DOES NOT
- 9 APPLY TO A STUDENT WHO DOES NOT COMPLETE THE COURSE DUE TO A FAMILY
- 10 OR MEDICAL EMERGENCY, AS DETERMINED BY THE CAREER AND TECHNICAL
- 11 PREPARATION PROGRAM.
- 12 (11) (9)—A school district, STATE APPROVED NONPUBLIC SCHOOL,
- 13 THE DEPARTMENT, OR THE DEPARTMENT OF TREASURY shall make available
- 14 to an eliqible student enrolled in the school district copies of
- 15 all correspondence in the possession of the school district, STATE
- 16 APPROVED NONPUBLIC SCHOOL, DEPARTMENT, OR DEPARTMENT OF TREASURY
- 17 regarding the eligible student's participation in a career and
- 18 technical preparation course under this act. Correspondence
- 19 described in this subsection shall be kept by the school district,

- 22 (12) (10)—If a school district pays for books for an eligible

- 27 (13) (11) This section does not apply to any career and

- 1 technical preparation courses in which an eliqible student is
- 2 enrolled in addition to being enrolled full-time in that eligible
- 3 student's school district, STATE APPROVED NONPUBLIC SCHOOL, OR HOME
- 4 SCHOOL PROGRAM; to a career and technical preparation course an

- 15 (1984), THEN THE ELIGIBLE STUDENT MAY ENROLL IN, AND RECEIVE
- 16 PAYMENT BY THE DEPARTMENT OF TREASURY UNDER SECTION 4(6) OF ALL OR
- 17 PART OF ELIGIBLE CHARGES FOR, AN ELIGIBLE COURSE UNDER THIS ACT FOR
- 18 HIGH SCHOOL CREDIT OR POSTSECONDARY CREDIT, OR BOTH. AT THE TIME AN
- 19 ELIGIBLE STUDENT ENROLLS UNDER THIS ACT IN AN ELIGIBLE COURSE

- 25 transcript shall indicate that the credits were earned at a career
- 26 and technical preparation program and identify the career and
- 27 technical preparation program.

1 (7) $\frac{(4)}{(4)}$ If a student enrolls in a career and technical 2 preparation program after leaving high school, the career and 3 technical preparation program, in accordance with institutional 4 policy, shall award postsecondary credit for postsecondary courses successfully completed by that student for high school credit under 5 6 this act at that career and technical preparation program. A career and technical preparation program shall not charge a student for 7 credit awarded under this subsection. 8 9 Sec. 9. (1) Each school district OR STATE APPROVED NONPUBLIC 10 SCHOOL shall provide information to all high school students on the 11 career and technical preparation enrollment options under this act, 12 including enrollment eligibility; the programs and types of courses 13 that are eligible for participation; the decision-making process for granting academic credits; an explanation of eligible charges 14 that will be paid by the school district OR DEPARTMENT OF TREASURY, 15 AS APPLICABLE, and of financial arrangements for eligible charges 16 17 and for paying costs not paid for by the school district OR 18 DEPARTMENT OF TREASURY; eligibility for payment of all or part of 19 eliqible charqes by the school district OR DEPARTMENT OF TREASURY, 20 AS APPLICABLE, under this act; an explanation that, if the student qualifies for payment of all or part of eligible charges by the 21 22 school district OR DEPARTMENT OF TREASURY under this act, the school district OR DEPARTMENT OF TREASURY, AS APPLICABLE, will pay 23 24 that support directly to the career and technical preparation program upon being billed by the career and technical preparation 25 26 program and that the student is not responsible for that payment 27 but is responsible for payment of costs not paid for under this

- 5 SCHOOL DISTRICT OR DEPARTMENT OF TREASURY, AS APPLICABLE, FOR MONEY
- 6 PAID ON BEHALF OF THE STUDENT; the effect of enrolling in a career
- 7 and technical preparation course on the eliqible student's ability
- 8 to complete the required high school graduation requirements; and
- 9 the academic and social responsibilities that must be assumed by
- 10 the eligible student and his or her parent or guardian.
- 11 (2) To the extent possible, a school district OR STATE
- 12 APPROVED NONPUBLIC SCHOOL shall provide counseling services to an
- 13 eligible student and his or her parent or guardian before the
- 14 eligible student enrolls in a career and technical preparation
- 15 course under this act to ensure that the eligible student and his
- 16 or her parent or guardian are fully aware of the benefits, risks,
- 17 and possible consequences of enrolling in the course. The person
- 18 providing the counseling shall encourage the eligible student and
- 19 his or her parent or guardian to also use available counseling
- 20 services at the career and technical preparation program before the
- 21 quarter or semester of enrollment to ensure that anticipated plans
- 22 are appropriate. A school district OR STATE APPROVED NONPUBLIC
- 23 SCHOOL may provide the counseling required under this section in a
- 24 group meeting if additional personalized counseling is also made

- 26 (3) Before enrolling in an eligible course at a career and
- 27 technical preparation program under this act, an eligible student

- 1 and his or her parent or guardian shall file with the career and
- 2 technical preparation program a signed form provided by the
- 3 eligible student's school district OR STATE APPROVED NONPUBLIC
- 4 SCHOOL stating that the student is an eligible student and has
- 5 received the information and counseling specified in subsections
- 6 (1) and (2) and that the student understands the responsibilities
- 7 that must be assumed in enrolling in the course. Upon request, the
- 8 department shall provide technical assistance to a school district
- 9 OR STATE APPROVED NONPUBLIC SCHOOL and to a career and technical
- 10 preparation program in developing appropriate forms and counseling
- 11 guidelines for purposes of this section.
- 12 Sec. 10. By May 1, 2001, and by March 1 of each school year
- 13 thereafter, a school district OR STATE APPROVED NONPUBLIC SCHOOL

- 12 (2) EACH CAREER AND TECHNICAL PREPARATION PROGRAM THAT
- 13 RECEIVES FUNDS UNDER THIS ACT SHALL ANNUALLY REPORT TO THE
- 14 DEPARTMENT, IN THE FORM AND MANNER PRESCRIBED BY THE DEPARTMENT,

- 19 (B) THE TOTAL NUMBER OF ELIGIBLE COURSES COMPLETED BY ELIGIBLE
- 20 STUDENTS UNDER THIS ACT AT THE CAREER AND TECHNICAL PREPARATION
- 21 PROGRAM DURING THE PRECEDING ACADEMIC YEAR.
- 22 (C) THE NUMBER OF ELIGIBLE COURSES UNDER SUBDIVISION (B) FOR
- 23 WHICH THE CAREER AND TECHNICAL PREPARATION PROGRAM GRANTED
- 24 POSTSECONDARY CREDIT TO THE ELIGIBLE STUDENT.
- 25 (D) THE NUMBER OF ELIGIBLE COURSES UNDER SUBDIVISION (B) FOR
- 26 WHICH THE CAREER AND TECHNICAL PREPARATION PROGRAM DECLINED TO
- 27 GRANT POSTSECONDARY CREDIT TO THE ELIGIBLE STUDENT.

- 1 (3) (2) Not later than March 1 of each year, the department
- 2 shall prepare and submit to the house and senate fiscal agencies
- 3 and the department of TECHNOLOGY, management, and budget a summary
- 4 annual report on the information received under subsection (1).
- 5 THIS SECTION. The department of education AND DEPARTMENT OF
- 6 TREASURY shall work cooperatively with the department in the
- 7 preparation of this report.
- 8 Enacting section 1. This amendatory act takes effect July 1,
