 - (c) For a commercial registered applicator, \$45.00.
 - (d) For a private registered applicator, \$50.00 until September 30, 2012-2015 and \$10.00 after September 30, 2012-2015.
 - (2) Certificates for commercial applicators, private agricultural applicators, and registered applicators shall be valid
