# SENATE SUBSTITUTE FOR HOUSE BILL NO. 5267

A bill to amend 1979 PA 94, entitled
"The state school aid act of 1979,"
by amending sections 6, 25, and 201 (MCL 388.1606, 388.1625, and 388.1801), as amended by 2012 PA 201, and by adding sections 23a and 25d.

#### THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 6. (1) "Center program" means a program operated by a
- 2 district or by an intermediate district for special education
- 3 pupils from several districts in programs for pupils with autism
- 4 spectrum disorder, pupils with severe cognitive impairment, pupils
- 5 with moderate cognitive impairment, pupils with severe multiple
- 6 impairments, pupils with hearing impairment, pupils with visual
- 7 impairment, and pupils with physical impairment or other health

- 1 impairment. Programs for pupils with emotional impairment housed in
- 2 buildings that do not serve regular education pupils also qualify.
- 3 Unless otherwise approved by the department, a center program
- 4 either shall serve all constituent districts within an intermediate
- 5 district or shall serve several districts with less than 50% of the
- 6 pupils residing in the operating district. In addition, special
- 7 education center program pupils placed part-time in noncenter
- 8 programs to comply with the least restrictive environment
- 9 provisions of section 612 of part B of the individuals with
- 10 disabilities education act, 20 USC 1412, may be considered center
- 11 program pupils for pupil accounting purposes for the time scheduled
- in either a center program or a noncenter program.
- 13 (2) "District and high school graduation rate" means the
- 14 annual completion and pupil dropout rate that is calculated by the
- 15 center pursuant to nationally recognized standards.
- 16 (3) "District and high school graduation report" means a
- 17 report of the number of pupils, excluding adult participants, in
- 18 the district for the immediately preceding school year, adjusted
- 19 for those pupils who have transferred into or out of the district
- 20 or high school, who leave high school with a diploma or other
- 21 credential of equal status.
- 22 (4) "Membership", except as otherwise provided in this
- 23 article, means for a district, a public school academy, the
- 24 education achievement system, or an intermediate district the sum
- of the product of .90 times the number of full-time equated pupils
- 26 in grades K to 12 actually enrolled and in regular daily attendance
- 27 on the pupil membership count day for the current school year, plus

- 1 the product of .10 times the final audited count from the
- 2 supplemental count day for the immediately preceding school year. A
- 3 district's, public school academy's, or intermediate district's
- 4 membership shall be adjusted as provided under section 25 for
- 5 pupils who enroll in the district, public school academy, or
- 6 intermediate district after the pupil membership count day. All
- 7 pupil counts used in this subsection are as determined by the
- 8 department and calculated by adding the number of pupils registered
- 9 for attendance plus pupils received by transfer and minus pupils
- 10 lost as defined by rules promulgated by the superintendent, and as
- 11 corrected by a subsequent department audit. For the purposes of
- 12 this section and section 6a, for a school of excellence that is a
- 13 cyber school, as defined in section 551 of the revised school code,
- 14 MCL 380.551, and is in compliance with section 553a of the revised
- 15 school code, MCL 380.553a, or for the education achievement system,
- 16 a pupil's participation in the cyber school's educational program
- 17 or in an online educational program of the education achievement
- 18 system or of an achievement school is considered regular daily
- 19 attendance. The amount of the foundation allowance for a pupil in
- 20 membership is determined under section 20. In making the
- 21 calculation of membership, all of the following, as applicable,
- 22 apply to determining the membership of a district, a public school
- 23 academy, the education achievement system, or an intermediate
- 24 district:
- 25 (a) Except as otherwise provided in this subsection, and
- 26 pursuant to subsection (6), a pupil shall be counted in membership
- 27 in the pupil's educating district or districts. An individual pupil

- 1 shall not be counted for more than a total of 1.0 full-time equated
- 2 membership.
- 3 (b) If a pupil is educated in a district other than the
- 4 pupil's district of residence, if the pupil is not being educated
- 5 as part of a cooperative education program, if the pupil's district
- 6 of residence does not give the educating district its approval to
- 7 count the pupil in membership in the educating district, and if the
- 8 pupil is not covered by an exception specified in subsection (6) to
- 9 the requirement that the educating district must have the approval
- 10 of the pupil's district of residence to count the pupil in
- 11 membership, the pupil shall not be counted in membership in any
- 12 district.
- 13 (c) A special education pupil educated by the intermediate
- 14 district shall be counted in membership in the intermediate
- 15 district.
- 16 (d) A pupil placed by a court or state agency in an on-grounds
- 17 program of a juvenile detention facility, a child caring
- 18 institution, or a mental health institution, or a pupil funded
- 19 under section 53a, shall be counted in membership in the district
- 20 or intermediate district approved by the department to operate the
- 21 program.
- (e) A pupil enrolled in the Michigan schools for the deaf and
- 23 blind shall be counted in membership in the pupil's intermediate
- 24 district of residence.
- 25 (f) A pupil enrolled in a career and technical education
- 26 program supported by a millage levied over an area larger than a
- 27 single district or in an area vocational-technical education

- 1 program established pursuant to section 690 of the revised school
- 2 code, MCL 380.690, shall be counted only in the pupil's district of
- 3 residence.
- 4 (g) A pupil enrolled in a public school academy shall be
- 5 counted in membership in the public school academy.
- 6 (h) A pupil enrolled in an achievement school shall be counted
- 7 in membership in the education achievement system.
- 8 (i) For a new district or public school academy beginning its
- 9 operation after December 31, 1994, or for the education achievement
- 10 system or an achievement school, membership for the first 2 full or
- 11 partial fiscal years of operation shall be determined as follows:
- 12 (i) If operations begin before the pupil membership count day
- 13 for the fiscal year, membership is the average number of full-time
- 14 equated pupils in grades K to 12 actually enrolled and in regular
- 15 daily attendance on the pupil membership count day for the current
- 16 school year and on the supplemental count day for the current
- 17 school year, as determined by the department and calculated by
- 18 adding the number of pupils registered for attendance on the pupil
- 19 membership count day plus pupils received by transfer and minus
- 20 pupils lost as defined by rules promulgated by the superintendent,
- 21 and as corrected by a subsequent department audit, plus the final
- 22 audited count from the supplemental count day for the current
- 23 school year, and dividing that sum by 2.
- 24 (ii) If operations begin after the pupil membership count day
- 25 for the fiscal year and not later than the supplemental count day
- 26 for the fiscal year, membership is the final audited count of the
- 27 number of full-time equated pupils in grades K to 12 actually

- 1 enrolled and in regular daily attendance on the supplemental count
- 2 day for the current school year.
- 3 (j) If a district is the authorizing body for a public school
- 4 academy, then, in the first school year in which pupils are counted
- 5 in membership on the pupil membership count day in the public
- 6 school academy, the determination of the district's membership
- 7 shall exclude from the district's pupil count for the immediately
- 8 preceding supplemental count day any pupils who are counted in the
- 9 public school academy on that first pupil membership count day who
- 10 were also counted in the district on the immediately preceding
- 11 supplemental count day.
- 12 (k) In a district, a public school academy, the education
- 13 achievement system, or an intermediate district operating an
- 14 extended school year program approved by the superintendent, a
- 15 pupil enrolled, but not scheduled to be in regular daily attendance
- on a pupil membership count day, shall be counted.
- 17 (l) Pupils to TO be counted in membership, shall be not less
- 18 than 5 years of age on December 1 and A PUPIL SHALL MEET THE
- 19 MINIMUM AGE REQUIREMENT TO BE ELIGIBLE TO ATTEND SCHOOL UNDER
- 20 SECTION 1147 OF THE REVISED SCHOOL CODE, MCL 380.1147, OR SHALL BE
- 21 ENROLLED UNDER SUBSECTION (3) OF THAT SECTION, AND SHALL BE less
- 22 than 20 years of age on September 1 of the school year except as
- 23 follows:
- 24 (i) A special education pupil who is enrolled and receiving
- 25 instruction in a special education program or service approved by
- 26 the department, who does not have a high school diploma, and who is
- 27 less than 26 years of age as of September 1 of the current school

- 1 year shall be counted in membership.
- $\mathbf{2}$  (ii) A pupil who is determined by the department to meet all of
- 3 the following may be counted in membership:
- 4 (A) Is enrolled in a public school academy or an alternative
- 5 education high school diploma program, that is primarily focused on
- 6 educating homeless pupils and that is located in a city with a
- 7 population of more than 500,000.
- 8 (B) Had dropped out of school for more than 1 year and has re-
- 9 entered school.
- 10 (C) Is less than 22 years of age as of September 1 of the
- 11 current school year.
- 12 (m) An individual who has obtained a high school diploma shall
- 13 not be counted in membership. An individual who has obtained a
- 14 general educational development (G.E.D.) certificate shall not be
- 15 counted in membership unless the individual is a pupil with a
- 16 disability as defined in R 340.1702 of the Michigan administrative
- 17 code. An individual participating in a job training program funded
- 18 under former section 107a or a jobs program funded under former
- 19 section 107b, administered by the Michigan strategic fund, or
- 20 participating in any successor of either of those 2 programs, shall
- 21 not be counted in membership.
- (n) If a pupil counted in membership in a public school
- 23 academy or the education achievement system is also educated by a
- 24 district or intermediate district as part of a cooperative
- 25 education program, the pupil shall be counted in membership only in
- 26 the public school academy or the education achievement system
- 27 unless a written agreement signed by all parties designates the

- 1 party or parties in which the pupil shall be counted in membership,
- 2 and the instructional time scheduled for the pupil in the district
- 3 or intermediate district shall be included in the full-time equated
- 4 membership determination under subdivision (q). However, for pupils
- 5 receiving instruction in both a public school academy or the
- 6 education achievement system and in a district or intermediate
- 7 district but not as a part of a cooperative education program, the
- 8 following apply:
- 9 (i) If the public school academy or the education achievement
- 10 system provides instruction for at least 1/2 of the class hours
- 11 specified in subdivision (q), the public school academy or the
- 12 education achievement system shall receive as its prorated share of
- 13 the full-time equated membership for each of those pupils an amount
- 14 equal to 1 times the product of the hours of instruction the public
- 15 school academy or the education achievement system provides divided
- 16 by the number of hours specified in subdivision (q) for full-time
- 17 equivalency, and the remainder of the full-time membership for each
- 18 of those pupils shall be allocated to the district or intermediate
- 19 district providing the remainder of the hours of instruction.
- (ii) If the public school academy or the education achievement
- 21 system provides instruction for less than 1/2 of the class hours
- 22 specified in subdivision (q), the district or intermediate district
- 23 providing the remainder of the hours of instruction shall receive
- 24 as its prorated share of the full-time equated membership for each
- 25 of those pupils an amount equal to 1 times the product of the hours
- 26 of instruction the district or intermediate district provides
- 27 divided by the number of hours specified in subdivision (q) for

- 1 full-time equivalency, and the remainder of the full-time
- 2 membership for each of those pupils shall be allocated to the
- 3 public school academy or the education achievement system.
- 4 (o) An individual less than 16 years of age as of September 1
- 5 of the current school year who is being educated in an alternative
- 6 education program shall not be counted in membership if there are
- 7 also adult education participants being educated in the same
- 8 program or classroom.
- 9 (p) The department shall give a uniform interpretation of
- 10 full-time and part-time memberships.
- 11 (q) The number of class hours used to calculate full-time
- 12 equated memberships shall be consistent with section 101(3). In
- 13 determining full-time equated memberships for pupils who are
- 14 enrolled in a postsecondary institution, a pupil shall not be
- 15 considered to be less than a full-time equated pupil solely because
- 16 of the effect of his or her postsecondary enrollment, including
- 17 necessary travel time, on the number of class hours provided by the
- 18 district to the pupil.
- 19 (r) Beginning in 2012-2013, full-time equated memberships for
- 20 pupils in kindergarten shall be determined by dividing the number
- 21 of instructional hours scheduled and provided per year per
- 22 kindergarten pupil by the same number used for determining full-
- 23 time equated memberships for pupils in grades 1 to 12. However, to
- 24 the extent allowable under federal law, for a district or public
- 25 school academy that provides evidence satisfactory to the
- 26 department that it used federal title I money in the 2 immediately
- 27 preceding school fiscal years to fund full-time kindergarten, full-

- 1 time equated memberships for pupils in kindergarten shall be
- 2 determined by dividing the number of class hours scheduled and
- 3 provided per year per kindergarten pupil by a number equal to 1/2
- 4 the number used for determining full-time equated memberships for
- 5 pupils in grades 1 to 12. Not later than December 1, 2012, the
- 6 department shall seek a clarification from the federal department
- 7 of education as to whether this is an allowable use of federal
- 8 title I money. The change in the counting of full-time equated
- 9 memberships for pupils in kindergarten that takes effect in 2012-
- 10 2013 is not a mandate. Not later than the fifth Wednesday after the
- 11 pupil membership count day, each district or public school academy
- 12 and the education achievement system shall report to the department
- 13 and the center the number of instructional hours scheduled per
- 14 kindergarten pupil for 2012-2013. If the number of instructional
- 15 hours scheduled per kindergarten pupil is not equal for all
- 16 kindergarten pupils in the district, the district or public school
- 17 academy and the education achievement system shall report the
- 18 number of kindergarten pupils who were scheduled to receive each of
- 19 the different numbers of instructional hours scheduled.
- 20 (s) For a district, a public school academy, or the education
- 21 achievement system that has pupils enrolled in a grade level that
- 22 was not offered by the district, the public school academy, or the
- 23 education achievement system in the immediately preceding school
- 24 year, the number of pupils enrolled in that grade level to be
- 25 counted in membership is the average of the number of those pupils
- 26 enrolled and in regular daily attendance on the pupil membership
- 27 count day and the supplemental count day of the current school

- 1 year, as determined by the department. Membership shall be
- 2 calculated by adding the number of pupils registered for attendance
- 3 in that grade level on the pupil membership count day plus pupils
- 4 received by transfer and minus pupils lost as defined by rules
- 5 promulgated by the superintendent, and as corrected by subsequent
- 6 department audit, plus the final audited count from the
- 7 supplemental count day for the current school year, and dividing
- 8 that sum by 2.
- 9 (t) A pupil enrolled in a cooperative education program may be
- 10 counted in membership in the pupil's district of residence with the
- 11 written approval of all parties to the cooperative agreement.
- 12 (u) If, as a result of a disciplinary action, a district
- 13 determines through the district's alternative or disciplinary
- 14 education program that the best instructional placement for a pupil
- is in the pupil's home or otherwise apart from the general school
- 16 population, if that placement is authorized in writing by the
- 17 district superintendent and district alternative or disciplinary
- 18 education supervisor, and if the district provides appropriate
- 19 instruction as described in this subdivision to the pupil at the
- 20 pupil's home or otherwise apart from the general school population,
- 21 the district may count the pupil in membership on a pro rata basis,
- 22 with the proration based on the number of hours of instruction the
- 23 district actually provides to the pupil divided by the number of
- 24 hours specified in subdivision (q) for full-time equivalency. For
- 25 the purposes of this subdivision, a district shall be considered to
- 26 be providing appropriate instruction if all of the following are
- **27** met:

- 1 (i) The district provides at least 2 nonconsecutive hours of
- 2 instruction per week to the pupil at the pupil's home or otherwise
- 3 apart from the general school population under the supervision of a
- 4 certificated teacher.
- 5 (ii) The district provides instructional materials, resources,
- 6 and supplies, except computers, that are comparable to those
- 7 otherwise provided in the district's alternative education program.
- 8 (iii) Course content is comparable to that in the district's
- 9 alternative education program.
- (iv) Credit earned is awarded to the pupil and placed on the
- pupil's transcript.
- 12 (v) A pupil enrolled in an alternative or disciplinary
- 13 education program described in section 25 shall be counted in
- 14 membership in the district, the public school academy, or the
- 15 education achievement system that is educating the pupil.
- 16 (w) If a pupil was enrolled in a public school academy on the
- 17 pupil membership count day, if the public school academy's contract
- 18 with its authorizing body is revoked or the public school academy
- 19 otherwise ceases to operate, and if the pupil enrolls in a district
- 20 or the education achievement system within 45 days after the pupil
- 21 membership count day, the department shall adjust the district's or
- 22 the education achievement system's pupil count for the pupil
- 23 membership count day to include the pupil in the count.
- 24 (x) For a public school academy that has been in operation for
- 25 at least 2 years and that suspended operations for at least 1
- 26 semester and is resuming operations, membership is the sum of the
- 27 product of .90 times the number of full-time equated pupils in

- 1 grades K to 12 actually enrolled and in regular daily attendance on
- 2 the first pupil membership count day or supplemental count day,
- 3 whichever is first, occurring after operations resume, plus the
- 4 product of .10 times the final audited count from the most recent
- 5 pupil membership count day or supplemental count day that occurred
- 6 before suspending operations, as determined by the superintendent.
- 7 (y) If a district's membership for a particular fiscal year,
- 8 as otherwise calculated under this subsection, would be less than
- 9 1,550 pupils and the district has 4.5 or fewer pupils per square
- 10 mile, as determined by the department, and, beginning in 2007-2008,
- 11 if the district does not receive funding under section 22d(2), the
- 12 district's membership shall be considered to be the membership
- 13 figure calculated under this subdivision. If a district educates
- 14 and counts in its membership pupils in grades 9 to 12 who reside in
- 15 a contiguous district that does not operate grades 9 to 12 and if 1
- 16 or both of the affected districts request the department to use the
- 17 determination allowed under this sentence, the department shall
- 18 include the square mileage of both districts in determining the
- 19 number of pupils per square mile for each of the districts for the
- 20 purposes of this subdivision. The membership figure calculated
- 21 under this subdivision is the greater of the following:
- (i) The average of the district's membership for the 3-fiscal-
- 23 year period ending with that fiscal year, calculated by adding the
- 24 district's actual membership for each of those 3 fiscal years, as
- 25 otherwise calculated under this subsection, and dividing the sum of
- 26 those 3 membership figures by 3.
- 27 (ii) The district's actual membership for that fiscal year as

- 1 otherwise calculated under this subsection.
- 2 (z) If a public school academy that is not in its first or
- 3 second year of operation closes at the end of a school year and
- 4 does not reopen for the next school year, the department shall
- 5 adjust the membership count of the district or the education
- 6 achievement system in which a former pupil of the public school
- 7 academy enrolls and is in regular daily attendance for the next
- 8 school year to ensure that the district or the education
- 9 achievement system receives the same amount of membership aid for
- 10 the pupil as if the pupil were counted in the district or the
- 11 education achievement system on the supplemental count day of the
- 12 preceding school year.
- 13 (aa) Full-time equated memberships for special education
- 14 pupils who are not enrolled in kindergarten but are enrolled in a
- 15 classroom program under R 340.1754 of the Michigan administrative
- 16 code shall be determined by dividing the number of class hours
- 17 scheduled and provided per year by 450. Full-time equated
- 18 memberships for special education pupils who are not enrolled in
- 19 kindergarten but are receiving early childhood special education
- 20 services under R 340.1755 of the Michigan administrative code shall
- 21 be determined by dividing the number of hours of service scheduled
- 22 and provided per year per pupil by 180.
- 23 (bb) A pupil of a district that begins its school year after
- 24 Labor day who is enrolled in an intermediate district program that
- 25 begins before Labor day shall not be considered to be less than a
- 26 full-time pupil solely due to instructional time scheduled but not
- 27 attended by the pupil before Labor day.

- 1 (cc) For the first year in which a pupil is counted in
- 2 membership on the pupil membership count day in a middle college
- 3 program, the membership is the average of the full-time equated
- 4 membership on the pupil membership count day and on the
- 5 supplemental count day for the current school year, as determined
- 6 by the department. If a pupil was counted by the operating district
- 7 on the immediately preceding supplemental count day, the pupil
- 8 shall be excluded from the district's immediately preceding
- 9 supplemental count for purposes of determining the district's
- 10 membership.
- 11 (dd) A district, a public school academy, or the education
- 12 achievement system that educates a pupil who attends a United
- 13 States Olympic education center may count the pupil in membership
- 14 regardless of whether or not the pupil is a resident of this state.
- 15 (ee) A pupil enrolled in a district other than the pupil's
- 16 district of residence pursuant to section 1148(2) of the revised
- 17 school code, MCL 380.1148, shall be counted in the educating
- 18 district or the education achievement system.
- 19 (FF) FOR A PUPIL ENROLLED IN A DROPOUT RECOVERY PROGRAM THAT
- 20 MEETS THE REQUIREMENTS OF SECTION 23A, THE PUPIL SHALL BE COUNTED
- 21 AS 1/12 OF A FULL-TIME EQUATED MEMBERSHIP FOR EACH MONTH THAT THE
- 22 DISTRICT OPERATING THE PROGRAM REPORTS THAT THE PUPIL WAS ENROLLED
- 23 IN THE PROGRAM AND WAS IN FULL ATTENDANCE. THE DISTRICT OPERATING
- 24 THE PROGRAM SHALL REPORT TO THE CENTER THE NUMBER OF PUPILS WHO
- 25 WERE ENROLLED IN THE PROGRAM AND WERE IN FULL ATTENDANCE FOR A
- 26 MONTH NOT LATER THAN THE TENTH DAY OF THE NEXT MONTH. A DISTRICT
- 27 SHALL NOT REPORT A PUPIL AS BEING IN FULL ATTENDANCE FOR A MONTH

- 1 UNLESS BOTH OF THE FOLLOWING ARE MET:
- 2 (i) A PERSONALIZED LEARNING PLAN IS IN PLACE ON OR BEFORE THE
- 3 FIRST SCHOOL DAY OF THE MONTH FOR THE FIRST MONTH THE PUPIL
- 4 PARTICIPATES IN THE PROGRAM.
- 5 (ii) THE PUPIL MEETS THE DISTRICT'S DEFINITION UNDER SECTION
- 6 23A OF SATISFACTORY MONTHLY PROGRESS FOR THAT MONTH OR, IF THE
- 7 PUPIL DOES NOT MEET THAT DEFINITION OF SATISFACTORY MONTHLY
- 8 PROGRESS FOR THAT MONTH, THE PUPIL DID MEET THAT DEFINITION OF
- 9 SATISFACTORY MONTHLY PROGRESS IN THE IMMEDIATELY PRECEDING MONTH
- 10 AND APPROPRIATE INTERVENTIONS ARE IMPLEMENTED WITHIN 10 SCHOOL DAYS
- 11 AFTER IT IS DETERMINED THAT THE PUPIL DOES NOT MEET THAT DEFINITION
- 12 OF SATISFACTORY MONTHLY PROGRESS.
- 13 (5) "Public school academy" means that term as defined in the
- 14 revised school code.
- 15 (6) "Pupil" means a person in membership in a public school. A
- 16 district must have the approval of the pupil's district of
- 17 residence to count the pupil in membership, except approval by the
- 18 pupil's district of residence is not required for any of the
- 19 following:
- 20 (a) A nonpublic part-time pupil enrolled in grades 1 to 12 in
- 21 accordance with section 166b.
- 22 (b) A pupil receiving 1/2 or less of his or her instruction in
- 23 a district other than the pupil's district of residence.
- 24 (c) A pupil enrolled in a public school academy or the
- 25 education achievement system.
- 26 (d) A pupil enrolled in a district other than the pupil's
- 27 district of residence under an intermediate district schools of

- 1 choice pilot program as described in section 91a or former section
- 2 91 if the intermediate district and its constituent districts have
- 3 been exempted from section 105.
- 4 (e) A pupil enrolled in a district other than the pupil's
- 5 district of residence if the pupil is enrolled in accordance with
- 6 section 105 or 105c.
- 7 (f) A pupil who has made an official written complaint or
- 8 whose parent or legal guardian has made an official written
- 9 complaint to law enforcement officials and to school officials of
- 10 the pupil's district of residence that the pupil has been the
- 11 victim of a criminal sexual assault or other serious assault, if
- 12 the official complaint either indicates that the assault occurred
- 13 at school or that the assault was committed by 1 or more other
- 14 pupils enrolled in the school the pupil would otherwise attend in
- 15 the district of residence or by an employee of the district of
- 16 residence. A person who intentionally makes a false report of a
- 17 crime to law enforcement officials for the purposes of this
- 18 subdivision is subject to section 411a of the Michigan penal code,
- 19 1931 PA 328, MCL 750.411a, which provides criminal penalties for
- 20 that conduct. As used in this subdivision:
- 21 (i) "At school" means in a classroom, elsewhere on school
- 22 premises, on a school bus or other school-related vehicle, or at a
- 23 school-sponsored activity or event whether or not it is held on
- 24 school premises.
- 25 (ii) "Serious assault" means an act that constitutes a felony
- 26 violation of chapter XI of the Michigan penal code, 1931 PA 328,
- 27 MCL 750.81 to  $\frac{750.90g}{750.90H}$ , or that constitutes an assault and
