## SUBSTITUTE FOR SENATE BILL NO. 1064

A bill to amend 2006 PA 110, entitled "Michigan zoning enabling act,"

(MCL 125.3101 to 125.3702) by adding section 3514.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 3514. (1) WIRELESS COMMUNICATIONS EQUIPMENT IS A
- 2 PERMITTED USE OF PROPERTY AND IS NOT SUBJECT TO SPECIAL LAND USE
- 3 APPROVAL OR ANY OTHER APPROVAL UNDER THIS ACT IF ALL OF THE
- 4 FOLLOWING REQUIREMENTS ARE MET:
- 5 (A) THE WIRELESS COMMUNICATIONS EQUIPMENT WILL BE COLLOCATED
- 6 ON AN EXISTING WIRELESS COMMUNICATIONS SUPPORT STRUCTURE OR IN AN
- 7 EXISTING EQUIPMENT COMPOUND.
- 8 (B) THE EXISTING WIRELESS COMMUNICATIONS SUPPORT STRUCTURE OR
- 9 EXISTING EQUIPMENT COMPOUND IS IN COMPLIANCE WITH THE LOCAL UNIT OF
- 10 GOVERNMENT'S ZONING ORDINANCE OR WAS APPROVED BY THE APPROPRIATE

- 1 ZONING BODY OR OFFICIAL FOR THE LOCAL UNIT OF GOVERNMENT.
- 2 (C) THE PROPOSED COLLOCATION WILL NOT DO ANY OF THE FOLLOWING:
- 3 (i) INCREASE THE OVERALL HEIGHT OF THE WIRELESS COMMUNICATIONS
- 4 SUPPORT STRUCTURE BY MORE THAN 20 FEET OR 10% OF ITS ORIGINAL
- 5 HEIGHT, WHICHEVER IS GREATER.
- 6 (ii) INCREASE THE WIDTH OF THE WIRELESS COMMUNICATIONS SUPPORT
- 7 STRUCTURE BY MORE THAN THE MINIMUM NECESSARY TO PERMIT COLLOCATION.
- 8 (iii) INCREASE THE AREA OF THE EXISTING EQUIPMENT COMPOUND TO
- 9 GREATER THAN 2,500 SQUARE FEET.
- 10 (D) THE PROPOSED COLLOCATION COMPLIES WITH THE TERMS AND
- 11 CONDITIONS OF ANY PREVIOUS FINAL APPROVAL OF THE WIRELESS
- 12 COMMUNICATIONS SUPPORT STRUCTURE OR EQUIPMENT COMPOUND BY THE
- 13 APPROPRIATE ZONING BODY OR OFFICIAL OF THE LOCAL UNIT OF
- 14 GOVERNMENT.
- 15 (2) WIRELESS COMMUNICATIONS EQUIPMENT THAT MEETS THE
- 16 REQUIREMENTS OF SUBSECTION (1)(A) AND (B) BUT DOES NOT MEET THE
- 17 REQUIREMENTS OF SUBSECTION (1)(C) OR (D) IS A PERMITTED USE OF
- 18 PROPERTY IF IT RECEIVES SPECIAL LAND USE APPROVAL UNDER SUBSECTIONS
- 19 (3) TO (6).
- 20 (3) AN APPLICATION FOR SPECIAL LAND USE APPROVAL OF WIRELESS
- 21 COMMUNICATIONS EQUIPMENT DESCRIBED IN SUBSECTION (2) SHALL INCLUDE
- 22 ALL OF THE FOLLOWING:
- 23 (A) A SITE PLAN AS REQUIRED UNDER SECTION 501, INCLUDING A MAP
- 24 OF THE PROPERTY AND EXISTING AND PROPOSED BUILDINGS AND OTHER
- 25 FACILITIES.
- 26 (B) ANY ADDITIONAL RELEVANT INFORMATION THAT IS SPECIFICALLY
- 27 REQUIRED BY A ZONING ORDINANCE PROVISION DESCRIBED IN SECTION

- 1 502(1) OR 504.
- 2 (4) AFTER AN APPLICATION FOR A SPECIAL LAND USE APPROVAL IS
- 3 FILED WITH THE BODY OR OFFICIAL RESPONSIBLE FOR APPROVING SPECIAL
- 4 LAND USES, THE BODY OR OFFICIAL SHALL DETERMINE WHETHER THE
- 5 APPLICATION IS ADMINISTRATIVELY COMPLETE. UNLESS THE BODY OR
- 6 OFFICIAL PROCEEDS AS PROVIDED UNDER SUBSECTION (5), THE APPLICATION
- 7 SHALL BE CONSIDERED TO BE ADMINISTRATIVELY COMPLETE WHEN THE BODY
- 8 OR OFFICIAL MAKES THAT DETERMINATION OR 14 BUSINESS DAYS AFTER THE
- 9 BODY OR OFFICIAL RECEIVES THE APPLICATION, WHICHEVER IS FIRST.
- 10 (5) IF, BEFORE THE EXPIRATION OF THE 14-DAY PERIOD UNDER
- 11 SUBSECTION (4), THE BODY OR OFFICIAL RESPONSIBLE FOR APPROVING
- 12 SPECIAL LAND USES NOTIFIES THE APPLICANT THAT THE APPLICATION IS
- 13 NOT ADMINISTRATIVELY COMPLETE, SPECIFYING THE INFORMATION NECESSARY
- 14 TO MAKE THE APPLICATION ADMINISTRATIVELY COMPLETE, OR NOTIFIES THE
- 15 APPLICANT THAT A FEE REQUIRED TO ACCOMPANY THE APPLICATION HAS NOT
- 16 BEEN PAID, SPECIFYING THE AMOUNT DUE, THE RUNNING OF THE 14-DAY
- 17 PERIOD UNDER SUBSECTION (4) IS TOLLED UNTIL THE APPLICANT SUBMITS
- 18 TO THE BODY OR OFFICIAL THE SPECIFIED INFORMATION OR FEE AMOUNT
- 19 DUE. THE NOTICE SHALL BE GIVEN IN WRITING OR BY ELECTRONIC
- 20 NOTIFICATION. A FEE REQUIRED TO ACCOMPANY ANY APPLICATION SHALL NOT
- 21 EXCEED THE LOCAL UNIT OF GOVERNMENT'S ACTUAL, REASONABLE COSTS TO
- 22 REVIEW AND PROCESS THE APPLICATION OR \$1,000.00, WHICHEVER IS LESS.
- 23 (6) THE BODY OR OFFICIAL RESPONSIBLE FOR APPROVING SPECIAL
- 24 LAND USES SHALL APPROVE OR DENY THE APPLICATION NOT MORE THAN 60
- 25 DAYS AFTER THE APPLICATION IS CONSIDERED TO BE ADMINISTRATIVELY
- 26 COMPLETE. IF THE BODY OR OFFICIAL FAILS TO TIMELY APPROVE OR DENY
- 27 THE APPLICATION, THE APPLICATION SHALL BE CONSIDERED APPROVED AND

- 1 THE BODY OR OFFICIAL SHALL BE CONSIDERED TO HAVE MADE ANY
- 2 DETERMINATION REQUIRED FOR APPROVAL.
- 3 (7) SPECIAL LAND USE APPROVAL OF WIRELESS COMMUNICATIONS
- 4 EQUIPMENT DESCRIBED IN SUBSECTION (2) MAY BE MADE EXPRESSLY
- 5 CONDITIONAL ONLY ON THE WIRELESS COMMUNICATIONS EQUIPMENT'S MEETING
- 6 THE REQUIREMENTS OF OTHER LOCAL ORDINANCES AND OF FEDERAL AND STATE
- 7 LAWS BEFORE THE WIRELESS COMMUNICATIONS EQUIPMENT BEGINS OPERATION.
- 8 (8) IF A LOCAL UNIT OF GOVERNMENT REQUIRES SPECIAL LAND USE
- 9 APPROVAL FOR WIRELESS COMMUNICATIONS EQUIPMENT THAT DOES NOT MEET
- 10 THE REQUIREMENTS OF SUBSECTION (1) (A) OR FOR A WIRELESS
- 11 COMMUNICATIONS SUPPORT STRUCTURE, SUBSECTIONS (4) TO (6) APPLY TO
- 12 THE SPECIAL LAND USE APPROVAL PROCESS, EXCEPT THAT THE PERIOD FOR
- 13 APPROVAL OR DENIAL UNDER SUBSECTION (6) IS 90 DAYS.
- 14 (9) A LOCAL UNIT OF GOVERNMENT MAY AUTHORIZE WIRELESS
- 15 COMMUNICATIONS EQUIPMENT AS A PERMITTED USE OF PROPERTY NOT SUBJECT
- 16 TO A SPECIAL LAND USE APPROVAL.
- 17 (10) AS USED IN THIS SECTION:
- 18 (A) "COLLOCATE" MEANS TO PLACE OR INSTALL WIRELESS
- 19 COMMUNICATIONS EQUIPMENT ON AN EXISTING WIRELESS COMMUNICATIONS
- 20 SUPPORT STRUCTURE OR IN AN EXISTING EQUIPMENT COMPOUND.
- 21 "COLLOCATION" HAS A CORRESPONDING MEANING.
- 22 (B) "EQUIPMENT COMPOUND" MEANS AN AREA SURROUNDING OR ADJACENT
- 23 TO THE BASE OF A WIRELESS COMMUNICATIONS SUPPORT STRUCTURE AND
- 24 WITHIN WHICH WIRELESS COMMUNICATIONS EQUIPMENT IS LOCATED.
- 25 (C) "WIRELESS COMMUNICATIONS EQUIPMENT" MEANS THE SET OF
- 26 EQUIPMENT AND NETWORK COMPONENTS USED IN THE PROVISION OF WIRELESS
- 27 COMMUNICATIONS SERVICES, INCLUDING, BUT NOT LIMITED TO, ANTENNAS,

- TRANSMITTERS, RECEIVERS, BASE STATIONS, EQUIPMENT SHELTERS, 1
- 2 CABINETS, EMERGENCY GENERATORS, POWER SUPPLY CABLES, AND COAXIAL
- 3 AND FIBER OPTIC CABLES, BUT EXCLUDING WIRELESS COMMUNICATIONS
- SUPPORT STRUCTURES. 4
- 5 (D) "WIRELESS COMMUNICATIONS SUPPORT STRUCTURE" MEANS A
- 6 STRUCTURE THAT IS DESIGNED TO SUPPORT, OR IS CAPABLE OF SUPPORTING,
- 7 WIRELESS COMMUNICATIONS EQUIPMENT, INCLUDING A MONOPOLE, SELF-
- 8 SUPPORTING LATTICE TOWER, GUYED TOWER, WATER TOWER, UTILITY POLE,
- 9 OR BUILDING.
