HOUSE BILL NO. 4026

A bill to amend 1846 RS 12, entitled "Of certain state officers,"

(MCL 14.28 to 14.35) by adding section 32a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 32A. (1) BEGINNING SEPTEMBER 1, 2014, WITHIN 10 DAYS
- 2 AFTER EXECUTING A CROSS BOUNDARY MEMORANDUM OF AGREEMENT, A
- 3 GOVERNMENTAL UNIT OR OFFICER OF THIS STATE SHALL FORWARD THE
- 4 EXECUTED AGREEMENT TO THE OFFICE OF THE GREAT SEAL WITH A COPY TO
- 5 THE ATTORNEY GENERAL.
- 6 (2) BY SEPTEMBER 1, 2016, EACH STATE GOVERNMENTAL UNIT SHALL
- 7 FORWARD A COPY OF ANY CROSS BOUNDARY MEMORANDUM OF AGREEMENT THAT
- 8 IT ENTERED INTO BEFORE SEPTEMBER 1, 2014, AND THAT IS LEGALLY
- 9 BINDING AND STILL IN EFFECT, TO THE OFFICE OF THE GREAT SEAL.
- 10 (3) THE OFFICE OF THE GREAT SEAL SHALL ESTABLISH AND MAINTAIN

- 1 A PUBLICLY ACCESSIBLE CENTRAL REPOSITORY AND SHALL ACCEPT AND
- 2 OFFICIALLY FILE EACH CROSS BOUNDARY MEMORANDUM OF AGREEMENT
- 3 FORWARDED TO IT UNDER SUBSECTION (1) OR (2) IN THE CENTRAL
- 4 REPOSITORY. THE OFFICE OF THE GREAT SEAL SHALL MAKE THE CENTRAL
- 5 REPOSITORY ACCESSIBLE VIA THE INTERNET BY 1 YEAR AFTER THE OFFICE
- 6 OF THE GREAT SEAL OR ITS ASSIGNEES OR SUCCESSORS MAKE INTERLOCAL
- 7 AGREEMENTS CREATED UNDER THE URBAN COOPERATION ACT OF 1967, 1967
- 8 (EX SESS) PA 7, MCL 124.501 TO 124.512, ACCESSIBLE TO THE PUBLIC
- 9 VIA THE INTERNET.
- 10 (4) THIS SECTION DOES NOT REQUIRE THE DISCLOSURE OF A PUBLIC
- 11 RECORD THAT IS OTHERWISE PROHIBITED BY LAW FROM PUBLIC DISCLOSURE,
- 12 IS PRIVILEGED, OR IS EXEMPT FROM DISCLOSURE UNDER THE FREEDOM OF
- 13 INFORMATION ACT, 1976 PA 442, MCL 15.231 TO 15.246. THIS SECTION
- 14 DOES NOT AND SHALL NOT BE CONSTRUED TO PROHIBIT OR PREEMPT FROM
- 15 PUBLIC DISCLOSURE ANY CROSS BOUNDARY MEMORANDUM OF AGREEMENT FOR
- 16 THE SOLE REASON THAT IT WAS EXECUTED BY THE GOVERNOR OR THE
- 17 LIEUTENANT GOVERNOR OR AN AGENT OR EMPLOYEE OF THE GOVERNOR OR
- 18 LIEUTENANT GOVERNOR.
- 19 (5) AS USED IN THIS ACT:
- 20 (A) "CROSS BOUNDARY MEMORANDUM OF AGREEMENT" MEANS A
- 21 MEMORANDUM OF AGREEMENT, MEMORANDUM OF UNDERSTANDING, MEMORANDUM OF
- 22 RECORD, COMPACT, OR SIMILAR AGREEMENT THAT A GOVERNMENTAL UNIT OR
- 23 OFFICER OF THIS STATE ENTERS INTO WITH THE FEDERAL GOVERNMENT OR A
- 24 UNIT OF GOVERNMENT LOCATED OUTSIDE OF THIS STATE.
- 25 (B) "GOVERNMENTAL UNIT" MEANS A STATE DEPARTMENT, AGENCY,
- 26 DIVISION, OR ANY OTHER ENTITY OR SUBUNIT DERIVED FROM THOSE PUBLIC
- 27 BODIES.

- Enacting section 1. This amendatory act takes effect September 1
- 1, 2013. 2
