SUBSTITUTE FOR HOUSE BILL NO. 4927

A bill to amend 1939 PA 280, entitled "The social welfare act,"

(MCL 400.1 to 400.119b) by adding section 5a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 5A. (1) IN ACCORDANCE WITH SECTION 23G OF CHAPTER X OF
- 2 THE PROBATE CODE OF 1939, 1939 PA 288, MCL 710.23G, AND SECTION 14E
- 3 OF 1973 PA 116, MCL 722.124E, THE STATE OR A LOCAL UNIT OF
- 4 GOVERNMENT SHALL NOT DISCRIMINATE OR TAKE AN ADVERSE ACTION AGAINST
- 5 A CHILD PLACING AGENCY ON THE BASIS THAT THE CHILD PLACING AGENCY
- 6 HAS DECLINED TO PROVIDE FOSTER CARE OR ADOPTION SERVICES THAT
- 7 CONFLICT WITH, OR DECLINED TO PROVIDE FOSTER CARE OR ADOPTION
- 8 SERVICES UNDER CIRCUMSTANCES THAT CONFLICT WITH, THE CHILD PLACING
- 9 AGENCY'S SINCERELY HELD RELIGIOUS BELIEFS CONTAINED IN A WRITTEN

- 1 POLICY, STATEMENT OF FAITH, OR OTHER DOCUMENT ADHERED TO BY THE
- 2 CHILD PLACING AGENCY.
- 3 (2) FOR THE PURPOSE OF THIS SECTION, THE TERM "FOSTER CARE OR
- 4 ADOPTION SERVICES" INCLUDES COMPLETING A HOME STUDY FOR A FOSTER
- 5 CARE PLACEMENT FOR AN INDIVIDUAL OR INDIVIDUALS WHO DESIRE TO BE
- 6 FOSTER PARENTS, COMPLETING A CHILD ADOPTIVE ASSESSMENT FOR AN
- 7 ADOPTIVE PLACEMENT FOR AN INDIVIDUAL OR INDIVIDUALS WHO DESIRE TO
- 8 ADOPT A CHILD, OR OTHERWISE PARTICIPATING IN A PLACEMENT OF A CHILD
- 9 FOR FOSTER CARE OR ADOPTION.
- 10 Enacting section 1. It is the intent of the legislature to
- 11 protect child placing agencies' free exercise of religion protected
- 12 by the United States constitution and the state constitution of
- 13 1963. This amendatory act is not intended to limit or deny any
- 14 person's right to adopt a child or participate in foster care.
