## SENATE SUBSTITUTE FOR HOUSE BILL NO. 4303

A bill to amend 1980 PA 299, entitled "Occupational code,"

(MCL 339.101 to 339.2919) by adding section 1806a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1806A. (1) THE DEPARTMENT MAY ISSUE A COURTESY LICENSE TO
- 2 ENGAGE IN THE PRACTICE OF MORTUARY SCIENCE TO AN INDIVIDUAL IF THE
- 3 DEPARTMENT DETERMINES THAT ALL OF THE FOLLOWING ARE MET:
- 4 (A) THE INDIVIDUAL HOLDS A VALID LICENSE TO PRACTICE MORTUARY
- 5 SCIENCE, FUNERAL DIRECTING, OR ANOTHER OCCUPATION THAT IS THE
- 6 EQUIVALENT OF THE PRACTICE OF MORTUARY SCIENCE OR FUNERAL
- 7 DIRECTING, ISSUED BY THE STATE OF INDIANA, OHIO, OR WISCONSIN.
- 8 (B) THE STATE THAT ISSUED THE LICENSE DESCRIBED IN SUBDIVISION
- 9 (A) BY LAW PROVIDES INDIVIDUALS LICENSED UNDER THIS ARTICLE

- 1 SUBSTANTIALLY THE SAME OPPORTUNITY TO PRACTICE IN THAT STATE AS ITS
- 2 LICENSEES ARE AUTHORIZED TO PRACTICE IN THIS STATE UNDER THIS
- 3 SECTION.
- 4 (2) A COURTESY LICENSE IS VALID FOR 2 YEARS, BEGINNING ON THE
- 5 DATE IT IS ISSUED OR RENEWED.
- 6 (3) AN INDIVIDUAL WHO HOLDS A COURTESY LICENSE MAY DO ANY OF
- 7 THE FOLLOWING:
- 8 (A) REMOVE A DEAD HUMAN BODY FROM THE PLACE OF DEATH IN THIS
- 9 STATE.
- 10 (B) REGISTER WITH A LOCAL REGISTRAR UNDER SECTION 1807.
- 11 (C) SUBJECT TO SECTION 1807, TRANSPORT A DEAD HUMAN BODY TO OR
- 12 FROM THE STATE IN WHICH HE OR SHE IS LICENSED.
- 13 (D) SUBJECT TO SECTION 1807, SUPERVISE THE FINAL DISPOSITION
- 14 IN THIS STATE OF THE HUMAN BODY OF AN INDIVIDUAL WHO DIED IN THE
- 15 STATE IN WHICH HE OR SHE IS LICENSED.
- 16 (4) AN INDIVIDUAL WHO HOLDS ONLY A COURTESY LICENSE SHALL NOT
- 17 DO ANY OF THE FOLLOWING IN THIS STATE:
- 18 (A) OPERATE A FUNERAL ESTABLISHMENT.
- 19 (B) ENGAGE IN THE PRACTICE OF EMBALMING.
- 20 (C) ADVERTISE MORTUARY SCIENCE, FUNERAL DIRECTING, OR
- 21 CREMATION SERVICES.
- 22 (D) DIRECTLY OR INDIRECTLY OWN, MANAGE, OPERATE, MAINTAIN, OR
- 23 BE EMPLOYED BY A CEMETERY OR CREMATORY OR ENGAGE IN ANY SIMILAR
- 24 ACTIVITY FOR WHICH REGISTRATION IS REQUIRED UNDER THE CEMETERY
- 25 REGULATION ACT, 1968 PA 251, MCL 456.521 TO 456.543.
- 26 (E) VIOLATE SECTION 1810.
- 27 (5) THE DEPARTMENT SHALL ENSURE THAT A COURTESY LICENSE IS

- ISSUED WITH THE RESTRICTIONS DESCRIBED IN THIS SECTION. 1
- 2 (6) AS USED IN THIS SECTION, "COURTESY LICENSE" MEANS A
- LICENSE ISSUED UNDER THIS ARTICLE TO AN INDIVIDUAL DESCRIBED IN 3
- SUBSECTION (1) THAT IS SUBJECT TO THE RESTRICTIONS DESCRIBED IN
- THIS SECTION. 5
- Enacting section 1. This amendatory act takes effect upon the
- 7 expiration of 90 days after the date it is enacted into law.
