## SENATE SUBSTITUTE FOR HOUSE BILL NO. 4605

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 20950 (MCL 333.20950), as amended by 2006 PA 568.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 20950. (1) An individual shall not practice or advertise
- 2 to practice as a medical first responder, emergency medical
- 3 technician, emergency medical technician specialist, paramedic, or
- 4 emergency medical services instructor-coordinator unless licensed
- 5 to do so by the department UNDER THIS SECTION.
- 6 (2) The department shall issue a license under this section
- 7 only to an individual who meets all of the following requirements:
- 8 (a) Is 18 years of age or older.

- 1 (B) MEETS EITHER OF THE FOLLOWING REQUIREMENTS:
- 2 (i) (b) Has successfully completed the appropriate education
- 3 program approved under section 20912.
- 4 (ii) WHILE SERVING AS A MEMBER OF THE ARMED FORCES, SERVED AS A
- 5 MILITARY HEALTH CARE SPECIALIST AND WAS SEPARATED FROM SERVICE WITH
- 6 AN HONORABLE CHARACTER OF SERVICE OR UNDER AN HONORABLE CONDITIONS
- 7 (GENERAL) CHARACTER OF SERVICE IN THE 2-YEAR PERIOD PRECEDING THE
- 8 DATE THE LICENSE APPLICATION IS FILED. THE APPLICANT SHALL PROVIDE
- 9 A FORM DD214, DD215, OR ANY OTHER FORM THAT IS SATISFACTORY TO THE
- 10 DEPARTMENT TO MEET THE CRITERIA ESTABLISHED IN THIS SUBPARAGRAPH.
- 11 THIS SUBPARAGRAPH ONLY APPLIES TO AN APPLICANT FOR A LICENSE AS AN
- 12 EMERGENCY MEDICAL TECHNICIAN.
- 13 (c) Subject to subsection (3), has attained a passing score on
- 14 the appropriate department prescribed examination, as follows:
- 15 (i) A medical first responder shall—MUST pass the written
- 16 examination proctored by the department or the department's
- 17 designee and a practical examination approved by the department.
- 18 The practical examination shall be administered by the instructors
- 19 of the medical first responder course. The department or the
- 20 department's designee may also proctor the practical examination.
- 21 THE INDIVIDUAL SHALL PAY THE FEE FOR THE WRITTEN EXAMINATION
- 22 REQUIRED UNDER THIS SUBPARAGRAPH DIRECTLY TO THE NATIONAL REGISTRY
- 23 OF EMERGENCY MEDICAL TECHNICIANS OR OTHER ORGANIZATION APPROVED BY
- 24 THE DEPARTMENT.
- 25 (ii) An emergency medical technician, emergency medical
- 26 technician specialist, and a OR paramedic shall MUST pass the
- 27 written examination proctored by the department or the department's

- 1 designee and a practical examination proctored by the department or
- 2 the department's designee. THE INDIVIDUAL SHALL PAY THE FEE FOR THE
- 3 WRITTEN EXAMINATION REQUIRED UNDER THIS SUBPARAGRAPH DIRECTLY TO
- 4 THE NATIONAL REGISTRY OF EMERGENCY MEDICAL TECHNICIANS OR OTHER
- 5 ORGANIZATION APPROVED BY THE DEPARTMENT.
- 6 (iii) The fee for the written examinations required under
- 7 subparagraphs (i) and (ii) shall be paid directly to the national
- 8 registry of emergency medical technicians or other organization
- 9 approved by the department.
- 10 (d) Meets other requirements of this part.
- 11 (3) The department shall require for purposes of compliance
- 12 with subsection (2)(c) successful passage by each first-time
- 13 applicant of an examination. as that term is defined in section
- **14** 20904 (10).
- 15 (4) The department shall issue a license as an emergency
- 16 medical services instructor-coordinator only to an individual who
- 17 meets the requirements of subsection (2) for an emergency medical
- 18 services instructor-coordinator and at the time of application is
- 19 currently licensed as a medical first responder, emergency medical
- 20 technician, emergency medical technician specialist, or paramedic
- 21 and has at least 3 years' field experience with a licensed life
- 22 support agency as a medical first responder, emergency medical
- 23 technician, emergency medical technician specialist, or paramedic.
- 24 The department shall provide for the development and administration
- 25 of an examination for emergency medical services instructor-
- 26 coordinators. The license shall specify the level of instruction-
- 27 coordination the individual is licensed to provide. An emergency

- 1 medical services instructor-coordinator shall not instruct or
- 2 coordinate emergency medical training courses at a level that
- 3 exceeds his or her designated level of licensure and for which he
- 4 or she does not have at least 3 years' field experience at that
- 5 level of licensure.
- 6 (5) Except as **OTHERWISE** provided by IN section 20952, a
- 7 license under this section is effective for 3 years from the date
- 8 of issuance unless revoked or suspended by the department.
- 9 (6) Except as otherwise provided in subsection (7), THIS
- 10 SECTION, an applicant for licensure under this section shall pay
- 11 the following triennial licensure fees:
- 12 (a) Medical first responder no fee.
- 13 (b) Emergency medical technician \$40.00.
- 14 (c) Emergency medical technician specialist \$60.00.
- 15 (d) Paramedic \$80.00.
- 16 (e) Emergency medical services instructor-coordinator -
- **17** \$100.00.
- 18 (7) If a life support agency certifies to the department that
- 19 an applicant for licensure under this section will act as a
- 20 volunteer and if the life support agency does not charge for its
- 21 services, the department shall not require the applicant to pay the
- 22 fee required under subsection (6). If the applicant ceases to meet
- 23 the definition of a volunteer under this part at any time during
- 24 the effective period of his or her license and is employed as a
- 25 licensee under this part, the applicant shall at that time pay the
- 26 fee required under subsection (6).
- 27 (8) THE DEPARTMENT SHALL WAIVE THE FEE REQUIRED UNDER

- 1 SUBSECTION (6) FOR THE INITIAL LICENSE IF THE APPLICANT FOR INITIAL
- 2 LICENSURE WAS SEPARATED FROM SERVICE WITH AN HONORABLE CHARACTER OF
- 3 SERVICE OR UNDER HONORABLE CONDITIONS (GENERAL) CHARACTER OF
- 4 SERVICE IN THE ARMED FORCES. THE APPLICANT SHALL PROVIDE A FORM
- 5 DD214, DD215, OR ANY OTHER FORM THAT IS SATISFACTORY TO THE
- 6 DEPARTMENT TO BE ELIGIBLE FOR THE WAIVER OF THE FEE UNDER THIS
- 7 SUBSECTION.
- 8 (9) AS USED IN THIS SECTION, "ARMED FORCES" MEANS THAT TERM AS
- 9 DEFINED IN SECTION 2 OF THE VETERAN RIGHT TO EMPLOYMENT SERVICES
- 10 ACT, 1994 PA 39, MCL 35.1092.
- 11 Enacting section 1. This amendatory act takes effect upon the
- 12 expiration of 90 days after the date it is enacted into law.
