

HOUSE SUBSTITUTE FOR
SENATE BILL NO. 7

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending section 2133 (MCL 324.2133), as added by 1995 PA 60.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 2133. (1) ~~A notice of~~ **NOT LESS THAN 10 DAYS BEFORE** a
2 sealed or oral bid public auction sale of surplus lands, **A NOTICE**
3 **OF THE SALE** shall be published at least once in a newspaper as
4 defined in ~~section 1461 of the revised judicature act of 1961, Act~~
5 ~~No. 236 of the Public Acts of 1961, being section 600.1461 of the~~
6 ~~Michigan Compiled Laws, not less than 10 days before the sale. The~~
7 ~~newspaper shall be~~ **SECTION 1 OF 1963 PA 247, MCL 691.1051, THAT IS**
8 published in the county where the surplus lands are located. If a
9 ~~newspaper is not published~~ **THERE IS NO PUBLICATION OR WEBSITE THAT**

1 in the county where the surplus lands are located **OR IN AN**
 2 **ADJOINING COUNTY**, the notice shall be published in a newspaper in a

 4 notice shall describe the general location of the surplus lands to
 5 be offered at the sale and the date, time, and place of the sale.
 6 Upon request, the department shall furnish a list of surplus lands
 7 being offered for sale at public auction. The surplus land sale
 8 list shall include all of the following:

9 (a) The date, time, and place of sale.

10 (b) Descriptions of surplus lands being offered.

11 (c) The conditions of sale.

12 (2) ~~A notice of~~ **NOT LESS THAN 10 DAYS BEFORE THE DEPARTMENT**
 13 **SELLS SURPLUS LANDS IN** a negotiated sale, ~~of surplus lands~~ **NOTICE**
 14 **OF THE SALE** shall be published at least once in a newspaper as
 15 defined in ~~section 1461 of the revised judicature act of 1961 not~~
 16 ~~less than 10 days before the department authorizes the sale. The~~

 26 department will meet to authorize the sale. Upon request, the
 27 department shall furnish a list of surplus lands being offered in a

1 negotiated sale. The surplus land negotiated sale list shall
2 include both of the following:

3 (a) The date, time, and place that the department will meet to
4 authorize the sale.

5 (b) Descriptions of surplus lands being offered.

6 Enacting section 1. This amendatory act takes effect on the
7 expiration of 90 days after the date it is enacted into law.

8 Enacting section 2. This amendatory act does not take effect
9 unless Senate Bill No. 8 of the 97th Legislature is enacted into
10 law.
