## HOUSE SUBSTITUTE FOR SENATE BILL NO. 92

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending sections 16333, 17703, 17707, 17711, 17721, and 17731 (MCL 333.16333, 333.17703, 333.17707, 333.17711, 333.17721, and 333.17731), section 16333 as added by 1993 PA 80, section 17703 as amended by 2012 PA 209, section 17707 as amended by 1990 PA 333, sections 17711 and 17721 as amended by 2006 PA 390, and section 17731 as amended by 1994 PA 234, and by adding sections 17739, 17739a, 17739b, and 17739c.

27	other animals.		
28	(2) "Dispense" means to issue 1 or more doses of a drug for		
29	subsequent administration to, or use by, a patient.		

- 1 (3) "Dispensing prescriber" means a prescriber , other than
- 2 a veterinarian, who dispenses prescription drugs.WHO IS REQUIRED
- 3 TO OBTAIN A DRUG CONTROL LICENSE, OR IS EXCLUDED FROM THAT
- 4 REQUIREMENT, UNDER SECTION 17745(1).
- 5 (4) "Drug" means any of the following:
- 6 (a) A substance recognized or for which the standards or
- 7 specifications are prescribed in the official compendium.
- 8 (b) A substance intended for use in the diagnosis, cure,
- 9 mitigation, treatment, or prevention of disease in human beings
- 10 or other animals.
- 11 (c) A substance, other than food, intended to affect the
- 12 structure or a function of the body of human beings or other
- 13 animals.
- 14 (d) A substance intended for use as a component of a
- 15 substance specified in subdivision (a), (b), or (c), but not
- 16 including a device or its components, parts, or accessories.
- 17 (5) "Electronic signature" means an electronic sound,
- 18 symbol, or process attached to or logically associated with a
- 19 record and executed or adopted by a person with the intent to
- 20 sign the record.
- 21 (6) "Electronically transmitted prescription" means the
- 22 communication of an original prescription or refill authorization
- 23 by electronic means including computer to computer, computer to
- 24 facsimile machine, or electronic mail transmission that contains
- 25 the same information it contained when the prescriber or his or
- 26 her agent transmitted the prescription. Electronically
- 27 transmitted prescription does not include a prescription or

- 3 Sec. 17707. (1) "Personal charge" means the immediate
- 4 physical presence of a pharmacist or dispensing prescriber.
- 5 (2) "Pharmacist" means an individual licensed under this
- 6 article to engage in the practice of pharmacy.
- 7 (3) "Pharmacist intern" or "intern" means an individual who
- 8 satisfactorily completes the requirements set forth in rules
- 9 promulgated by the board and is licensed by the board for the
- 10 purpose of obtaining instruction in the practice of pharmacy from
- 11 a preceptor approved by the board.
- 12 (4) "Pharmacy" means a building or part of a building in
- 13 which the practice of pharmacy is conducted.
- 14 (5) "PHARMACY TECHNICIAN" MEANS AN INDIVIDUAL WHO IS
- 15 REQUIRED TO HOLD A HEALTH PROFESSION SUBFIELD LICENSE UNDER THIS
- 16 PART TO SERVE AS A PHARMACY TECHNICIAN.
- 17 (6) (5) "Practice of pharmacy" means a health service, the
- 18 clinical application of which includes the encouragement of
- 19 safety and efficacy in the prescribing, dispensing,
- 20 administering, and use of drugs and related articles for the
- 21 prevention of illness, and the maintenance and management of
- 22 health. PRACTICE OF PHARMACY INCLUDES THE DIRECT OR INDIRECT
- 23 PROVISION OF PROFESSIONAL FUNCTIONS AND SERVICES ASSOCIATED WITH
- 24 THE PRACTICE OF PHARMACY. Professional functions associated with
- 25 the practice of pharmacy include:
- (a) The interpretation and evaluation of the prescription.
- 27 (b) Drug product selection.

- 1 (c) The compounding, dispensing, safe storage, and
- 2 distribution of drugs and devices.
- 3 (d) The maintenance of legally required records.
- 4 (e) Advising the prescriber and the patient as required as
- 5 to contents, therapeutic action, utilization, and possible
- 6 adverse reactions or interactions of drugs.
- 7 Sec. 17711. (1) A person shall not engage in the practice of
- 8 pharmacy OR SERVE AS A PHARMACY TECHNICIAN unless licensed or
- 9 otherwise authorized by this article.
- 10 (2) The following words, titles, or letters or a combination
- 11 thereof, OF WORDS, TITLES, OR LETTERS, with or without qualifying
- 12 words or phrases, are restricted in use only to those persons
- 13 authorized under this part to use the terms and in a way
- 14 prescribed in this part: "pharmacy", "pharmacist", "PHARM.D",
- 15 "DOCTOR OF PHARMACY", "PHARMACY INTERN", "PHARMACY TECHNICIAN",
- 16 "LICENSED PHARMACY TECHNICIAN", "CERTIFIED PHARMACY TECHNICIAN",
- 17 "CPHT", "apothecary", "DISPENSARY", "drugstore", "druggist",
- 18 "medicine store", "prescriptions", and "r.ph.".
- 19 Sec. 17721. (1) The Michigan board of pharmacy is created in
- 20 the department and shall consist of the following 11 voting
- 21 members who shall meet the requirements of part 161: 6
- 22 (A) SIX pharmacists. and 5
- 23 (B) ONE PHARMACY TECHNICIAN.
- 24 (C) FOUR public members.
- 25 (2) The terms of office of the individual members of the
- 26 board created under this section, except those appointed to fill
- 27 vacancies, expire 4 years after appointment on June 30 of the

- 1 year in which the term expires.
- 2 Sec. 17731. (1) Notwithstanding the requirements of part
- 3 161, the board may require EITHER OF THE FOLLOWING:
- 4 (A) THAT a licensee seeking renewal of a pharmacist's
- 5 license to furnish the board with satisfactory evidence that
- 6 during the 2 years immediately preceding application for renewal,
- 7 the applicant has HE OR SHE attended continuing education courses
- 8 or programs, approved by the board, totaling not less than 30
- 9 hours or the satisfactory completion of SATISFACTORILY COMPLETED
- 10 a proficiency examination according to rules promulgated by the
- 11 board.
- 12 (B) THAT A LICENSEE SEEKING RENEWAL OF A PHARMACY
- 13 TECHNICIAN'S LICENSE FURNISH THE BOARD WITH SATISFACTORY EVIDENCE
- 14 THAT DURING THE 2 YEARS IMMEDIATELY PRECEDING APPLICATION FOR
- 15 RENEWAL, HE OR SHE HAS ATTENDED AT LEAST 20 HOURS OF CONTINUING
- 16 EDUCATION COURSES OR PROGRAMS, APPROVED BY THE BOARD, OR
- 17 SATISFACTORILY COMPLETED A PROFICIENCY EXAMINATION ACCORDING TO
- 18 RULES PROMULGATED BY THE BOARD.
- 19 (2) As required under section 16204, the board shall
- 20 promulgate rules requiring each applicant for license renewal to
- 21 complete as part of the continuing education or proficiency
- 22 examination requirement of subsection (1) an appropriate number
- 23 of hours or courses in pain and symptom management.
- 24 SEC. 17739. (1) AN INDIVIDUAL WHO PERFORMS ANY OF THE
- 25 FOLLOWING FUNCTIONS IS CONSIDERED TO BE SERVING AS A PHARMACY
- 26 TECHNICIAN AND, EXCEPT AS OTHERWISE PROVIDED IN THIS PART, IS

- 3 SUBSTANCES PRESCRIPTIONS.
- 4 (C) COMPOUNDING DRUGS.
- 5 (D) PREPARING OR MIXING INTRAVENOUS DRUGS FOR INJECTION INTO
- 6 A HUMAN PATIENT.
- 7 (E) CONTACTING PRESCRIBERS CONCERNING PRESCRIPTION DRUG
- 8 ORDER CLARIFICATION, WHICH DOES NOT INCLUDE DRUG REGIMEN REVIEW
- 9 OR CLINICAL OR THERAPEUTIC INTERPRETATION.
- 10 (F) RECEIVING VERBAL ORDERS FOR PRESCRIPTION DRUGS, EXCEPT
- 11 ORDERS FOR CONTROLLED SUBSTANCES.
- 12 (G) SUBJECT TO SECTION 16215, PERFORMING ANY OTHER FUNCTIONS
- 13 AUTHORIZED UNDER RULES PROMULGATED UNDER THIS PART.
- 14 (2) A PHARMACY OR DISPENSING PRESCRIBER THAT UTILIZES THE
- 15 SERVICES OF A PHARMACY TECHNICIAN SHALL ENSURE THAT ALL OF THE
- 16 FOLLOWING REQUIREMENTS, AS APPLICABLE, ARE MET:
- 17 (A) THE PHARMACY TECHNICIAN IS LICENSED OR OTHERWISE
- 18 AUTHORIZED TO SERVE AS A PHARMACY TECHNICIAN UNDER THIS PART.
- 19 (B) THE PHARMACY TECHNICIAN ONLY PERFORMS THE ACTIVITIES OR
- 20 FUNCTIONS THAT HE OR SHE IS LICENSED OR OTHERWISE AUTHORIZED TO
- 21 PERFORM UNDER THIS PART OR RULES PROMULGATED UNDER THIS PART.
- 22 (C) EXCEPT AS OTHERWISE PROVIDED BY RULE PROMULGATED UNDER
- 23 THIS PART, THE PHARMACY TECHNICIAN ONLY PERFORMS THE ACTIVITIES
- 24 OR FUNCTIONS DESCRIBED IN SUBDIVISION (B) UNDER THE SUPERVISION
- 25 AND PERSONAL CHARGE OF THE PHARMACIST OR DISPENSING PRESCRIBER.

- 27 DRUG RECORD-KEEPING REQUIREMENTS, PATIENT CONFIDENTIALITY, AND

- 1 PHARMACY SECURITY AND DRUG STORAGE.
- 2 (2) AN INDIVIDUAL WHO IS NOT A PHARMACIST, PHARMACIST
- 3 INTERN, OR PHARMACY TECHNICIAN SHALL NOT PERFORM ANY OF THE
- 4 FUNCTIONS DESCRIBED IN SECTION 17739(1) FOR A PHARMACY.
- 5 (3) A PHARMACIST SHALL NOT ALLOW ANY INDIVIDUAL EMPLOYED OR
- 6 OTHERWISE UNDER THE PERSONAL CHARGE OF THE PHARMACIST TO VIOLATE
- 7 SUBSECTION (2). A PERSON THAT OWNS, MANAGES, OPERATES, OR
- 8 CONDUCTS A PHARMACY SHALL NOT ALLOW ANY INDIVIDUAL EMPLOYED OR
- 9 OTHERWISE UNDER THE CONTROL OF THAT PERSON TO VIOLATE SUBSECTION
- 10 (2).
- 11 (4) AN INDIVIDUAL WHO MEETS ANY OF THE FOLLOWING IS NOT
- 12 REQUIRED TO MEET THE EXAMINATION REQUIREMENT DESCRIBED IN
- 13 SUBSECTION (1)(D) TO BE ELIGIBLE FOR A LICENSE UNDER SUBSECTION
- 14 (1):
- 15 (A) AS PROVIDED IN SECTION 16171(A), IS A STUDENT IN A
- 16 PHARMACY TECHNICIAN PROGRAM APPROVED BY THE BOARD.
- 17 (B) IS APPLYING FOR A TEMPORARY LICENSE UNDER SECTION
- 18 17739B.
- 19 (C) IS APPLYING FOR A LIMITED LICENSE UNDER SECTION 17739C.
- 20 SEC. 17739B. (1) SUBJECT TO SECTION 17739A(4), THE
- 21 DEPARTMENT MAY ISSUE A TEMPORARY LICENSE AS A PHARMACY TECHNICIAN
- 22 TO AN INDIVIDUAL WHO IS PREPARING FOR THE EXAMINATION UNDER
- 23 SECTION 17739A(1)(D). NOTWITHSTANDING SECTION 16181, THE TERM OF
- 24 A TEMPORARY LICENSE ISSUED UNDER THIS SECTION EXPIRES 210 DAYS
- 25 AFTER THE DATE THE TEMPORARY LICENSE IS ISSUED.
- 26 (2) AN INDIVIDUAL REQUESTING A TEMPORARY LICENSE UNDER THIS
- 27 SECTION SHALL SUBMIT A COMPLETED APPLICATION, ON A FORM

- 1 PRESCRIBED BY THE DEPARTMENT, TO THE DEPARTMENT AND PAY THE
- 2 APPLICABLE FEE UNDER SECTION 16333.
- 3 (3) AN INDIVIDUAL WHO HOLDS A TEMPORARY LICENSE AS A
- 4 PHARMACY TECHNICIAN ISSUED UNDER SUBSECTION (1) IS SUBJECT TO ALL
- 5 OF THE REQUIREMENTS OF THIS PART, AND RULES PROMULGATED UNDER
- 6 THIS PART, APPLICABLE TO PHARMACY TECHNICIANS EXCEPT THE
- 7 EXAMINATION REQUIREMENT UNDER SECTION 17739A(1)(D).
- 8 SEC. 17739C. (1) IN ADDITION TO THE REQUIREMENT OF SECTION
- 9 16182 AND SUBJECT TO SECTION 17739A(4), THE DEPARTMENT MAY ISSUE
- 10 A LIMITED LICENSE AS A PHARMACY TECHNICIAN TO AN INDIVIDUAL IF
- 11 ALL OF THE FOLLOWING ARE MET:
- 12 (A) THE INDIVIDUAL WAS EMPLOYED AS A PHARMACY TECHNICIAN BY
- 13 A PHARMACY ON THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED
- 14 THIS SECTION AND HAS BEEN CONTINUOUSLY EMPLOYED BY THAT PHARMACY
- 15 SINCE THAT DATE.
- 16 (B) THE INDIVIDUAL SUBMITS A COMPLETED APPLICATION TO THE
- 17 DEPARTMENT ON A FORM PRESCRIBED BY THE DEPARTMENT AND MEETS THE
- 18 REQUIREMENTS OF SECTION 16174.
- 19 (C) THE INDIVIDUAL PROVIDES DOCUMENTATION OF SATISFACTORY
- 20 EMPLOYMENT AS A PHARMACY TECHNICIAN FOR A MINIMUM OF 1,000 HOURS
- 21 DURING THE 2-YEAR PERIOD IMMEDIATELY PRECEDING THE DATE OF HIS OR
- 22 HER APPLICATION UNDER SUBDIVISION (B).
- 23 (D) THE APPLICABLE FEE UNDER SECTION 16333 IS PAID.
- 24 (2) AN INDIVIDUAL WHO HOLDS A LIMITED LICENSE UNDER THIS
- 25 SECTION MAY ONLY ACT AS A PHARMACY TECHNICIAN FOR THE PHARMACY
- 26 DESCRIBED IN SUBSECTION (1)(A) AND ONLY UNTIL 1 OF THE FOLLOWING

- 13 Enacting section 1. This amendatory act takes effect 90 days
- 14 after the date it is enacted into law.
