HOUSE SUBSTITUTE FOR SENATE BILL NO. 641

A bill to amend 1980 PA 299, entitled "Occupational code,"

by amending sections 2502a, 2504, and 2508 (MCL 339.2502a, 339.2504, and 339.2508), section 2502a as added by 2002 PA 611, section 2504 as amended by 2003 PA 196, and section 2508 as amended by 1988 PA 16, and by adding section 2504a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2502a. (1) Beginning November 1, 2003, the THE department
- 2 shall issue a license for A real estate broker, associate real
- 3 estate broker, and real estate salesperson for a term of 3 years.
- 4 (2) THE DEPARTMENT SHALL RENEW A LICENSE FOR A REAL ESTATE
- 5 BROKER, ASSOCIATE REAL ESTATE BROKER, OR REAL ESTATE SALESPERSON IF
- 6 THE DEPARTMENT RECEIVES AN APPLICATION FOR RENEWAL ON A FORM
- 7 PRESCRIBED BY THE DEPARTMENT, AND PAYMENT OF THE APPROPRIATE FEES,

- 1 WITHIN THE TIME PERIOD DESCRIBED IN SECTION 411(1) OR (2), AND THE
- 2 APPLICABLE REQUIREMENTS OF SECTION 2504A ARE MET.
- 3 (3) THE DEPARTMENT MAY RELICENSE WITHOUT EXAMINATION A PERSON
- 4 THAT FAILS TO RENEW A LICENSE ISSUED UNDER THIS ARTICLE WITHIN THE
- 5 TIME PERIOD DESCRIBED IN SUBSECTION (2) IF ALL OF THE FOLLOWING ARE
- 6 MET:
- 7 (A) THE PERSON APPLIES WITHIN 3 YEARS AFTER THE EXPIRATION
- 8 DATE OF THE PERSON'S LAST LICENSE.
- 9 (B) THE PERSON PAYS AN APPLICATION PROCESSING FEE, THE LATE
- 10 RENEWAL FEE, AND THE PER-YEAR LICENSE FEE FOR THE UPCOMING
- 11 LICENSURE PERIOD.
- 12 (C) PROOF OF THE PERSON'S COMPLETION OF 6 CLOCK HOURS OF
- 13 CONTINUING EDUCATION FOR EACH YEAR AND PARTIAL YEAR THAT HAVE

- 4 (C) HAS PASSED THE EXAMINATION REQUIRED FOR A REAL ESTATE
- 5 BROKER LICENSE UNDER SECTION 2505(5).
- 6 (5) THE DEPARTMENT MAY RELICENSE AN INDIVIDUAL WHO FAILED TO
- 7 RENEW A REAL ESTATE SALESPERSON LICENSE WITHIN 3 YEARS AFTER THE
- 8 EXPIRATION DATE OF HIS OR HER LAST LICENSE IF HE OR SHE PAYS AN
- 9 APPLICATION PROCESSING FEE, THE LATE RENEWAL FEE, AND THE PER-YEAR

- 20 Sec. 2504. (1) Before receiving BOTH OF THE FOLLOWING MUST BE

- 22 an applicant shall UNDER THIS ARTICLE:
- 23 (A) THE APPLICANT MUST submit an application as described in

- 4 (k) Real estate securities and syndications.
- 5 (l) Investments, including property management.
- 6 (4) Except as otherwise provided in this subsection, before
- 7 being permitted to renew an active real estate broker's or real
- 8 estate salesperson's license, a licensee shall have successfully
- 9 completed, within the preceding 12 months, not less than 6 clock
- 10 hours of continuing education approved by the department involving
- 11 any topics relevant to the management, operation, and practice of
- 12 real estate and covering changes in economic conditions, law,
- 13 rules, court cases, and interpretations, or any combination of
- 14 those changes, relating to real property which are pertinent to the
- 15 activities of a real estate broker or real estate salesperson.
- 16 Beginning November 1, 2003, a licensee shall complete not less than
- 17 18 hours of continuing education per 3-year license cycle. A
- 18 licensee shall complete at least 6 hours of the required 18 hours
- 19 of continuing education courses during the time period from
- 20 November 1, 2003 and ending on December 31, 2004. During calendar
- 21 year 2005, a licensee shall complete at least 6 hours of the
- 22 required 18 hours of continuing education courses. During calendar
- 23 year 2006, a licensee shall complete at least 4 hours of the
- 24 required 18 hours of continuing education courses. During calendar

licensee for further professional designation and approved by the 1 department as continuing education may be counted toward the total 2 continuing education credits required for the 3-year license cycle. 3 4 Each licensee, in completing the appropriate number of clock hours, will have the option of selecting the education courses in that 5 licensee's area of expertise, as long as the education courses are 6 approved by the department and as long as at least 2 hours of an 7 education course per calendar year involve law, rules, and court 8 cases regarding real estate. Notwithstanding the provisions of this 9 subsection, the department may renew the license of a licensee who 10 11 has completed not less than 18 hours of continuing education in the 12 subject matter areas required by this subsection during the 3-year license cycle but has not otherwise met the requirements of this 13 14 section if the licensee provides evidence satisfactory to the department that he or she has good cause for not complying with the 15 requirements in this subsection. 16 (5) The department may relicense without examination a 17 licensee whose license has lapsed for less than 3 years if the 18 19 licensee shows proof of completion of not less than 6 clock hours of continuing education for each year the license was lapsed, on 20 21 topics as described in subsection (4). (6) The department may relicense a broker whose license has 22 23 lapsed for 3 or more continuous years if the licensee provides proof of the successful completion of 1 of the following: 24 (a) Six clock hours of continuing education for each of the 25 years the license was lapsed on topics described in subsection (4). 26 27 (b) Ninety clock hours of instruction described in subsections 7

(1) and (3). 1 (c) Passing the examination required for licensure as a broker 2 as provided for in section 2505(5). 3 4 (7) A salesperson whose license has been lapsed for 3 or more continuous years may be relicensed if the licensee provides proof 5 of the successful completion of 1 of the following: 6 (a) Six clock hours of continuing education for each of the 7 years the license was lapsed on topics described in subsection (4). 8 (b) Forty clock hours of instruction described in subsections 9 (2) and (3). 10 11 (c) Passing the examination required for licensure as a 12 salesperson as provided in section 2505(5). (8) The department shall not apply the course credits used to 13 meet continuing education requirements provided in subsections (4) 14 through (7) towards the real estate broker's license education 15 requirements provided in subsection (1), and course credits taken 16 under real estate broker's license education requirements shall not 17 be applied towards the continuing education requirements. The 18 19 department shall apportion the approved course credits eligible for education requirements in subsection (1) and subsections (4) 20 through (7) to meet either requirement upon the licensee's request. 21 (9) For real estate brokers, associate brokers, and 22 salespersons who receive a license issued in the second or third 23 years of a 3-year license cycle, continuing education shall be in 24 compliance with subsection (4), except for the following: 25

- 12 (6) (12) The department may conduct, hold, or assist in

- 21 (4) An associate real estate broker's license THAT IS issued
- 22 to a principal is not transferable. An associate real estate
- 23 broker's license issued to a nonprincipal may be transferred in the
- 24 same manner as provided in section 2507 for the transfer of a real
- 25 estate salesperson's license.
- 26 (5) Upon the revocation of IF a real estate broker's license
- 27 IS REVOKED, the licenses of all real estate salespersons WHO ARE

- 1 employed by the real estate broker and all affiliated associate
- 2 real estate brokers shall ARE automatically be suspended, pending a
- 3 change of employer and the issuance of a new license. A THE
- 4 DEPARTMENT SHALL ISSUE A new license shall be issued UNDER THIS
- 5 SUBSECTION without charge if the license is issued during the
- 6 same term in which the original license was issued.
- 7 (6) IN THE EVENT OF THE DEATH OR DISABILITY OF A SOLE
- 8 PRINCIPAL ASSOCIATE BROKER, THE DEPARTMENT SHALL ALLOW ALL
- 9 AFFILIATED REAL ESTATE LICENSEES A REASONABLE TIME TO EITHER WIND
- 10 UP THE BUSINESS OF THE REAL ESTATE BROKER OR DESIGNATE A NEW
- 11 PRINCIPAL ASSOCIATE BROKER.
- 12 Enacting section 1. This amendatory act takes effect upon the
- 13 expiration of 90 days after the date it is enacted into law.
