SENATE BILL NO. 22

A bill to amend 1966 PA 346, entitled "State housing development authority act of 1966," (MCL 125.1401 to 125.1499c) by adding chapter 3C.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 CHAPTER 3C
- 2 SEC. 59D. THE STATE HISTORIC PRESERVATION OFFICE CREATED IN
- 3 EXECUTIVE ORDER NO. 2007-53 IS ESTABLISHED IN THE AUTHORITY.
- 4 SEC. 59E. (1) IN ADDITION TO ITS OTHER DUTIES, THROUGH
- 5 DECEMBER 31, 2018, THE STATE HISTORIC PRESERVATION OFFICE SHALL
- 6 REVIEW PROPOSED CHANGES TO THE EXTERIOR OF A SITE OWNED BY A
- 7 DOWNTOWN DEVELOPMENT AUTHORITY, OR FOR WHICH THE ACQUISITION,
- 8 REHABILITATION, OR DEMOLITION IS FINANCED BY A DOWNTOWN DEVELOPMENT
- 9 AUTHORITY, AND LISTED ON THE STATE REGISTER OF HISTORIC SITES OR

- THE NATIONAL REGISTER OF HISTORIC PLACES THAT IS NOT LOCATED IN A 1
- 2 LOCAL HISTORIC DISTRICT CREATED UNDER THE LOCAL HISTORIC DISTRICTS
- ACT, 1970 PA 169, MCL 399.201 TO 399.215. THE REVIEW SHALL BE 3
- CONDUCTED AS DESCRIBED IN 16 USC 470F AND THE RESPONSE SHALL BE
- 5 FORWARDED TO THE DOWNTOWN DEVELOPMENT AUTHORITY NOT LATER THAN 30
- DAYS AFTER THE STATE HISTORIC PRESERVATION OFFICE RECEIVES THE
- 7 REFERRAL FOR REVIEW. HOWEVER, FOR PROPOSED CHANGES THAT PROVIDE FOR
- THE DEMOLITION OF A STRUCTURE, THE DOWNTOWN DEVELOPMENT AUTHORITY 8
- SHALL NOT PROCEED UNLESS THE REVIEW BY THE STATE HISTORIC 9
- PRESERVATION OFFICE APPROVES THE DEMOLITION. IF THE STATE HISTORIC 10
- 11 PRESERVATION OFFICE DOES NOT APPROVE THE DEMOLITION, THEN THE
- 12 DOWNTOWN DEVELOPMENT AUTHORITY MAY APPEAL THE DECISION AS PROVIDED
- 13 IN THIS ACT IN THE SAME MANNER AS FOR SITES LOCATED WITHIN A LOCAL
- HISTORIC DISTRICT CREATED UNDER THE LOCAL HISTORIC DISTRICTS ACT, 14
