THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1307. (1) By the processing deadline, the department
- 2 shall approve or deny an application for a permit. If requested by
- 3 the permit applicant, the department shall extend the processing
- 4 period for a permit by not more than 120 days, as specified by the
- 5 applicant. If requested by the permit applicant, the department may
- 6 extend the processing period beyond the additional 120 days.
- 7 However, a processing period shall not be extended under this
- 8 subsection to a date later than 1 year after the application period
- 9 ends.
- 10 (2) THE APPROVAL OR DENIAL OF AN APPLICATION FOR A PERMIT
- 11 SHALL BE IN WRITING AND SHALL BE BASED UPON EVIDENCE THAT WOULD

- 14 (3) (2)—Approval of an application for a permit may be granted
- 15 with conditions or modifications necessary to achieve compliance
- 16 with the part or parts of this act under which the permit is
- 17 issued.
- 18 (4) (3) A denial of an application for a permit shall
- 19 DOCUMENT, AND ANY REVIEW UPHOLDING THE DECISION SHALL DETERMINE, to
- 20 the extent practical, specify all of the reasons for the denial,
- 21 including both ALL of the following:
- 22 (a) The THAT THE DECISION IS BASED ON SPECIFIC provisions of
- 23 this act or rules promulgated under this act. providing the basis
- 24 for the denial.
- 25 (B) THAT THE DECISION IS BASED UPON SUFFICIENT FACTS OR DATA,
- 26 WHICH ARE RECORDED IN THE FILE.

- 1 (C) (b) To the extent applicable, the scientific information
- 2 providing the basis for the denial.ALL OF THE FOLLOWING:
- 3 (i) THAT THE DECISION IS THE PRODUCT OF RELIABLE SCIENTIFIC
- 4 PRINCIPLES AND METHODS.
- 5 (ii) THAT THE DECISION HAS APPLIED THE PRINCIPLES AND METHODS
- 6 RELIABLY TO THE FACTS.
- 7 (5) $\frac{4}{2}$ Except for permits described in subsection $\frac{5}{2}$ (6), if
- 8 the department fails to satisfy the requirements of subsection (1)
- 9 with respect to an application for a permit, the department shall
- 10 pay the applicant an amount equal to 15% of the greater of the
- 11 following, as applicable:
- 12 (a) The amount of the application fee for that permit.
- 13 (b) If an assessment or other fee is charged on an annual or
- 14 other periodic basis by the department to a person holding the
- 15 permit for which the application was submitted, the amount of the
- 16 first periodic charge of that assessment or other fee for that
- 17 permit.
- 18 (6) (5) If the department fails to satisfy the requirements of
- 19 subsection (1) with respect to a permit required by section 11509,
- 20 11512, 30304, or 32603, the application shall be considered to be
- 21 approved and the department shall be considered to have made any
- 22 determination required for approval.
- 23 (7) (6) The failure of the department to satisfy the
- 24 requirements of subsection (1) or the fact that the department is
- 25 required to make a payment under subsection $\frac{(4)}{(5)}$ or is
- 26 considered to have approved a permit under subsection (5)—(6) shall
- 27 not be used by the department as the basis for discriminating

- 1 against the applicant. If the department is required to make a
- 2 payment under subsection $\frac{4}{5}$, the application shall be
- 3 processed in sequence with other applications for the same type of
- 4 permit, based on the date on which the processing period began,
- 5 unless the director determines on an application-by-application
- 6 basis that the public interest is best served by processing in a
- 7 different order.
- 8 (8) (7)—If the department fails to satisfy the requirements of
- 9 subsection (1) with respect to 10% or more of the applications for
- 10 a particular type of permit received during a quarter of the state
- 11 fiscal year, the department shall immediately devote resources from
- 12 that program to eliminate any backlog and satisfy the requirements
- 13 of subsection (1) with respect to new applications for that type of
- 14 permit within the next fiscal quarter.
- 15 (9) (8)—If the department fails to satisfy the requirements of
- 16 subsection (1), the director shall notify the appropriations
- 17 committees of the senate and house of representatives of the
- 18 failure. The notification shall be in writing and shall include
- 19 both of the following:
- 20 (a) An explanation of the reason for the failure.
- 21 (b) A statement of the amount the department was required to
- 22 pay the applicant under subsection $\frac{(4)}{(5)}$ or a statement that the
- 23 department was required to consider the application to be approved
- 24 under subsection (5) (6), as applicable.

- 20 complete when received.
- 21 (f) The amount of money refunded and discounts granted under
- 22 section 1307.
- 23 (g) The number of applications processed as provided in
- 24 section 1309.
- 25 (h) If a department failed to satisfy the requirements of
- 26 section 1307(1) with respect to 10% or more of the applications for
- 27 a particular type of permit received during a quarter of the state

- 2 which the requirements were not met, how the department attempted
- 3 to eliminate any backlog and satisfy the requirements of section
- 4 1307(1) with respect to new applications for that type of permit

- 7 SEC. 30101A. FOR THE PURPOSES OF THIS PART, THE POWERS,

- 17 (f) Construction and maintenance of minor drainage structures
- 18 and facilities which are identified by rule promulgated by the
- 19 department pursuant to section 30110. Before such a rule is
- 20 promulgated, the rule shall be approved by the majority of a
- 21 committee consisting of the director of the department, the
- 22 director of the department of agriculture AND RURAL DEVELOPMENT,
- 23 and the director of the state transportation department or their
- 24 designated representatives. The rules shall be reviewed at least
- **25** annually.

- 1 (viii) EMERGENCY RECONSTRUCTION OF RECENTLY DAMAGED PARTS OF THE
- 2 DRAIN. EMERGENCY RECONSTRUCTION MUST OCCUR WITHIN A REASONABLE
- 3 PERIOD OF TIME AFTER DAMAGE OCCURS IN ORDER TO QUALIFY FOR THIS
- 4 EXEMPTION.
- 5 (h) Projects constructed under the watershed protection and
- 6 flood prevention act, chapter 656, 68 Stat. 666, 16 USC 1001 to
- 7 1008 and 1010.
- 8 (i) Construction and maintenance of privately owned cooling or
- 9 storage ponds used in connection with a public utility except at
- 10 the interface with public waters.

- 13 under section 30110, if the maintenance is in place and in kind

- 5 material has been determined through testing to be 90% or more

- 8 (iii) Seawalls, bulkheads, or revetments of 500 feet or more.
- 9 (iv) Filling or draining of 1 acre or more of wetland
- 10 contiguous to a lake or stream.
- (v) New dredging or upland boat basin excavation in areas of
- 12 suspected contamination.
- 13 (vi) Shore projections, such as groins and underwater
- 14 stabilizers, that extend 150 feet or more into a lake or stream.
- 15 (vii) New commercial docks or wharves of 300 feet or more in
- 16 length.
- 17 (viii) Stream enclosures 100 feet or more in length.
- 18 (ix) Stream relocations 500 feet or more in length.
- 19 (x) New golf courses.
- 20 (xi) Subdivisions.
- 21 (xii) Condominiums.
- 22 (F) (e)—For the removal of submerged logs from bottomland of
- 23 an inland lake, a \$500.00 fee.
- 24 (G) (f)—For all other projects not listed in subdivisions (a)
- 25 through $\frac{(e)}{(F)}$, a fee of \$500.00.
- 26 (3) A project that requires review and approval under this
- 27 part and 1 or more of the following acts or parts of acts is

- 1 subject to only the single highest permit fee required under this
- part or the following acts or parts of acts:
- 3 (A) SECTION 3104.
- **4 (B)** (a) Part 303.
- **(C)** (b) Part 323.
- **(D)** (c) Part 325.
- 7 (d) Section 3104.
- 8 (e) Section 117 of the land division act, 1967 PA 288, MCL
- **9** 560.117.
- 10 (4) If work has been done in violation of a permit requirement
- 11 under this part and restoration is not ordered by the department,
- 12 the department may accept an application for a permit if the
- 13 application is accompanied by a fee equal to 2 times the permit fee
- 14 required under this section.
- 15 (5) IF THE DEPARTMENT DENIES AN APPLICATION FOR A PERMIT UNDER
- 16 THIS PART, THE DEPARTMENT SHALL PROMPTLY REFUND THE APPLICATION FEE
- 17 PAID UNDER THIS SECTION.
- 18 Sec. 30105. (1) The department shall post on its website all
- 19 of the following under this part:
- 20 (a) A list of pending applications.
- 21 (b) Public notices.
- (c) Public hearing schedules.
- 23 (2) The department may hold a public hearing on pending
- 24 applications.
- 25 (3) Except as otherwise provided in this section, upon
- 26 receiving an application, the department shall submit copies for
- 27 review to the director of the department of community health or the

- 1 local health department designated by the director of the
- 2 department of community health, to the city, village, or township

- 3 and the county where the project is to be located, to the local
- 4 conservation district, to the watershed council established under
- 5 part 311, if any, to the local port commission, if any, and to the

- 17 and certify to the applicant that the applicant has complied with
- 18 the department's permit requirements.
- 19 (5) At least 10 days' notice of a hearing to be held under
- 20 this section shall be given by publication in a newspaper
- 21 circulated in the county where the project is to be located, to the
- 22 person requesting the hearing, and to the persons and governmental
- 23 units AND OTHER PERSONS that are entitled to receive a copy of the
- 24 application pursuant to subsection (3).
- 25 (6) In an emergency, the department may issue a conditional
- 26 permit before the expiration of the 20-day period referred to in
- 27 subsection (3).

- 1 (7) After providing notice and an opportunity for a public
- 2 hearing, the department shall establish minor project categories of
- 3 activities and projects that are similar in nature, have minimal
- 4 adverse environmental effects when performed separately, and will
- 5 have only minimal cumulative adverse effects on the environment.
- 6 The department may act upon an application received pursuant to
- 7 section 30104 for an activity or project within a minor project
- 8 category without providing notices pursuant to subsection (3). All
- 9 other provisions of this part, except provisions applicable only to
- 10 general permits, are applicable to a minor project.
- 11 (8) The department, after notice and an opportunity for a
- 12 public hearing, shall issue general permits on a statewide basis or
- 13 within a local unit of government for projects that are similar in
- 14 nature, that will cause only minimal adverse environmental effects
- 15 when performed separately, and that will only have minimal
- 16 cumulative adverse effects on the environment. Before authorizing a
- 17 specific project to proceed under a general permit, the department
- 18 may provide notice pursuant to subsection (3) but shall not hold a
- 19 public hearing and shall not typically require a site inspection. A
- 20 general permit issued under this subsection shall not be valid for
- 21 more than 5 years. Among the activities the department may consider
- 22 for general permit eligibility under this subsection are the
- 23 following:
- 24 (a) The removal of qualifying small dams.
- 25 (b) The maintenance or repair of an existing pipeline, if the

- 7 (5) If work has been done in violation of a permit requirement

- 9 the department may accept an application for a permit if the

- 11 APPLICATION fee otherwise required under this section.
- 12 (6) If the department determines that a permit is not required
- 13 under this part OR DENIES AN APPLICATION FOR A PERMIT UNDER THIS
- 14 PART, the department shall promptly refund the APPLICATION fee paid
- 15 under this section.
- 16 (7) THE DEPARTMENT MAY ISSUE A CONDITIONAL PERMIT BEFORE THE
- 17 EXPIRATION OF THE 20-DAY PERIOD REFERRED TO IN SECTION 30307 IF

- 12 FOOTPRINT OF THE STRUCTURE AND NOT THE SQUARE FOOTAGE OF THE

- 27 (10) THE DEPARTMENT SHALL ESTABLISH A WETLAND MITIGATION BANK

- 1 FUNDING PROGRAM UNDER PART 52 THAT PROVIDES GRANTS AND LOANS TO
- 2 ELIGIBLE MUNICIPALITIES FOR THE PURPOSES OF ESTABLISHING MITIGATION
- 3 BANKS.

- 11 (2) At least 2 hearings shall be held in each state planning
- 12 and development region created by Executive Directive No. 1973-1.

- 21 DEPARTMENT DETERMINES THAT THERE IS NO DIRECT PHYSICAL CONTACT AND

- 5 (5) The department shall forward all fees collected under this
- 6 section to the state treasurer for deposit into the land and water
- 7 management permit fee fund created in section 30113.
