## SUBSTITUTE FOR SENATE BILL NO. 382

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"

(MCL 600.101 to 600.9947) by adding section 3206.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 3206. (1) THIS SECTION APPLIES TO A FORECLOSURE
- 2 PROCEEDING UNDER THIS CHAPTER OF A MORTGAGE OF PROPERTY USED AS A
- 3 PRIMARY RESIDENCE TO WHICH BOTH OF THE FOLLOWING APPLY:
- 4 (A) THE FIRST NOTICE UNDER SECTION 3208 IS MAILED TO THE
- 5 MORTGAGOR AFTER JANUARY 9, 2014.
- 6 (B) THE PARTY FORECLOSING THE MORTGAGE IS A DEFENDANT THAT
- 7 ENTERED INTO A CONSENT JUDGMENT IN UNITED STATES OF AMERICA, ET AL.
- 8 V BANK OF AMERICA CORP., ET AL., CIVIL ACTION NO. 12-0361 IN THE
- 9 UNITED STATES DISTRICT COURT FOR THE DISTRICT OF COLUMBIA OR A

- 1 SUCCESSOR IN INTEREST TO SUCH A DEFENDANT.
- 2 (2) IN A FORECLOSURE PROCEEDING TO WHICH THIS SECTION APPLIES,
- 3 THE PERSON FORECLOSING THE MORTGAGE SHALL DO ALL OF THE FOLLOWING:
- 4 (A) DESIGNATE AN INDIVIDUAL WHO IS AN EMPLOYEE OR AGENT OF THE
- 5 PERSON OR OF ANOTHER ENTITY THAT IS AN AGENT OF THE PERSON OR
- 6 DESIGNATE A SPECIFIC DEPARTMENT OR UNIT OF THE PERSON OR OF AN
- 7 ENTITY THAT IS AN AGENT OF THE PERSON TO SERVE AS A CONTACT UNDER
- 8 THIS SECTION.
- 9 (B) AUTHORIZE THE INDIVIDUAL DESIGNATED UNDER SUBDIVISION (A)
- 10 OR, IF THE DESIGNEE IS A DEPARTMENT OR UNIT, A REPRESENTATIVE OF
- 11 THE DEPARTMENT OR UNIT TO FACILITATE NEGOTIATIONS AND ATTEND
- 12 MEETINGS WITH THE MORTGAGOR.
- 13 (C) INCLUDE IN THE WRITTEN NOTICE THE PERSON SENDS TO THE
- 14 MORTGAGOR UNDER 12 CFR 1024.39(B), OR ENCLOSE WITH THE NOTICE A
- 15 SEPARATE WRITTEN NOTICE THAT CONTAINS, ALL OF THE FOLLOWING
- 16 INFORMATION:
- 17 (i) THE NAME AND ADDRESS AND A DEDICATED TELEPHONE NUMBER AND
- 18 DEDICATED ELECTRONIC MAIL ADDRESS OF THE INDIVIDUAL, DEPARTMENT, OR
- 19 UNIT DESIGNATED UNDER SUBDIVISION (A).
- 20 (ii) A STATEMENT THAT THE MORTGAGOR MAY, WITHIN 30 DAYS, EITHER
- 21 BY CONTACTING THE INDIVIDUAL, DEPARTMENT, OR UNIT DESIGNATED UNDER
- 22 SUBDIVISION (A) DIRECTLY OR BY CONTACTING A HOMEOWNERSHIP COUNSELOR
- 23 OR COUNSELING ORGANIZATION FROM A LIST REFERRED TO IN THE WRITTEN
- 24 NOTICE UNDER 12 CFR 1024.39(B), REQUEST A MEETING WITH THE
- 25 INDIVIDUAL, DEPARTMENT, OR UNIT DESIGNATED UNDER SUBDIVISION (A) TO
- 26 ATTEMPT TO WORK OUT A MODIFICATION OF THE MORTGAGE LOAN TO AVOID
- 27 FORECLOSURE.

- (D) IF THE MORTGAGOR REQUESTS A MEETING UNDER SUBDIVISION (C), 1
- 2 NOT COMMENCE FORECLOSURE PROCEEDINGS UNDER THIS CHAPTER UNLESS THE
- 3 MEETING HAS BEEN HELD. THIS SUBDIVISION DOES NOT APPLY IF THE
- MORTGAGOR HAS NOT COOPERATED BY SCHEDULING A MEETING AT A TIME AND 4
- PLACE THAT IS CONVENIENT TO ALL PARTIES, OR IN THE COUNTY WHERE THE 5
- PROPERTY IS SITUATED, OR HAS NOT ATTENDED A SCHEDULED MEETING. 6
- 7 Enacting section 1. This amendatory act does not take effect
- 8 unless all of the following bills of the 97th Legislature are
- enacted into law:
- 10 (a) Senate Bill No. 380 or House Bill No. 4764.
- 11 (b) Senate Bill No. 381 or House Bill No. 4765.
- (c) Senate Bill No. 383 or House Bill No. 4767. 12
