SUBSTITUTE FOR

SENATE BILL NO. 443

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," by amending section 6094 (MCL 600.6094).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 6094. (1) Whenever any SUBJECT TO SUBSECTION (4), IF A
- 2 final judgment FOR DAMAGES is obtained ENTERED against the A school
- 3 district , if it OR AN INTERMEDIATE SCHOOL DISTRICT AND is not
- 4 removed to any other ANOTHER court, the treasurer of the SCHOOL
- 5 district OR INTERMEDIATE SCHOOL DISTRICT shall certify to the
- 6 supervisor of the township AND ASSESSING OFFICER OF THE TOWNSHIP OR
- 7 MUNICIPALITY IN WHICH THE SCHOOL DISTRICT OR INTERMEDIATE SCHOOL
- 8 DISTRICT IS LOCATED and to the director SECRETARY of the SCHOOL
- 9 district OR INTERMEDIATE SCHOOL DISTRICT the date and amount of the
- 10 judgment , with AND the name of the person in whose favor it was

- 1 rendered, and if ENTERED. IF the judgment is removed to another
- 2 court, the treasurer shall certify it as aforesaid—immediately
- 3 after the final determination thereof OF THE JUDGMENT against the
- 4 SCHOOL district OR INTERMEDIATE SCHOOL DISTRICT.
- 5 (2) If SUBJECT TO SUBSECTION (4), IF the treasurer fails to
- 6 certify the A judgment FOR DAMAGES AS REQUIRED BY SUBSECTION (1),
- 7 the party obtaining it, his executors, administrators, PERSON IN
- 8 WHOSE FAVOR THE JUDGMENT WAS ENTERED OR THE PERSON'S PERSONAL
- 9 REPRESENTATIVE or assigns , may file with the supervisor the A
- 10 certificate of the clerk of the court rendering THAT ENTERED the
- 11 judgment , showing THAT CONTAINS the facts which INFORMATION THAT
- 12 should have been certified by the treasurer.
- 13 (3) If the A SCHOOL district OR INTERMEDIATE SCHOOL DISTRICT
- 14 against which a judgment FOR DAMAGES is rendered ENTERED is
- 15 situated in part_LOCATED in 2 or more townships OR MUNICIPALITIES,
- 16 a certificate thereof_UNDER THIS SECTION shall be delivered as
- 17 aforesaid PROVIDED IN THIS SECTION to the supervisor of each
- 18 township AND ASSESSING OFFICER OF EACH TOWNSHIP OR MUNICIPALITY in
- 19 which PART OF the SCHOOL DISTRICT OR INTERMEDIATE SCHOOL district
- 20 is in part situated.LOCATED.
- 21 (4) THIS SECTION DOES NOT APPLY TO A JUDGMENT FOR DAMAGES THAT
- 22 RESULTS FROM AN ACTION TO ENFORCE A CONTRACT TO WHICH THE SCHOOL
- 23 DISTRICT OR INTERMEDIATE SCHOOL DISTRICT IS A PARTY AND THAT
- 24 SPECIFICALLY RELATES TO SCHOOL OPERATIONS, INCLUDING, BUT NOT
- 25 LIMITED TO, A COLLECTIVE BARGAINING AGREEMENT, A CONTRACT RELATING
- 26 TO EMPLOYMENT, A CONSTRUCTION CONTRACT, OR A PROCUREMENT CONTRACT.
- 27 (5) (4) The supervisor or supervisors receiving either of the

- 1 certificates AN ASSESSING OFFICER WHO RECEIVES A CERTIFICATE of a
- 2 judgment as aforesaid UNDER THIS SECTION shall proceed to assess
- 3 the amount thereof, OF THE JUDGMENT, with interest from the date of
- 4 the judgment to the time when the warrant for the collection
- 5 thereof OF THE JUDGMENT will expire, upon the taxable property of
- 6 the SCHOOL DISTRICT OR INTERMEDIATE SCHOOL district, placing it on
- 7 the next township assessment roll in the column for school taxes. τ
- 8 and the same proceedings shall be had, and it THE AMOUNT OF THE
- 9 JUDGMENT shall be collected and returned in the same manner as
- 10 other district taxes OF THE SCHOOL DISTRICT OR INTERMEDIATE SCHOOL
- 11 DISTRICT.
