A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

- 25 knowing that the minor will be used for child sexually abusive
- 26 activity. A person who violates this section is guilty of a felony
- 27 punishable by imprisonment for not more than 20 years. THE TESTIMONY

- 1 OF A VICTIM IS NOT REQUIRED IN A PROSECUTION UNDER THIS CHAPTER.
- 2 HOWEVER, IF A VICTIM TESTIFIES, THAT TESTIMONY NEED NOT BE
- 3 CORROBORATED.

- 26 penal code, 1931 PA 328, MCL 750.462i and 750.462j, are repealed.
- 27 Enacting section 2. This amendatory act takes effect 90 days

1 after the date it is enacted into law.
