SUBSTITUTE FOR HOUSE BILL NO. 5273

A bill to amend 2008 PA 551, entitled "Uniform securities act (2002),"

by amending the title and sections 202, 401, and 501 (MCL 451.2202, 451.2401, and 451.2501), section 202 as amended by 2013 PA 264, and by adding article 4A.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 TITLE

- 2 An act to enact the uniform securities act (2002) relating to
- 3 the issuance, offer, sale, or purchase of securities; to prohibit

- 4 Sec. 202. (1) The following transactions are exempt from the

- 6 (a) An isolated nonissuer transaction, whether effected by or

- 9 registered or exempt from registration under this act, and a resale
- 10 transaction by a sponsor of a unit investment trust registered
- 11 under the investment company act of 1940, in a security of a class
- 12 that has been outstanding in the hands of the public for at least
- 13 90 days, if all of the following are met at the date of the

- 15 (i) The issuer of the security is engaged in business, the
- 16 issuer is not in the organizational stage or in bankruptcy or

- 20 or combination of the business with, or an acquisition of, an
- 21 unidentified person.
- 22 (ii) The security is sold at a price reasonably related to its

- 24 (iii) The security does not constitute the whole or part of an
- 25 unsold allotment to, or a subscription or participation by, the
- 26 broker-dealer as an underwriter of the security or a
- 27 redistribution.

- 1 (iv) A nationally recognized securities manual or its
- 2 electronic equivalent designated by rule or order under this act or
- 3 a record filed with the securities and exchange commission that is
- 4 publicly available contains all of the following:
- 5 (A) A description of the business and operations of the
- 6 issuer.
- 7 (B) The names of the issuer's executive officers and the names
- 8 of the issuer's directors, if any.
- 9 (C) An audited balance sheet of the issuer as of a date within
- 10 18 months before the date of the transaction or, in the case of a
- 11 reorganization or merger, and when the parties to the
- 12 reorganization or merger each had an audited balance sheet, a pro
- 13 forma balance sheet for the combined entity.
- 14 (D) An audited income statement for each of the issuer's 2

- 27 (C) The issuer of the security, including its predecessors,

- 1 has been engaged in continuous business for at least 3 years.
- 2 (D) The issuer of the security has total assets of at least
- 3 \$2,000,000.00 based on an audited balance sheet as of a date within
- 4 18 months before the date of the transaction or, in the case of a
- 5 reorganization or merger when the parties to the reorganization or
- 6 merger each had an audited balance sheet as of a date within 18
- 7 months before the date of the transaction, a pro forma balance
- 8 sheet for the combined entity.
- 9 (c) A nonissuer transaction by or through a broker-dealer
- 10 registered or exempt from registration under this act in a security
- 11 of a foreign issuer that is a margin security defined in
- 12 regulations or rules adopted by the board of governors of the
- 13 federal reserve system.
- 14 (d) A nonissuer transaction by or through a broker-dealer
- 15 registered or exempt from registration under this act in an
- 16 outstanding security if the guarantor of the security files reports
- 17 with the securities and exchange commission under the reporting
- 18 requirements of section 13 or 15(d) of the securities exchange act
- 19 of 1934, 15 USC 78m or 78o.
- (e) A nonissuer transaction by or through a broker-dealer
- 21 registered or exempt from registration under this act in a security
- 22 that meets 1 or more of the following:
- 23 (i) Is rated at the time of the transaction by a nationally
- 24 recognized statistical rating organization in 1 of its 4 highest
- 25 rating categories.
- 26 (ii) Has a fixed maturity or a fixed interest or dividend, if
- 27 both of the following are met:

- 1 (A) A default has not occurred during the current fiscal year
- 2 or within the 3 previous fiscal years or during the existence of
- 3 the issuer and any predecessor if less than 3 fiscal years, in the
- 4 payment of principal, interest, or dividends on the security.
- 5 (B) The issuer is engaged in business, is not in the
- 6 organizational stage or in bankruptcy or receivership, and is not
- 7 and has not been within the previous 12 months a blank check, blind
- 8 pool, or shell company that has no specific business plan or
- 9 purpose or has indicated that its primary business plan is to
- 10 engage in a merger or combination of the business with, or an
- 11 acquisition of, an unidentified person.
- 12 (f) A nonissuer transaction by or through a broker-dealer
- 13 registered or exempt from registration under this act effecting an
- 14 unsolicited order or offer to purchase.
- 15 (g) A nonissuer transaction executed by a bona fide pledgee
- 16 without any purpose of evading this act.
- 17 (h) A nonissuer transaction by a federal covered investment
- 18 adviser with investments under management in excess of
- 19 \$100,000,000.00 acting in the exercise of discretionary authority
- 20 in a signed record for the account of others.
- 21 (i) A transaction in a security, whether or not the security
- 22 or transaction is otherwise exempt, in exchange for 1 or more bona
- 23 fide outstanding securities, claims, or property interests, or
- 24 partly in exchange and partly for cash, if the terms and conditions
- 25 of the issuance and exchange or the delivery and exchange and the
- 26 fairness of the terms and conditions have been approved by the
- 27 administrator at a hearing.

- 1 (j) A transaction between the issuer or other person on whose
- 2 behalf the offering is made and an underwriter, or among
- 3 underwriters.
- 4 (k) A transaction in a note, bond, debenture, or other
- 5 evidence of indebtedness secured by a mortgage or other security
- 6 agreement if all of the following are met:
- 7 (i) The note, bond, debenture, or other evidence of
- 8 indebtedness is offered and sold with the mortgage or other
- 9 security agreement as a unit.
- 10 (ii) A general solicitation or general advertisement of the
- 11 transaction is not made.
- 12 (iii) A commission or other remuneration is not paid or given,
- 13 directly or indirectly, to a person not registered under this act
- 14 as a broker-dealer or as an agent.
- 15 (l) A transaction by an executor, administrator of an estate,
- 16 sheriff, marshal, receiver, trustee in bankruptcy, guardian, or
- 17 conservator.
- (m) A sale or offer to sell to any of the following:
- 19 (i) An institutional investor.
- 20 (ii) A federal covered investment adviser.
- 21 (iii) Any other person exempted by rule or order under this act.
- (n) A sale or an offer to sell securities by or on behalf of
- 23 an issuer, if the transaction is part of a single issue in which
- 24 all of the following are met:
- 25 (i) There are not more than 50 purchasers in this state during
- 26 any 12 consecutive months, other than those designated in
- 27 subdivision (m).

- 1 (ii) There is no general solicitation or general advertising
- 2 used in connection with the offer to sell or sale of the
- 3 securities.
- 4 (iii) A commission or other remuneration is not paid or given,
- 5 directly or indirectly, to a person other than a broker-dealer
- 6 registered under this act or an agent registered under this act for
- 7 soliciting a prospective purchaser in this state.
- 8 (iv) The issuer reasonably believes that all the purchasers in
- 9 this state other than those designated in subdivision (m) are
- 10 purchasing for investment.
- 11 (o) A transaction under an offer to existing security holders
- 12 of the issuer, including persons that at the date of the
- 13 transaction are holders of convertible securities, options, or
- 14 warrants, if a commission or other remuneration, other than a
- 15 standby commission, is not paid or given, directly or indirectly,
- 16 for soliciting a security holder in this state.
- 17 (p) An offer to sell, but not a sale, of a security not exempt
- 18 from registration under the securities act of 1933 if both of the
- 19 following are met:
- 20 (i) A registration or offering statement or similar record as
- 21 required under the securities act of 1933 has been filed, but is
- 22 not effective, or the offer is made in compliance with rule 165
- 23 adopted under the securities act of 1933, 17 CFR 230.165.
- 24 (ii) A stop order of which the offeror is aware has not been
- 25 issued against the offeror by the administrator or the securities
- 26 and exchange commission, and an audit, inspection, or proceeding
- 27 that is public and may culminate in a stop order is not known by

- 1 the offeror to be pending.
- 2 (q) An offer to sell, but not a sale, of a security exempt
- 3 from registration under the securities act of 1933 if all of the
- 4 following are met:
- 5 (i) A registration statement has been filed under this act, but
- 6 is not effective.
- 7 (ii) A solicitation of interest is provided in a record to
- 8 offerees in compliance with a rule adopted by the administrator
- 9 under this act.
- 10 (iii) A stop order of which the offeror is aware has not been
- 11 issued by the administrator under this act, and an audit,
- 12 inspection, or proceeding that may culminate in a stop order is not
- 13 known by the offeror to be pending.
- 14 (r) A transaction involving the distribution of the securities
- 15 of an issuer to the security holders of another person in
- 16 connection with a merger, consolidation, exchange of securities,
- 17 sale of assets, or other reorganization to which the issuer, or its
- 18 parent or subsidiary, and the other person, or its parent or
- 19 subsidiary, are parties.
- (s) A rescission offer, sale, or purchase under section 510.
- 21 (t) An offer or sale of a security to a person not resident in
- 22 this state and not present in this state if the offer or sale does
- 23 not constitute a violation of the laws of the state or foreign
- 24 jurisdiction in which the offeree or purchaser is present and is
- 25 not part of an unlawful plan or scheme to evade this act.
- (u) An offer or sale of a security pursuant to an employee's
- 27 stock purchase, savings, option, profit-sharing, pension, or

- 1 similar employees' benefit plan, including any securities, plan
- 2 interests, and guarantees issued under a compensatory benefit plan
- 3 or compensation contract, contained in a record, established by the
- 4 issuer, its parents, its majority-owned subsidiaries, or the
- 5 majority-owned subsidiaries of the issuer's parent for the
- 6 participation of their employees including any of the following:
- 7 (i) Offers or sales of those securities to directors; general
- 8 partners; trustees, if the issuer is a business trust; officers; or
- 9 consultants and advisors.
- 10 (ii) Family members who acquire those securities from those
- 11 persons through gifts or domestic relations orders.
- 12 (iii) Former employees, directors, general partners, trustees,
- 13 officers, consultants, and advisors if those individuals were
- 14 employed by or providing services to the issuer when the securities
- 15 were offered.
- (iv) Insurance agents who are exclusive insurance agents of the
- 17 issuer, its subsidiaries or parents, or who derive more than 50% of
- 18 their annual income from those organizations.
- (v) A transaction involving any of the following:
- 20 (i) A stock dividend or equivalent equity distribution, whether
- 21 the corporation or other business organization distributing the

- 1 (ii) An act incident to a judicially approved reorganization in
- 2 which a security is issued in exchange for 1 or more outstanding
- 3 securities, claims, or property interests, or partly in exchange
- 4 and partly for cash.
- 5 (iii) The solicitation of tenders of securities by an offeror in
- 6 a tender offer in compliance with rule 162 adopted under the
- 7 securities act of 1933, 17 CFR 230.162.
- 8 (w) Subject to subsection (2), a nonissuer transaction in an
- 9 outstanding security by or through a broker-dealer registered or
- 10 exempt from registration under this act, if both of the following
- 11 are met:
- 12 (i) The issuer is a reporting issuer in a foreign jurisdiction
- 13 designated in subsection (2)(a), or by rule or order of the
- 14 administrator, and has been subject to continuous reporting
- 15 requirements in the foreign jurisdiction for not less than 180 days
- 16 before the transaction.
- 17 (ii) The security is listed on the foreign jurisdiction's
- 18 securities exchange that has been designated in subsection (2)(a),
- 19 or by rule or order under this act, or is a security of the same
- 20 issuer that is of senior or substantially equal rank to the listed
- 21 security or is a warrant or right to purchase or subscribe to any
- 22 of the foregoing.
- 23 (x) Any offer or sale of a security by an issuer under section
- **24** 202a.
- 25 (y) Any offer or sale of a security that meets the
- 26 requirements for the federal exemption for a regulation A offering
- 27 under section 3(b) of the securities act of 1933, 15 USC 77c(b),

- 1 and SEC rule 251, 17 CFR 230.251, if the offer or sale meets all of
- 2 the following requirements:
- 3 (i) The issuer has filed SEC form 1A with the securities and
- 4 exchange commission with respect to the regulation A offering, in a
- 5 manner acceptable to the securities and exchange commission, and in
- 6 that filing the issuer has satisfied all of the requirements of 17
- 7 CFR 230.251 to 230.263 inclusively, including the filing of the
- 8 regulation A offering circular required under 17 CFR 230.253.
- 9 (ii) At least 10 days before commencing an offering of
- 10 securities in reliance on this exemption or the use of any publicly
- 11 available website in connection with an offering of securities in
- 12 reliance on this exemption, the issuer files a notice with the
- 13 administrator, in writing or in electronic form as specified by the
- 14 administrator, that contains all of the following:
- 15 (A) A notice of claim of exemption from registration,
- 16 specifying that the issuer intends to conduct an offering in
- 17 reliance on a regulation A exemption, accompanied by a
- 18 nonrefundable filing fee of \$100.00 for filing the exemption
- 19 notice. The fees paid to the administrator under this sub-
- 20 subparagraph shall be used to pay the costs incurred in
- 21 administering and enforcing this act.
- 22 (B) A copy of the completed SEC form 1A and all of the
- 23 accompanying documents filed with the securities and exchange

- 25 be provided to prospective purchasers in connection with the

- 27 issuer may advertise its intent to make a regulation A offering

- 2 purchasers under 17 CFR 230.254.
- 3 (iii) The sum of all cash and other consideration to be received
- 4 for all sales of the security in reliance on this exemption does
- 5 not exceed the amount set forth in subsection (b) of 17 CFR
- 6 230.251, less the aggregate amount received for all sales of
- 7 securities by the issuer within the 12 months before the first
- 8 offer or sale made in reliance on this exemption.
- 9 (iv) The issuer does not accept more than \$10,000.00 from any
- 10 single purchaser unless the purchaser is an accredited investor as
- 11 defined by rule 501 of SEC regulation D, 17 CFR 230.501. The issuer
- 12 may rely on confirmation that the purchaser is an accredited
- 13 investor from a licensed broker-dealer or another third party in
- 14 making a determination that the purchaser is an accredited
- 15 investor. Every fifth year, the administrator shall cumulatively
- 16 adjust the \$10,000.00 limitation amount described in this
- 17 subparagraph to reflect the change in the consumer price index for
- 18 all urban consumers published by the federal bureau of labor
- 19 statistics, rounding the dollar limitation to the nearest \$100.00.
- 20 (Z) ANY SECONDARY OFFER, SALE, PURCHASE, OR TRADE OF

- 27 (D) A PERSON THAT IS REGISTERED AS A MICHIGAN INVESTMENT

- 1 MARKET UNDER ARTICLE 4A AND THAT DEALS IN SECURITIES SOLELY IN ITS
- 2 CAPACITY AS A MICHIGAN INVESTMENT MARKET.
- 3 (3) A broker-dealer, or an issuer engaged in offering,
- 4 offering to purchase, purchasing, or selling securities in this
- 5 state, shall not directly or indirectly employ or associate with an
- 6 individual to engage in an activity related to securities
- 7 transactions in this state if the registration of the individual is
- 8 suspended or revoked or the individual is barred from employment or
