## SUBSTITUTE FOR HOUSE BILL NO. 5277

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"

by amending sections 3204, 3240, and 3278 (MCL 600.3204, 600.3240, and 600.3278), section 3204 as amended by 2013 PA 103, section 3240 as amended by 2013 PA 104, and section 3278 as added by 2011 PA 301, and by adding sections 3237 and 3238; and to repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 3204. (1) Subject to subsections (4) and (6), a A party
- 2 may foreclose a mortgage by advertisement if all of the following
- 3 circumstances exist:
- 4 (a) A default in a condition of the mortgage has occurred, by
- 5 which the power to sell became operative.

- 1 (b) An action or proceeding has not been instituted, at law,
- 2 to recover the debt secured by the mortgage or any part of the
- 3 mortgage ; or, if an action or proceeding has been instituted,
- 4 EITHER the action or proceeding has been discontinued ; or an
- 5 execution on a judgment rendered in an-THE action or proceeding has
- 6 been returned unsatisfied, in whole or in part.
- 7 (c) The mortgage containing the power of sale has been
- 8 properly recorded.
- 9 (d) The party foreclosing the mortgage is either the owner of
- 10 the indebtedness or of an interest in the indebtedness secured by
- 11 the mortgage or the servicing agent of the mortgage.
- 12 (2) If a mortgage is given to secure the payment of money by
- installments, each of the installments mentioned in the mortgage
- 14 after the first shall be treated as a separate and independent
- 15 mortgage. The mortgage for each of the installments may be
- 16 foreclosed in the same manner and with the same effect as if a
- 17 separate mortgage were given for each subsequent installment. A
- 18 redemption of a sale by the mortgagor has the same effect as if the
- 19 sale for the installment had been made upon an independent prior
- 20 mortgage.
- 21 (3) If the party foreclosing a mortgage by advertisement is
- 22 not the original mortgagee, a record chain of title shall MUST
- 23 exist prior to BEFORE the date of sale under section 3216
- 24 evidencing the assignment of the mortgage to the party foreclosing
- 25 the mortgage.
- 26 (4) A party shall not commence proceedings under this chapter
- 27 to foreclose a mortgage of property claimed as a principal

- residence exempt from tax under section 7cc of the general property 1 tax act, 1893 PA 206, MCL 211.7cc, if 1 or more of the following 2 apply: 3 4 (a) Notice has not been mailed to the mortgagor as required by 5 section 3205a. (b) After a notice is mailed to the mortgagor under section 6 3205a, the time has not expired for the mortgagor to request, 7 either directly or through a housing counselor, a meeting under 8 section 3205b with the person designated under section 3205a(1)(c). 9 (c) Within 30 days after a notice is mailed to the mortgagor 10 11 under section 3205a, the mortgagor has requested a meeting under 12 section 3205b with the person designated under section 3205a(1)(c) and 90 days have not passed after the notice was mailed. - 12 INCLUDING, BUT NOT LIMITED TO, A FURNACE, WATER HEATER, AIR-
- 13 CONDITIONING UNIT, COUNTERTOP, CABINETRY, FLOORING, WALL, CEILING,
- 14 ROOFING, TOILET, OR ANY OTHER FIXTURES. AS USED IN THIS
- 15 SUBDIVISION, "FIXTURES" MEANS THAT TERM AS DEFINED IN SECTION 9102

- 17 (E) DETERIORATION BELOW, OR BEING IN IMMINENT DANGER OF
- 18 DETERIORATING BELOW, COMMUNITY STANDARDS FOR PUBLIC SAFETY AND
- 19 SANITATION THAT ARE ESTABLISHED BY STATUTE OR LOCAL ORDINANCE.
- 20 (F) A CONDITION THAT WOULD JUSTIFY RECOVERY OF THE PREMISES
- 21 UNDER SECTION 5714(1)(D).
- 22 Sec. 3240. (1) A purchaser's deed under section 3232 is void
- 23 if the mortgagor, the mortgagor's heirs or personal representative,
- 24 or any person THAT HAS A RECORDED INTEREST IN THE PROPERTY lawfully
- 25 claiming under the mortgagor or the mortgagor's heirs or personal
- 26 representative redeems the entire premises sold by paying the
- 27 amount required under subsection (2) and any amount required under

- 1 subsection (4), within the applicable time limit prescribed in
- 2 subsections (7) to (12), to the purchaser or the purchaser's
- 3 personal representative or assigns, or to the register of deeds in
- 4 whose office the deed is deposited for the benefit of the

- 13 register of deeds shall not determine the amount necessary for
- 14 redemption. The purchaser shall provide an affidavit with the deed
- 15 to be recorded under this section that states the exact amount
- 16 required to redeem the property under this subsection, including
- 17 any daily per diem amounts, and the date by which the property must
- 18 be redeemed shall be stated on the certificate of sale. The
- 19 purchaser may include in the affidavit the name of a designee
- 20 responsible on behalf of the purchaser to assist the person
- 21 redeeming the property in computing the exact amount required to
- 22 redeem the property. The designee may charge a fee as stated in the
- 23 affidavit and may be authorized by the purchaser to receive
- 24 redemption money. The purchaser shall accept the amount computed by
- 25 the designee.
- 26 (3) If a distinct lot or parcel separately sold is redeemed,
- 27 leaving a portion of the premises unredeemed, the deed is void only

- 2 (4) If, after a sale under section 3220, 3216, the purchaser,
- 3 the purchaser's heirs or personal representative, or any person
- 4 lawfully claiming under the purchaser or the purchaser's heirs or
- 5 personal representative pays taxes assessed against the property,
- 6 amounts necessary to redeem senior liens from foreclosure,
- 7 condominium assessments, homeowner association assessments,
- 8 community association assessments, or premiums on an insurance
- 9 policy covering any buildings located on the property that under
- 10 the terms of the mortgage it would have been the duty of the
- 11 mortgagor to pay if the mortgage had not been foreclosed and that
- 12 are necessary to keep the policy in force until the expiration of
- 13 the period of redemption, redemption shall be made only upon
- 14 payment of the sum specified in subsection (2) plus the amounts

- 5 (5) If the redemption payment in subsection (4) includes an
- 6 amount used to redeem a senior lien from a nonjudicial foreclosure,
- 7 the mortgagor has the same defenses against the purchaser with
- 8 respect to the amount used to redeem the senior lien as the
- 9 mortgagor would have had against the senior lien.
- 10 (6) The register of deeds shall indorse on documents filed
- 11 under subsection (4) the time they are received. The register of
- 12 deeds shall record the affidavit of the purchaser only and shall
- 13 preserve in his or her files the recorded affidavit, receipts,

- 4 provide the notice required by section 3241a(c) expires, whichever
- 5 is later.
- 6 (11) Subject to subsection (13), SECTION 3238, for a mortgage
- 7 of property that is used for agricultural purposes, the redemption
- 8 period is 1 year from the date of the sale.
- 9 (12) If subsections (7) to (11) do not apply, and subject to
- 10 subsection (13), SECTION 3238, the redemption period is 1 year from
- 11 the date of the sale.
- 12 (13) After the sale under section 3220 and periodically
- 13 throughout the redemption period, the purchaser at the sale may
- 14 inspect the exterior and interior of the property and all ancillary
- 15 structures. If inspection is unreasonably refused or if damage to
- 16 the property is imminent or has occurred, the purchaser may
- 17 immediately commence summary proceedings for possession of the
- 18 property under chapter 57 or file an action for any other relief
- 19 necessary to protect the property from damage. A court shall not
- 20 enter a judgment for possession in an action under chapter 57 if,
- 21 before the hearing for possession, the mortgagor repairs any damage
- 22 to the property that was the basis for the action. If a judgment

- 17 this section shall be the amount necessary to satisfy the
- 18 requirements for redemption under this section.
- 19 (14) <del>(15)</del> The register of deeds of a county with a population
- 20 of more than 750,000 and less than 1,500,000, at the request of a
- 21 person entitled to redeem the property under this section, shall

- 5 that the property is used for agricultural purposes if, before the
- 6 foreclosure sale under this chapter, the mortgagor provides the
- 7 party foreclosing the mortgage and the foreclosing party's attorney
- 8 proof that the mortgagor filed a schedule F to the mortgagor's
- 9 federal income tax form 1040 for the year preceding the year in
- 10 which the proceedings to foreclose the mortgage were commenced and
- 11 records an affidavit with the register of deeds for the county in
- 12 which the property is located stating that the proof has been
- 13 delivered. If the mortgagor fails to provide proof and record an
- 14 affidavit as required by this subsection before the foreclosure
- 15 sale, there is a presumption that the property is not used for
- 16 agricultural purposes. The party foreclosing the mortgage or the
- 17 mortgagor may file a civil action to produce evidence to rebut a
- 18 presumption created by this subsection. An action under this
- 19 section shall be filed before the expiration of the redemption
- 20 period that would apply if the property is determined not to be
- 21 used for agricultural purposes.

- 17 (i) SUBJECT TO SECTION 3238, FAILS TO CONSENT TO AN INITIAL
- 18 INSPECTION, COMPLY WITH A REQUEST FOR INFORMATION ON THE CONDITION
- 19 OF THE PROPERTY, OR CONSENT TO AN INSPECTION OF THE PROPERTY AFTER
- 20 THE INITIAL INSPECTION, IF REQUESTED.
- 21 (ii) FAILS TO PROVIDE TIMELY NOTICE TO THE PURCHASER UNDER THIS
- 22 SUBSECTION.
- 23 (iii) FAILS TO SURRENDER CONTROL OF THE PROPERTY IN A MANNER
- 24 THAT REASONABLY PROVIDES THE PURCHASER WITH THE OPPORTUNITY TO
- 25 SECURE IT.
- 26 (B) THERE IS A REBUTTABLE PRESUMPTION THAT THE MORTGAGOR IS
- 27 NOT LIABLE FOR DAMAGE TO THE PROPERTY THAT OCCURS AFTER THE
