SUBSTITUTE FOR

HOUSE BILL NO. 5492

A bill to amend 1937 PA 94, entitled "Use tax act,"

by amending section 21 (MCL 205.111), as amended by 2010 PA 37.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 21. (1) Except as provided in subsections (2), and (3),
- 2 (4), AND (5), all money received and collected under this act shall
- 3 be deposited by the department of treasury in the state treasury to
- 4 the credit of the general fund, to be disbursed only by
- 5 appropriations by the legislature.
- 6 (2) The collections from the use tax imposed at the additional
- 7 rate of 2% approved by the electors March 15, 1994 shall be
- 8 deposited in the state school aid fund established in section 11 of
- 9 article IX of the state constitution of 1963.

- 1 (3) For the fiscal year ending September 30, 2010 only,
- 2 \$9,500,000.00 shall be deposited by the department of treasury into
- 3 the Michigan promotion fund. As used in this subsection, "Michigan
- 4 promotion fund" means the fund created in section 39 of the
- 5 Michigan strategic fund act, 1984 PA 270, MCL 125.2039.
- 6 (3) FROM THE MONEY RECEIVED AND COLLECTED UNDER THIS ACT FOR
- 7 THE STATE SHARE, AN AMOUNT EQUAL TO ALL REVENUE LOST UNDER THE
- 8 STATE EDUCATION TAX ACT, 1993 PA 331, MCL 211.901 TO 211.906, AND
- 9 ALL REVENUE LOST FROM BASIC SCHOOL OPERATING MILLS AS A RESULT OF
- 10 THE EXEMPTION OF PERSONAL PROPERTY UNDER SECTIONS 9M, 9N, AND 90 OF
- 11 THE GENERAL PROPERTY TAX ACT, 1893 PA 206, MCL 211.9M, 211.9N, AND
- 12 211.90, AS DETERMINED BY THE DEPARTMENT, SHALL BE DEPOSITED INTO
- 13 THE STATE SCHOOL AID FUND ESTABLISHED BY SECTION 11 OF ARTICLE IX
- 14 OF THE STATE CONSTITUTION OF 1963. FUNDS DEPOSITED INTO THE STATE
- 15 SCHOOL AID FUND UNDER THIS SUBSECTION SHALL NOT INCLUDE THE PORTION
- 16 OF THE STATE SHARE OF THE USE TAX IMPOSED AT THE ADDITIONAL RATE OF
- 17 2% APPROVED BY THE ELECTORS OF THIS STATE ON MARCH 15, 1994 AND
- 18 DEDICATED FOR AID TO SCHOOLS UNDER SUBSECTION (2).
- 19 (4) MONEY RECEIVED AND COLLECTED UNDER THIS ACT FOR THE LOCAL
- 20 COMMUNITY STABILIZATION SHARE IS NOT STATE FUNDS, SHALL NOT BE
- 21 CREDITED TO THE STATE TREASURY, AND SHALL BE TRANSMITTED TO THE
- 22 AUTHORITY FOR DEPOSIT IN THE TREASURY OF THE AUTHORITY, TO BE
- 23 DISBURSED BY THE AUTHORITY ONLY AS AUTHORIZED UNDER THE LOCAL
- 24 COMMUNITY STABILIZATION AUTHORITY ACT. THE LOCAL COMMUNITY
- 25 STABILIZATION SHARE IS A LOCAL TAX, NOT A STATE TAX, AND MONEY
- 26 RECEIVED AND COLLECTED FOR THE LOCAL COMMUNITY STABILIZATION SHARE
- 27 IS MONEY OF THE AUTHORITY AND NOT MONEY OF THIS STATE.

- 1 (5) FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2015 AND EACH
- 2 FISCAL YEAR THEREAFTER, FROM THE MONEY RECEIVED AND COLLECTED UNDER
- 3 THIS ACT REMAINING AFTER THE DISTRIBUTIONS UNDER SUBSECTIONS (2)
- 4 AND (3), AN AMOUNT EQUAL TO 50% OF THE AMOUNT DEPOSITED IN THE
- 5 SCHOOL AID FUND ESTABLISHED IN SECTION 11 OF ARTICLE IX OF THE
- 6 STATE CONSTITUTION OF 1963 UNDER SUBSECTION (2) SHALL BE
- 7 DISTRIBUTED TO THE STATE TRUNK LINE FUND, COUNTY ROAD COMMISSIONS,
- 8 AND THE CITIES AND VILLAGES OF THIS STATE, IN THE SAME PERCENTAGES
- 9 DESCRIBED IN SECTION 10(1)(J) OF 1951 PA 51, MCL 247.660, AND SHALL
- 10 BE USED FOR THE PURPOSES PROVIDED IN 1951 PA 51, MCL 247.651 TO
- 11 247.675.
- 12 Enacting section 1. It is the intent of the Legislature that
- 13 the distribution of money received and collected under the use tax
- 14 act, 1937 PA 94, MCL 205.91 to 205.111, provided for in section
- 15 21(5) of the use tax act, 1937 PA 94, MCL 205.111, as added by this
- 16 amendatory act, shall apply only to the state share of the money
- 17 received and collected under the use tax act, 1937 PA 94, MCL
- 18 205.91 to 205.111, as described in section 3 of the use tax act,
- 19 1937 PA 94, MCL 205.93, and shall take place after distributions of
- 20 money received and collected under the use tax act, 1937 PA 94, MCL
- 21 205.91 to 205.111, to the state school aid fund as provided in
- 22 section 21(2) and (3) of the use tax act, 1937 PA 94, MCL 205.111.
