- 17 (d) "Proceeds of a crime" means any property obtained through
- 18 the commission of a crime, including any appreciation in the value
- 19 of the property.
- (e) "Security interest" means any interest in real or personal
- 21 property that secures payment or performance of an obligation.
- 22 (f) "Substituted proceeds of a crime" means any property
- 23 obtained or any gain realized by the sale or exchange of proceeds
- 24 of a crime.
- 25 Enacting section 1. This amendatory act takes effect 90 days
- 26 after the date it is enacted into law.
- 27 Enacting section 2. This amendatory act does not take effect
