A bill to amend 1984 PA 270, entitled "Michigan strategic fund act,"

(MCL 125.2001 to 125.2094) by adding section 15.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 15. (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS ACT,
- 2 ALL MONEY AND ASSETS OF THE FUND ARE DECLARED PUBLIC MONEY AND
- 3 ASSETS AND SHALL BE DISBURSED, SUBJECT TO SUBSECTION (3), ONLY AS
- 4 PROVIDED BY LAW IN AN APPROPRIATION.
- 5 (2) BEGINNING FISCAL YEAR 2016-2017 AND EACH FISCAL YEAR
- 6 THEREAFTER, EACH YEAR AN AMOUNT OF REVENUE EQUAL TO THE AMOUNT THE
- 7 FUND RECEIVES EACH YEAR FROM THE INDIAN GAMING COMPACT RECEIPTS
- 8 SHALL BE DEPOSITED INTO THE MICHIGAN TRANSPORTATION FUND
- 9 ESTABLISHED IN SECTION 10 OF 1951 PA 51, MCL 247.660, AND
- 10 DISTRIBUTED AS PROVIDED IN SECTION 10(1)(K) OF 1951 PA 51, MCL
