SENATE SUBSTITUTE FOR HOUSE BILL NO. 4119

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"

by amending section 4012 (MCL 600.4012), as amended by 2012 PA 304.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 4012. (1) Except for garnishment of a tax refund under
- 2 section 4061a or garnishment of wages, salary, commissions, or
- 3 other earnings, and subject to subsection (2), a writ of A
- 4 garnishment of periodic payments remains in effect for the period
- 5 prescribed by the Michigan court rules. A writ of garnishment of
- 6 wages, salary, commissions, or other earnings remains in effect for
- 7 182 days. Until the balance of the judgment is satisfied.
- 8 (2) A garnishee is not liable for a writ of garnishment of
- 9 periodic payments under subsection (1) to the extent that the
- 10 garnishee is required to satisfy another writ of garnishment

- 1 against the same defendant having a higher priority or having the
- 2 same priority but received at an earlier date. For purposes of this
- 3 subsection, writs of garnishment GARNISHMENTS have priority in the
- 4 following order IN WHICH THEY ARE RECEIVED. BOTH OF THE FOLLOWING
- 5 HAVE PRIORITY OVER A GARNISHMENT, REGARDLESS OF THE ORDER IN WHICH
- 6 THEY ARE RECEIVED:
- 7 (a) A garnishment resulting from an obligation of court
- 8 ordered support AN ORDER OF INCOME WITHHOLDING as THAT TERM IS
- 9 defined in section 2 of the support and parenting time enforcement
- 10 act, 1982 PA 295, MCL 552.602.
- 11 (b) A levy of the THIS state or a governmental unit of the
- 12 THIS state to satisfy a tax liability.
- 13 (c) Any other garnishments, in the order in which they are
- 14 served.
- 15 (3) IF A GARNISHMENT OF PERIODIC PAYMENTS IS SUSPENDED
- 16 PURSUANT TO AN ORDER UNDER SECTIONS 6201 TO 6251 AND THE ORDER IS
- 17 SUBSEQUENTLY SET ASIDE, THE GARNISHMENT RETAINS ITS PRIORITY.
- 18 (4) A GARNISHMENT OF PERIODIC PAYMENTS OR A NOTICE OF FAILURE
- 19 IS NOT VALID OR ENFORCEABLE UNLESS THE GARNISHMENT IS SERVED ON THE
- 20 GARNISHEE IN ACCORDANCE WITH THE MICHIGAN COURT RULES.
- 21 (5) WHILE A GARNISHMENT OF PERIODIC PAYMENTS IS IN EFFECT, THE
- 22 PLAINTIFF SHALL DO BOTH OF THE FOLLOWING:
- 23 (A) AT LEAST ONCE EVERY 6 MONTHS AFTER THE PLAINTIFF RECEIVES
- 24 THE FIRST PAYMENT UNDER THE GARNISHMENT, PROVIDE TO THE GARNISHEE
- 25 AND DEFENDANT A STATEMENT SETTING FORTH THE BALANCE REMAINING ON
- 26 THE JUDGMENT, INCLUDING INTEREST AND COSTS. A FAILURE TO SEND A
- 27 TIMELY STATEMENT UNDER THIS SUBDIVISION DOES NOT AFFECT THE

- 1 GARNISHMENT OR ANY OBLIGATION OF THE GARNISHEE UNDER THE
- 2 GARNISHMENT.
- 3 (B) WITHIN 21 DAYS AFTER THE BALANCE OF THE JUDGMENT HAS BEEN
- 4 PAID IN FULL, INCLUDING ALL INTEREST AND COSTS, PROVIDE TO THE
- 5 GARNISHEE AND DEFENDANT A RELEASE OF GARNISHMENT.
- 6 (6) A PLAINTIFF SHALL NOT REQUEST THAT A DEFAULT BE ENTERED
- 7 AGAINST A GARNISHEE UNDER A GARNISHMENT OF PERIODIC PAYMENTS UNLESS
- 8 BOTH OF THE FOLLOWING APPLY:
- 9 (A) IF THE GARNISHEE FAILS TO FILE A DISCLOSURE WITHIN 14 DAYS
- 10 AFTER SERVICE OF THE GARNISHMENT OR FAILS TO PERFORM ANY OTHER
- 11 REQUIRED ACT, THE PLAINTIFF HAS SERVED ON THE GARNISHEE A NOTICE OF
- 12 FAILURE SETTING FORTH THE REQUIRED ACT OR ACTS THAT THE GARNISHEE
- 13 HAS FAILED TO PERFORM.
- 14 (B) THE GARNISHEE HAS FAILED, WITHIN 28 DAYS AFTER THE DATE OF
- 15 SERVICE OF THE NOTICE OF FAILURE UNDER SUBDIVISION (A), TO CURE THE
- 16 IDENTIFIED FAILURE BY MAILING TO THE PLAINTIFF AND DEFENDANT A
- 17 DISCLOSURE CERTIFYING THAT THE GARNISHEE WILL IMMEDIATELY BEGIN
- 18 WITHHOLDING ANY AVAILABLE FUNDS PURSUANT TO THE GARNISHMENT AS
- 19 PROVIDED BY STATUTE OR COURT RULE, OR HAS COMMENCED PERFORMING ANY
- 20 OTHER REQUIRED ACT.
- 21 (7) THE PLAINTIFF SHALL ATTACH TO A REQUEST FOR ENTRY OF A
- 22 DEFAULT AS ALLOWED UNDER SUBSECTION (6) PROOF OF SERVING THE NOTICE
- 23 OF FAILURE. THE PLAINTIFF SHALL SEND A COPY OF THE REQUEST FOR
- 24 ENTRY OF A DEFAULT BY CERTIFIED MAIL TO THE GARNISHEE AT THE
- 25 GARNISHEE'S PRINCIPAL PLACE OF BUSINESS OR REGISTERED AGENT.
- 26 (8) AFTER ENTRY OF A DEFAULT UNDER SUBSECTION (6) AND BEFORE
- 27 ENTRY OF A DEFAULT JUDGMENT, THE GARNISHEE MAY CURE THE IDENTIFIED

- 1 FAILURE BY MAILING TO THE COURT, PLAINTIFF, AND DEFENDANT A
- 2 DISCLOSURE CERTIFYING THAT THE GARNISHEE WILL IMMEDIATELY BEGIN
- 3 WITHHOLDING ANY AVAILABLE FUNDS PURSUANT TO THE GARNISHMENT AS
- 4 PROVIDED BY STATUTE OR COURT RULE OR THAT IT HAS COMMENCED
- 5 PERFORMING ANY OTHER REQUIRED ACT.
- 6 (9) AFTER A DEFAULT HAS BEEN ENTERED UNDER SUBSECTION (6), THE
- 7 PLAINTIFF MAY FILE WITH THE COURT A REQUEST FOR DEFAULT JUDGMENT
- 8 FOR AN AMOUNT THAT DOES NOT EXCEED THE FULL AMOUNT OF THE UNPAID
- 9 JUDGMENT, INTEREST, AND COSTS, AS STATED IN THE REQUEST AND
- 10 GARNISHMENT. THE PLAINTIFF SHALL SEND A COPY OF THE REQUEST FOR
- 11 DEFAULT JUDGMENT BY CERTIFIED MAIL TO THE GARNISHEE AT THE
- 12 GARNISHEE'S PRINCIPAL PLACE OF BUSINESS OR RESIDENT AGENT.
- 13 (10) ON MOTION OF THE GARNISHEE FILED WITHIN 21 DAYS AFTER
- 14 ENTRY OF A DEFAULT JUDGMENT UNDER SUBSECTION (9), THE COURT SHALL
- 15 DO 1 OR MORE OF THE FOLLOWING, AS APPLICABLE:
- 16 (A) IF THE GARNISHEE CERTIFIES BY AFFIDAVIT THAT ITS FAILURE
- 17 TO COMPLY WITH THE GARNISHMENT WAS INADVERTENT OR CAUSED BY AN
- 18 ADMINISTRATIVE ERROR, MISTAKE, OR OTHER OVERSIGHT AND IT WILL
- 19 IMMEDIATELY BEGIN WITHHOLDING ANY AVAILABLE FUNDS OR IMMEDIATELY
- 20 BEGIN PERFORMING ANY OTHER REQUIRED ACT PURSUANT TO THE GARNISHMENT
- 21 AS PROVIDED BY STATUTE OR COURT RULE, REDUCE THE DEFAULT JUDGMENT
- 22 TO NOT MORE THAN THE AMOUNT THAT WOULD HAVE BEEN WITHHELD IF THE
- 23 GARNISHMENT HAD BEEN IN EFFECT FOR 56 DAYS.
- 24 (B) IF ANY OF THE FOLLOWING CIRCUMSTANCES EXIST, SET ASIDE THE
- 25 DEFAULT JUDGMENT:
- 26 (i) THE GARNISHEE WAS NOT LIABLE TO THE DEFENDANT FOR ANY
- 27 PERIODIC PAYMENTS AFTER SERVICE OF THE GARNISHMENT.

- 1 (ii) THE GARNISHMENT, NOTICE OF FAILURE, REQUEST FOR ENTRY OF
- 2 A DEFAULT, OR REQUEST FOR DEFAULT JUDGMENT WAS NOT PROPERLY SERVED
- 3 OR SENT AS REQUIRED BY THIS SECTION.
- 4 (iii) THE NOTICE OF FAILURE WAS MATERIALLY INACCURATE OR
- 5 INCOMPLETE.
- 6 (11) A GARNISHEE MAY RECOVER AN AMOUNT FOR WHICH THE GARNISHEE
- 7 IS LIABLE BECAUSE OF THE ENTRY OF A DEFAULT JUDGMENT UNDER
- 8 SUBSECTION (9) OR (10) FROM FUTURE PERIODIC PAYMENTS TO THE
- 9 DEFENDANT AS PROVIDED IN SECTION 7 OF 1978 PA 390, MCL 408.477.
- 10 (12) (3) Except as otherwise provided by statute, a plaintiff
- 11 shall pay a fee of \$6.00-\$35.00 TO THE GARNISHEE at the time a writ
- 12 to the garnishee of garnishment of periodic payments is served upon
- 13 ON the garnishee.
- 14 (13) THIS SECTION DOES NOT APPLY TO ANY OF THE FOLLOWING:
- 15 (A) AN ORDER OF INCOME WITHHOLDING AS THAT TERM IS DEFINED IN
- 16 SECTION 2 OF THE SUPPORT AND PARENTING TIME ENFORCEMENT ACT, 1982
- 17 PA 295, MCL 552.602.
- 18 (B) A LEVY FOR TAX LIABILITY.
- 19 (C) A LEVY UNDER SECTION 15 (M) OF THE MICHIGAN EMPLOYMENT
- 20 SECURITY ACT, 1936 (EX SESS) PA 1, MCL 421.15.
- 21 (14) (4) As used in this section and section 8410a, "periodic
- 22 payments" means wages, salary, commissions, and other earnings,
- 23 land contract payments, rent, and other periodic debt or contract
- 24 payments that are or become payable during the effective period of
- 25 the writ of garnishment. Periodic payments do not mean any of the
- 26 following:
- 27 (a) Payments by a financial institution of interest on a

- 1 deposit account.
- 2 (b) Charges made by a financial institution automatically
- 3 against an account which applies THAT ARE APPLIED to a debt under
- 4 an automatic payment authorization executed by the account owner.
- 5 (c) Payments made by a financial institution to honor a check
- 6 or draft or to comply with an account holder's order of withdrawal
- 7 of funds from an account.
- 8 (d) Interest earned on a certificate of deposit that is paid
- 9 into a deposit account.
- 10 Enacting section 1. This amendatory act applies to a writ of
- 11 garnishment issued after September 30, 2015.
- 12 Enacting section 2. This amendatory act does not take effect
- 13 unless House Bill No. 4120 of the 98th Legislature is enacted into
- **14** law.
