A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1219.

- 10 THIS SUBSECTION. AFTER RECEIPT BY CEPI, CEPI SHALL COMPILE AND

- 3 (4) IF THE STATE TREASURER DECLARES UNDER SUBSECTION (3) THAT
- 4 THE POTENTIAL FOR FISCAL STRESS EXISTS FOR A SCHOOL DISTRICT,
- 5 INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY, THEN NOT
- 6 LESS THAN 14 DAYS AFTER THE DECLARATION THE STATE TREASURER SHALL
