SUBSTITUTE FOR SENATE BILL NO. 31

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 81f.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 81F. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A
- 2 PERSON WHO ASSAULTS, BATTERS, OR ASSAULTS AND BATTERS AN INDIVIDUAL
- 3 WHO PERFORMS HIS OR HER DUTIES AS A SPORTS OFFICIAL IMMEDIATELY
- 4 BEFORE, DURING, OR AFTER A SPORTING EVENT, OR AT ANY OTHER TIME IF
- 5 THE ASSAULT, BATTERY, OR ASSAULT AND BATTERY DIRECTLY ARISES FROM
- 6 THE SPORTS OFFICIAL'S EXECUTION OF HIS OR HER DUTY AS A SPORTS
- 7 OFFICIAL, IS GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR
- 8 NOT MORE THAN 1 YEAR OR A FINE OF NOT MORE THAN \$1,000.00, OR BOTH.
- 9 (2) A PERSON WHO ASSAULTS, BATTERS, OR ASSAULTS AND BATTERS AN
- 10 INDIVIDUAL WHO PERFORMS HIS OR HER DUTIES AS A SPORTS OFFICIAL

- 1 IMMEDIATELY BEFORE, DURING, OR AFTER A SPORTING EVENT, OR AT ANY
- 2 OTHER TIME IF THE ASSAULT, BATTERY, OR ASSAULT AND BATTERY ARISES
- 3 FROM THE SPORTS OFFICIAL'S EXECUTION OF HIS OR HER DUTY AS A SPORTS
- 4 OFFICIAL, CAUSING THE INDIVIDUAL BODILY INJURY REQUIRING MEDICAL
- 5 ATTENTION OR MEDICAL CARE IS GUILTY OF A FELONY PUNISHABLE BY
- 6 IMPRISONMENT FOR NOT MORE THAN 2 YEARS OR A FINE OF NOT MORE THAN
- 7 \$2,000.00, OR BOTH.
- 8 (3) A PERSON WHO ASSAULTS, BATTERS, OR ASSAULTS AND BATTERS AN
- 9 INDIVIDUAL WHO PERFORMS HIS OR HER DUTIES AS A SPORTS OFFICIAL
- 10 IMMEDIATELY BEFORE, DURING, OR AFTER A SPORTING EVENT, OR AT ANY
- 11 OTHER TIME IF THE ASSAULT, BATTERY, OR ASSAULT AND BATTERY ARISES
- 12 FROM THE SPORTS OFFICIAL'S EXECUTION OF HIS OR HER DUTY AS A SPORTS
- 13 OFFICIAL, CAUSING THE INDIVIDUAL SERIOUS IMPAIRMENT OF A BODY
- 14 FUNCTION IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT
- 15 MORE THAN 5 YEARS OR A FINE OF NOT LESS THAN \$1,000.00 OR MORE THAN
- 16 \$5,000.00, OR BOTH.
- 17 (4) THIS SECTION DOES NOT PROHIBIT A PERSON FROM BEING CHARGED
- 18 WITH, CONVICTED OF, OR PUNISHED FOR ANY OTHER VIOLATION OF LAW
- 19 ARISING OUT OF THE SAME TRANSACTION AS THE VIOLATION OF THIS
- 20 SECTION.
- 21 (5) AS USED IN THIS SECTION:
- 22 (A) "SERIOUS IMPAIRMENT OF A BODY FUNCTION" MEANS THAT TERM AS
- 23 DEFINED IN SECTION 58C OF THE MICHIGAN VEHICLE CODE, 1949 PA 300,
- 24 MCL 257.58C.
- 25 (B) "SPORTING EVENT" MEANS AN ORGANIZED COMPETITIVE ATHLETIC
- 26 ACTIVITY BETWEEN 2 OR MORE INDIVIDUALS.
- 27 (C) "SPORTS OFFICIAL" MEANS AN INDIVIDUAL WHO OFFICIALLY

- 1 ADMINISTERS OR OFFICIALLY ASSISTS IN ADMINISTERING THE RULES AT ANY
- SPORTING EVENT, INCLUDING, BUT NOT LIMITED TO, A REFEREE. 2
- 3 Enacting section 1. This amendatory act takes effect 90 days
- 4 after the date it is enacted into law.
