THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 TITLE
- 2 An act to exempt certain dogs SERVICE ANIMALS from license
- 3 fees.
- 4 Sec. 1. (1) Notwithstanding any law or ordinance to the
- 5 contrary, a dog SERVICE ANIMAL is not subject to any fee for
- 6 licensing if either of the following applies:
- 7 (a) The dog SERVICE ANIMAL is used as a guide or leader dog
- 8 for a blind person, a hearing dog for a deaf or audibly impaired
- 9 person, or a service dog for BY a physically limited person WITH A
- 10 DISABILITY.

- 1 (b) The dog SERVICE ANIMAL is owned by a partnership,
- 2 corporation, or other legal entity that trains dogs SERVICE ANIMALS
- 3 for use as guide or leader dogs for blind persons, hearing dogs for
- 4 deaf or audibly impaired persons, or service dogs for physically
- 5 limited persons.BY A PERSON WITH A DISABILITY.
- 6 (2) As used in this section:
- 7 (a) "Audibly impaired" means audibly impaired as defined in
- 8 section 1 of 1981 PA 82, MCL 752.61.
- 9 (b) "Blind person" means a blind person as defined in section
- 10 1 of 1978 PA 260, MCL 393.351.
- 11 (c) "Deaf person" means a deaf person as defined in section 1
- 12 of 1981 PA 82, MCL 752.61.
- 13 (d) "Physically limited" means physically limited as defined
- 14 in section 1 of 1966 PA 1, MCL 125.1351.
- 15 (A) "PERSON WITH A DISABILITY" MEANS A PERSON WHO HAS A
- 16 DISABILITY AS DEFINED IN SECTION 12102 OF THE AMERICANS WITH
- 17 DISABILITIES ACT OF 1990, 42 USC 12102, AND 28 CFR 36.104.
- 18 (B) AS USED IN SUBDIVISION (A), "PERSON WITH A DISABILITY"
- 19 INCLUDES A VETERAN WHO HAS BEEN DIAGNOSED WITH 1 OR MORE OF THE
- 20 FOLLOWING:
- 21 (i) POST-TRAUMATIC STRESS DISORDER.
- 22 (ii) TRAUMATIC BRAIN INJURY.
- 23 (iii) OTHER SERVICE-RELATED DISABILITIES.
- 24 (C) "SERVICE ANIMAL" MEANS ALL OF THE FOLLOWING:
- 25 (i) THAT TERM AS DEFINED IN 28 CFR 36.104.
- 26 (ii) A MINIATURE HORSE THAT HAS BEEN INDIVIDUALLY TRAINED TO DO
- 27 WORK OR PERFORM TASKS AS DESCRIBED IN 28 CFR 36.104 FOR THE BENEFIT

- 1 OF A PERSON WITH A DISABILITY.
- 2 (D) "VETERAN" MEANS ANY OF THE FOLLOWING:
- 3 (i) A PERSON WHO PERFORMED MILITARY SERVICE IN THE ARMED FORCES
- 4 FOR A PERIOD OF MORE THAN 90 DAYS AND SEPARATED FROM THE ARMED
- 5 FORCES IN A MANNER OTHER THAN A DISHONORABLE DISCHARGE.
- 6 (ii) A PERSON DISCHARGED OR RELEASED FROM MILITARY SERVICE
- 7 BECAUSE OF A SERVICE-RELATED DISABILITY.
- 8 (iii) A MEMBER OF A RESERVE BRANCH OF THE ARMED FORCES AT THE
- 9 TIME HE OR SHE WAS ORDERED TO MILITARY SERVICE DURING A PERIOD OF
- 10 WAR, OR IN A CAMPAIGN OR EXPEDITION FOR WHICH A CAMPAIGN BADGE IS
- 11 AUTHORIZED, AND WAS RELEASED FROM MILITARY SERVICE IN A MANNER
- 12 OTHER THAN A DISHONORABLE DISCHARGE.
- 13 Enacting section 1. This amendatory act takes effect 90 days
- 14 after the date it is enacted into law.
