- 11 Sec. 208. The departments and agencies receiving
- 12 appropriations in part 1 shall use the Internet to fulfill the
- 13 reporting requirements of this part. This requirement may include
- 14 transmission of reports via electronic mail to the recipients
- 15 identified for each reporting requirement, or it may include
- 16 placement of reports on an Internet or Intranet site.
- Sec. 209. Funds appropriated in this part and part 1 shall not
- 18 be used for the purchase of foreign goods or services, or both, if
- 19 competitively priced and of comparable quality American goods or
- 20 services, or both, are available. Preference shall be given to
- 21 goods or services, or both, manufactured or provided by Michigan

- 12 (b) The department's financial status, featuring a report of
- 13 budgeted versus actual expenditures by part 1 line item including a
- 14 year-end projection of budget requirements. If projected department
- 15 budget requirements exceed the allocated budget, the report shall
- 16 include a plan to reduce overall expenses while still satisfying
- 17 specified service level requirements.
- 18 (c) A report on the status of performance metrics cited in
- 19 this part and information required to be reported in this part.
- 20 (d) The number of active employees at the close of the fiscal
- 21 quarter by job classification and program.
- (e) A summary of fund shifts, that have been approved by the
- 23 state budget office, that have occurred between items listed in the
- 24 schedule of programs mentioned in part 1.
- 25 (f) Evidence of efficiencies and management of funds within
- 26 established appropriations.
- 27 Sec. 222. The appropriations in part 1 are for the core

- 1 services, support services, and work projects of the department,
- 2 including, but not limited to, the following core services:
- 3 (a) Armories and joint force readiness.
- 4 (b) National Guard training facilities and air bases.
- 5 (c) Michigan youth challeNGe academy.
- 6 (d) Military family relief fund.
- 7 (e) Starbase grant.
- 8 (f) National Guard tuition assistance program.
- 9 (g) Michigan veterans affairs agency administration.
- 10 (h) Veterans service grants.
- 11 (i) Veterans' trust fund administration.
- 12 (j) Veterans' trust fund grants.
- (k) Grand Rapids home for veterans.
- 14 (l) D.J. Jacobetti home for veterans.
- 15 (m) Board of managers (Grand Rapids and D.J. Jacobetti homes
- 16 for veterans).
- 17 Sec. 225. Funds appropriated in this part and part 1 shall not
- 18 be used by a principal executive department, state agency, or
- 19 authority to hire a person to provide legal services that are the
- 20 responsibility of the attorney general. This prohibition does not
- 21 apply to legal services for bonding activities and for those
- 22 activities that the attorney general authorizes.
- 23 Sec. 228. Not later than November 30, the state budget office
- 24 shall prepare and transmit a report that provides for estimates of
- 25 the total general fund/general purpose appropriations lapses at the
- 26 close of the prior fiscal year. This report shall summarize the
- 27 projected year-end general fund/general purpose appropriations

- 1 lapses by major departmental program or program areas. The report
- 2 shall be transmitted to the office of the state budget, the
- 3 chairpersons of the senate and house standing committees on
- 4 appropriations, the subcommittees, and the senate and house fiscal
- 5 agencies.
- 6 Sec. 229. Within 14 days after the release of the executive
- 7 budget recommendation, the department shall cooperate with the
- 8 state budget office to provide the senate and house appropriations
- 9 chairs, the subcommittees, and the senate and house fiscal agencies
- 10 with an annual report on estimated state restricted fund balances,
- 11 state restricted fund projected revenues, and state restricted fund
- 12 expenditures for the fiscal years ending September 30, 2016 and
- 13 September 30, 2017.
- 14 Sec. 230. The department shall maintain, on a publicly
- 15 accessible website, a department scorecard that identifies, tracks,
- 16 and regularly updates key metrics that are used to monitor and
- improve the agency's performance.
- 18 Sec. 231. Total authorized appropriations from all sources
- 19 under part 1 for legacy costs for the fiscal year ending September
- 20 30, 2017 are \$18,602,500.00. From this amount, total agency
- 21 appropriations for pension-related legacy costs are estimated at
- 22 \$10,314,600.00, and total agency appropriations for retiree health
- care legacy costs are estimated at \$8,287,900.00.
- Sec. 232. The appropriations in part 1 for capital outlay
- 25 shall be carried forward at the end of the fiscal year consistent
- 26 with section 248 of the management and budget act, 1984 PA 431, MCL

- 1 Sec. 233. Sixty days prior to the public announcement of the
- 2 intention to sell any department real property, the department
- 3 shall submit notification of that intent to the subcommittees and
- 4 the senate and house fiscal agencies.
- 5 Sec. 234. The one-time appropriations in part 1 for special
- 6 maintenance shall be carried forward at the end of the fiscal year
- 7 consistent with section 248 of the management and budget act, 1984
- 8 PA 431, MCL 18.1248.
- 9 Sec. 240. In addition to the metrics required under section
- 10 447 of the management and budget act, 1984 PA 431, MCL 18.1447, for
- 11 each new program or program enhancement for which funds in excess
- of \$500,000.00 are appropriated in part 1, the department shall
- 13 provide not later than November 1, 2015 a list of program-specific
- 14 metrics intended to measure its performance based on a return on
- 15 taxpayer investment. The department shall deliver the program-
- 16 specific metrics to members of the senate and house subcommittees
- 17 that have subject matter jurisdiction for this budget, fiscal
- 18 agencies, and the state budget director. The department shall
- 19 provide an update on its progress in tracking program-specific
- 20 metrics and the status of program success at an appropriations

23 UNCLASSIFIED POSITIONS

- 24 Sec. 300. (1) From the funds appropriated in part 1, there is
- 25 funding to support unclassified employee positions as authorized by
- 26 section 5 of article XI of the state constitution of 1963. These

- 1 positions include the following: department director the adjutant
- 2 general for Michigan; assistant adjutant general army; assistant
- 3 adjutant general installations; assistant adjutant general air;
- 4 senior policy executive Michigan veterans affairs agency; senior
- 5 deputy director state operations; director strategy and policy;
- 6 chief executive officer for veterans health system; and director -
- 7 Michigan veterans affairs agency.
- 8 (2) Not less than 30 days prior to the department submitting a
- 9 request for an additional unclassified employee position from the
- 10 civil service commission, or for any substantive change to the
- 11 duties of an existing unclassified employee position, the
- 12 department shall notify the subcommittees and the senate and house
- 13 fiscal agencies.

14 ARMORIES AND JOINT FORCE READINESS

- Sec. 302. (1) From the funds appropriated in part 1 for
- 16 military operations, effective and efficient executive direction
- 17 and administrative leadership shall be provided to the department.
- 18 (2) The department shall operate and maintain National Guard
- 19 armories.
- 20 (3) The department shall evaluate armories and submit a
- 21 quarterly report on the status of the armories.
- 22 (4) The department shall maintain a system to measure the
- 23 condition and adequacy of the armories.
- 24 (5) The Michigan Army National Guard and Air National Guard
- 25 shall work to provide a culture that is free of sexual assault,
- 26 through an environment of prevention, education and training,
- 27 response capability, victim support, reporting procedures, and

- 1 appropriate accountability that enhances the safety and well-being
- 2 of all guard members.
- 3 (6) By December 1, the department shall report the following
- 4 information to the subcommittees, the senate and house fiscal
- 5 agencies, and the state budget office:
- 6 (a) An assessment of the grounds and facilities of each armory
- 7 to objectively measure and determine the current facility condition
- 8 and capability to support authorized manpower, unit training, and
- 9 operations.
- 10 (b) Recommendations for the placement of new armories, the
- 11 relocation or consolidation of existing armories, or a change in
- 12 the mission of units assigned to armories to ideally position the
- 13 National Guard in current or projected population centers.
- 14 (c) Recommendations for the enhanced use of armories to
- 15 facilitate family support programs during deployments.
- 16 (d) An analysis of the feasibility, potential costs, and
- 17 benefits of use of armories shared with other local, state, or
- 18 federal agencies to improve responses to local emergencies as well
- 19 as the community support provided to armories.
- (e) An investment strategy and proposed funding amounts in a
- 21 prioritized project list to correct the most critical facility
- 22 shortfalls across the inventory of armories in this state.
- 23 NATIONAL GUARD TRAINING FACILITIES AND AIR BASES
- Sec. 304. (1) The department shall provide Army and Air
- 25 National Guard forces, when directed, for state and local
- 26 emergencies and in support of national military requirements.
- 27 (2) The department shall operate and maintain Army National

- 1 Guard training facilities, including Fort Custer and Camp Grayling.
- 2 (3) The department shall maintain a system that measures the
- 3 condition and adequacy of air facilities using both quality and
- 4 functionality criteria.
- 5 (4) The department shall operate and maintain Air National
- 6 Guard air bases, including Selfridge Air National Guard base,
- 7 Battle Creek Air National Guard base, and Alpena combat readiness
- 8 training center.
- 9 (5) The department shall provide the following information as
- 10 provided under section 219:
- 11 (a) The apportioned and assigned strength of the Michigan Army
- 12 National Guard.
- 13 (b) The apportioned and assigned strength of the Michigan Air
- 14 National Guard.
- 15 (c) Recruiting, retention, and attrition data, including
- 16 measurement against stated performance goals, for the Michigan Army
- 17 National Guard.
- 18 (d) Recruiting, retention, and attrition data, including
- 19 measurement against stated performance goals, for the Michigan Air
- 20 National Guard.
- 21 Sec. 305. There is hereby created and established under the
- 22 jurisdiction and control of the department a revolving account to
- 23 be known as the billeting fund account. All of the fees and other
- 24 revenues generated from the operation of the chargeable transient
- 25 quarters program shall be deposited in the billeting fund account.
- 26 Appropriations will be made from the account for the support of
- 27 program operations and the maintenance and operations of the

- 1 chargeable transient quarters program and will not exceed the
- 2 estimated revenues for the fiscal year in which they are made,
- 3 together with unexpended balances from prior years. The department
- 4 shall submit an annual report of operations and expenditures
- 5 regarding the billeting fund account to the appropriations
- 6 committees of the senate and house of representatives, the house
- 7 and senate fiscal agencies, and the state budget office at the end
- 8 of the fiscal year.

9 MICHIGAN YOUTH CHALLENGE ACADEMY

- 10 Sec. 307. (1) The department shall maintain the Michigan youth
- 11 challeNGe academy to provide values, skills, education, and self-
- 12 discipline instruction for at-risk youth as provided under 32 USC
- **13** 509.
- 14 (2) The department shall take steps to recruit candidates to
- 15 the challeNGe program from economically disadvantaged areas,
- 16 including those with low-income and high-unemployment backgrounds.
- 17 (3) The department shall partner with the department of health
- 18 and human services to identify youth who may be eligible for the
- 19 challeNGe program from those youth served by department of health
- 20 and human services programs. These eligible youth shall be given
- 21 priority for enrollment in the program.
- 22 (4) The department shall maintain the staffing and resources
- 23 necessary to train at least 144 cadets simultaneously at the
- 24 Michigan youth challeNGe academy.
- 25 (5) The department shall ensure that the average grade level
- 26 increase for Michigan youth challeNGe academy graduates is 2 years
- 27 as measured with the test adult basic education (TABE) metrics.

1 MILITARY FAMILY RELIEF FUND

- 2 Sec. 308. (1) The department shall provide grants for
- 3 disbursement from the military family relief fund, as provided
- 4 under the military family relief fund act, 2004 PA 363, MCL 35.1211
- 5 to 35.1216, and R 200.5 to R 200.95 of the Michigan administrative
- 6 code.
- 7 (2) The department shall provide information on the revenues,
- 8 expenditures for advertising and assistance grants, and fund
- 9 balance of the Michigan military family relief fund, as provided
- 10 under section 219.
- 11 (3) The department shall provide sufficient staffing and other
- 12 resources to provide outreach to the Michigan families of members
- 13 of the reserve component of the armed forces called into active
- 14 duty and to support the processing and approval of at least 60
- 15 grant applications this fiscal year under the Michigan military
- 16 relief fund and report those applications as provided in section
- **17** 219.

18 STARBASE GRANT

- 19 Sec. 309. The department shall maintain the starbase program
- 20 at Air National Guard facilities, as provided under 10 USC 2193b,
- 21 to improve the knowledge, skills, and interest of students,
- 22 primarily in the fifth grade, in math, science, and technology. The
- 23 starbase program is to specifically target minority and at-risk
- 24 students for participation.

25 NATIONAL GUARD TUITION ASSISTANCE PROGRAM

- Sec. 310. (1) The department shall establish and maintain a
- 27 National Guard tuition assistance program for members of the

- 1 Michigan Air and Army National Guard.
- 2 (2) The objective of the National Guard tuition program is to

- 23 (4) From the funds appropriated in part 1, the National Guard
- 24 tuition assistance program shall be supported with revenue from the
- 25 Michigan national guard tuition assistance fund created in section
- 26 4 of the Michigan national guard tuition assistance act, 2014 PA
- 27 259, MCL 32.434. As provided in section 4 of the Michigan national

- 1 guard tuition assistance act, 2014 PA 259, MCL 32.434, unexpended
- 2 funds remaining in the Michigan national guard tuition assistance
- 3 fund at the end of the fiscal year shall not lapse to the general
- 4 fund.

5 INFORMATION TECHNOLOGY SERVICES AND PROJECTS

- 6 Sec. 311. The funds appropriated in part 1 for information
- 7 technology services and projects shall be used as a pass through
- 8 via an IDG to the department of technology, management, and budget
- 9 for technology services, including maintenance and repair services,

13 MICHIGAN VETERANS AFFAIRS AGENCY ADMINISTRATION

- 14 Sec. 400. (1) The MVAA agency shall provide outreach services
- 15 to Michigan veterans that advise them on the benefits to which they
- 16 are entitled, as provided under Executive Reorganization Order No.
- 17 2013-2, MCL 32.92. The MVAA shall also do the following:
- 18 (a) Maintain the staffing partnerships and other resources
- 19 necessary to develop and operate an outreach program that will
- 20 communicate benefit eligibility information to at least 50% of
- 21 Michigan's population of veterans, as assessed by annual census
- 22 estimates, with a goal of reaching 100% and enabling 100% to access
- 23 benefit information online.
- 24 (b) Communicate veteran benefit information pertaining to the
- 25 Michigan military family relief fund, Michigan veterans' trust
- 26 fund, and USDVA health, financial, and memorial benefits to which

- 1 they are entitled.
- 2 (c) Provide sufficient staffing and other resources to approve
- 3 requests for military discharge certificates (DD-214) annually.
- 4 (d) Continue the process to digitize all medical records,
- 5 military discharge documents, and burial records that are currently
- 6 on paper and microfilm.
- 7 (e) Provide a report, as provided under section 219, on the
- 8 MVAA's performance on the performance measures, outcomes, and
- 9 initiatives developed by the agency in the strategic plan required
- 10 by section 501 of 2013 PA 9.
- 11 (f) Provide a report to the subcommittees, senate and house
- 12 fiscal agencies, and the state budget office no later than April 1
- 13 providing for the following:
- 14 (i) To the extent known, data on the estimated number of
- 15 homeless veterans, by county, in this state.
- 16 (ii) A summary of the activities and strategies developed to
- 17 date under the MVAA community assessment and regional service
- 18 delivery model pilot.
- 19 (2) From the funds appropriated in part 1, the MVAA shall
- 20 provide for the regional coordination of services, as follows:
- (a) Regional coordinators shall be selected by the MVAA
- 22 through a grant agreement with VSOs or by other means.
- 23 (b) Regional coordinators shall provide the following
- 24 services:
- 25 (i) Coordinate veteran benefit counselors' efforts throughout
- 26 a specified region.
- 27 (ii) Coordinate services with the department of health and

- 1 human services and the department of corrections.
- 2 (iii) Coordinate with regional workforce and economic
- 3 development agencies.
- 4 (iv) Coordinate activities among local foundations, nonprofit

- 9 (i) The number of benefit claims, by type, submitted to the

- 11 (ii) The number of fully developed claims, submitted to the
- 12 USDVA, with an overall goal of 40% of benefit claims submitted that
- 13 are considered fully developed by the USDVA.
- 14 (b) Maintain the staffing and resources necessary to process a
- 15 minimum of 500 claims per year.
- 16 (4) The MVAA shall maintain staffing and resources necessary
- 17 to develop and implement a process to ensure that all county
- 18 counselors receive the training and accreditation necessary to
- 19 provide quality services to our veterans. The MVAA shall report
- 20 information as provided in section 219 on the number and percentage

- 8 (d) Use of an MVAA-designated Internet-based claims data
- 9 system.
- 10 (3) The MVAA shall report the following information as
- 11 provided in section 219:
- 12 (a) A summary of activities supported through the
- 13 appropriation in part 1 for veterans service organization grants,
- 14 including separately for each service region, the amount of
- 15 expenditures to date, number of service hours, number of claims for
- 16 benefits submitted by type of claim, and other information deemed
- 17 appropriate by the MVAA.
- 18 (b) The number of fully developed claims, by type, submitted
- 19 to the USDVA by veterans service organizations, with an overall
- 20 goal of 40% of benefit claims submitted that are considered fully
- 21 developed by the USDVA.
- 22 VETERANS' TRUST FUND ADMINISTRATION
- Sec. 407. (1) The Michigan veterans' trust fund board together
- 24 with the MVAA shall provide emergency grants for disbursement from
- 25 the Michigan veterans' trust fund, as provided under the following
- 26 program authorities:
- 27 (a) Sections 37, 38, and 39 of article IX of the state

- 1 constitution of 1963.
- 2 (b) 1946 (1st Ex Sess) PA 9, MCL 35.602 to 35.610.
- 3 (c) R 35.1 to R 35.7 of the Michigan administrative code.
- 4 (d) R 35.621 to R 35.623 of the Michigan administrative code.
- 5 (2) No later than December 1, the MVAA shall provide a
- 6 detailed report of the Michigan veterans' trust fund that includes,
- 7 for the prior fiscal year, information on grants provided from the
- 8 emergency grant program, including details concerning the
- 9 methodology of allocations, the selection of emergency grant
- 10 program authorized agents, a description of how the emergency grant
- 11 program is administered in each county, and a detailed breakdown of

- 26 (2) The Michigan veterans' trust fund board together with the
- 27 agency shall maintain the staffing and resources necessary to

- 1 process a minimum of 2,000 applications for veterans' trust fund
- 2 emergency grants.
- 3 GRAND RAPIDS AND D.J. JACOBETTI HOMES FOR VETERANS
- 4 Sec. 501. (1) The MVAA and the board of managers shall provide
- 5 compassionate and quality nursing and domiciliary care services at
- 6 the Grand Rapids and D.J. Jacobetti homes for veterans so that
- 7 members can achieve their highest potential of wellness,
- 8 independence, self-worth, and dignity.
- 9 (2) The department shall provide resources necessary to
- 10 provide nursing care services to veterans in accordance with
- 11 federal standards and provide the results of the annual USDVA
- 12 survey and certification as proof of compliance, including the

- 20 (3) Appropriations in part 1 for the veterans' homes shall not
- 21 be used for any purpose other than for veterans and veterans'
- 22 families.
- 23 (4) Any contractor providing competency evaluated nursing
- 24 assistants (CENA) to either of the veterans' homes shall ensure
- 25 that each CENA has at least 8 hours of training on information
- 26 provided by the home.
- 27 (5) Any contractor providing competency evaluated nursing

- 1 assistants to either of the veterans' homes shall ensure that each
- 2 CENA has at least 1 eight-hour shift of shadowing at the veterans'
- 3 home.
- 4 (6) Any contractor providing competency evaluated nursing
- 5 assistants to either of the veterans' homes shall ensure that each
- 6 CENA is competent in the basic skills needed to perform his or her
- 7 assigned duties at the home.
- **8** (7) The veterans' homes shall provide each CENA at least 12
- 9 hours of in-service training once that individual has been assigned

- 17 for calculating resident member maintenance assessments in order to

- 19 each billing cycle. The veterans' homes shall establish sufficient
- 20 controls to ensure that all past due resident member maintenance
- 21 assessments are addressed within 30 days.
- 22 (14) The veterans' homes shall establish sufficient controls
- 23 over monetary donations and donated goods.
- 24 (15) The veterans' homes shall implement sufficient controls
- 25 over the handling of resident member funds to ensure the release of
- 26 funds within 3 business days upon the resident member leaving the
- 27 home and to ensure that a representative of a resident member is

- 1 provided a full accounting of that resident member's funds within
- 2 10 business days of the death of that resident member.
- 3 (16) The MVAA shall post on its website all policies adopted
- 4 by the board of managers and the home related to the administrative
- 5 operations of the home.
- 6 (17) The process by which visitors, residents, and employees
- 7 of the veterans' homes may register complaints shall be displayed
- 8 in high-traffic areas throughout the home.
- 9 (18) The MVAA shall report its findings regarding the veterans
- 10 homes' compliance with the requirements and standards under this
- 11 section as provided in section 219. The quarterly reports shall
- include, but are not limited to, the following information:
- 13 (a) Quality of care metrics, including:
- 14 (i) The number of patient care hours and staffing levels
- 15 measured against USDVA-VHA standards.

- 18 (iv) Complaint reports, including abuse and neglect complaints
- 19 and outcomes of complaint investigations.
- 20 (v) Additional minimum data set quality of care indicators
- 21 used to measure quality of care in long-term care facilities.
- 22 (b) Quarterly budget update.
- 23 (c) An accounting of resident member populations at the Grand
- 24 Rapids and D.J. Jacobetti homes for veterans as follows:
- 25 (i) By demographics, including period of service, gender, and
- **26** age.
- 27 (ii) By care setting, payment source, and associated revenue

- 1 projections.
- 2 (d) Updates related to the modernization of the veterans
- 3 homes, including information related to the following:
- 4 (i) Infrastructure/capital outlay improvements.
- 5 (ii) Information technology updates.
- 6 (iii) Financial management.
- 7 (e) Updates on corrective action status related to any audit
- 8 and survey findings until such findings have been fully addressed.
- 9 (19) The veterans' homes shall provide to the subcommittees,
- 10 the senate and house fiscal agencies, and the state budget office
- 11 the results of any annual or for-cause survey conducted by the
- 12 USDVA-VHA and any corresponding corrective action plan. This
- 13 information shall also be made available publicly through the
- 14 department's or MVAA's website.
- 15 (20) The MVAA shall provide to the legislature and the state
- 16 budget office quarterly reports regarding the status of Medicaid
- 17 certification efforts, including, but not limited to, descriptions
- 18 of incremental milestones, associated expenditures, and the percent
- 19 of plan completed.
- 20 Sec. 502. (1) From the increased funds appropriated in part 1
- 21 for the D.J. Jacobetti home for veterans, the department shall
- 22 pursue compliance with current Centers for Medicare and Medicaid
- 23 Services certification standards by the end of the current fiscal
- 24 year. The purpose of this expansion will be to obtain Medicaid
- 25 certification during fiscal year 2016-2017, to increase the ability
- 26 to fully utilize all federal funding available to cover the cost of
