## SENATE BILL NO. 1017

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 81f.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 81F. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A
- 2 PERSON WHO ASSAULTS OR ASSAULTS AND BATTERS AN INDIVIDUAL WITH A
- 3 DEVELOPMENTAL DISABILITY, MENTAL ILLNESS, OR COGNITIVE IMPAIRMENT
- 4 AND WHO KNOWS THE INDIVIDUAL HAS A DEVELOPMENTAL DISABILITY, MENTAL
- 5 ILLNESS, OR COGNITIVE IMPAIRMENT IS GUILTY OF A MISDEMEANOR
- 6 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1 YEAR OR A FINE OF
- 7 NOT MORE THAN \$1,000.00, OR BOTH.
- 8 (2) A PERSON WHO COMMITS AN ASSAULT OR AN ASSAULT AND BATTERY
- 9 IN VIOLATION OF SUBSECTION (1) AND WHO HAS 1 OR MORE PREVIOUS
- 10 CONVICTIONS FOR VIOLATING SUBSECTION (1) OR AN ORDINANCE OF A

- POLITICAL SUBDIVISION OF THIS STATE OR OF ANOTHER STATE 1
- 2 SUBSTANTIALLY CORRESPONDING TO SUBSECTION (1) IS GUILTY OF A FELONY
- PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 5 YEARS OR A FINE OF 3
- 4 NOT MORE THAN \$5,000.00, OR BOTH.
- (3) THIS SECTION DOES NOT APPLY TO AN INDIVIDUAL USING 5
- NECESSARY REASONABLE PHYSICAL FORCE IN COMPLIANCE WITH SECTION 1312
- OF THE REVISED SCHOOL CODE, 1976 PA 451, MCL 380.1312. 7
- 8 (4) AS USED IN THIS SECTION:
- (A) "DEVELOPMENTAL DISABILITY" MEANS THAT TERM AS DEFINED IN 9
- SECTION 520A(B) OF THE MICHIGAN PENAL CODE, 1931 PA 328, MCL 10
- 11 750.520A.
- 12 (B) "MENTAL ILLNESS" MEANS THAT TERM AS DEFINED IN SECTION
- 13 1001A OF THE MENTAL HEALTH CODE, 1974 PA 258, MCL 330.2001A.
- 14 Enacting section 1. This amendatory act takes effect 90 days
- after the date it is enacted into law. 15
