A bill to amend 1973 PA 186, entitled
"Tax tribunal act,"
by amending sections 3, 21, 22, 25, 26, 32, 34, 35a, 49, 51, and 62
(MCL 205.703, 205.721, 205.722, 205.725, 205.726, 205.732, 205.734,
205.735a, 205.749, 205.751, and 205.762), sections 3, 32, and 35a
as amended by 2008 PA 125, section 22 as amended by 2008 PA 127,
sections 26 and 49 as amended by 2008 PA 126, section 34 as amended
by 1980 PA 437, and section 62 as amended by 2008 PA 128; and to
repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 3. As used in this act:

2 (a) "Agency" means a board, official, or administrative agency
3 empowered to make a decision, finding, ruling, assessment,
4 determination, or order that is subject to review under the

1 jurisdiction of the tribunal or that has collected a tax for which
2 a refund is claimed.

3 (b) "Chairperson" means the chairperson of the tribunal.

4 (C) "ENTIRE TRIBUNAL" MEANS THE HEARING DIVISION OF THE
5 TRIBUNAL OTHER THAN THE RESIDENTIAL PROPERTY AND SMALL CLAIMS
6 DIVISION CREATED IN SECTION 61.

7 (D) ~~(e)~~—"Mediation" means a voluntary process in which a
8 mediator facilitates communication between parties, assists in
9 identifying issues, and helps explore solutions to promote a
10 mutually acceptable settlement.

11 (E) ~~(d)~~—"Mediator" means a neutral third party who is
12 certified by the tribunal under section 47 as a mediator in a
13 proceeding before the tribunal or as a facilitator in the court of
14 claims, and who is agreed to by the parties.

15 (F) ~~(e)~~—"Proceeding" means an appeal taken under this act.

16 (G) ~~(f)~~—"Property tax laws" does not include the drain code of
17 1956, 1956 PA 40, MCL 280.1 to 280.630.

18 (H) ~~(g)~~—"Tribunal" means the tax tribunal created under
19 section 21.

20 Sec. 21. (1) The tax tribunal is created and is a quasi-
21 judicial agency which, for administrative purposes only, is in the
22 department of ~~treasury~~. **LICENSING AND REGULATORY AFFAIRS.**

23 (2) The tribunal ~~consists~~ **SHALL CONSIST** of 7 members, **EACH**
24 appointed by the governor **AS A FULL- OR PART-TIME MEMBER**, with the
25 advice and consent of the senate, for ~~terms~~ **A TERM** of 4 years. The
26 ~~2 additional members first appointed by this amendatory act shall~~
27 ~~first serve for 3 years.~~ **WHEN MAKING AN APPOINTMENT, THE GOVERNOR**

1 SHALL CONSIDER A LIST OF QUALIFIED CANDIDATES SOLICITED FROM AT
2 LEAST 1 APPROPRIATE PROFESSIONAL ASSOCIATION LOCATED AND PRIMARILY
3 OPERATING IN THIS STATE THAT IS ABLE TO IDENTIFY CANDIDATES
4 QUALIFIED FOR THE VACANCY BEING FILLED.

5 (3) SUBJECT TO SUBSECTION (6), THE FULL- OR PART-TIME STATUS
6 OF A MEMBER, INCLUDING ANY HOURLY BASIS FOR THAT STATUS, SHALL NOT
7 BE DIMINISHED DURING THE LENGTH OF HIS OR HER TERM WITHOUT HIS OR
8 HER CONSENT.

9 (4) A member may be reappointed and a vacancy shall be filled
10 for an unexpired term in the same manner as the appointment is made
11 for a full term.

12 (5) THE GOVERNOR SHALL DESIGNATE A MEMBER AS CHAIRPERSON, WHO
13 SHALL ASSIGN MATTERS, APPORTION BUSINESS OF THE TRIBUNAL, AND
14 PERFORM OTHER DUTIES PRESCRIBED BY LAW. THE CHAIRPERSON SHALL SERVE
15 IN THAT CAPACITY AT THE PLEASURE OF THE GOVERNOR.

16 (6) THE GOVERNOR MAY REMOVE A MEMBER, AFTER NOTICE AND AN
17 OPPORTUNITY TO BE HEARD, FOR FAILURE TO SUBSTANTIALLY PERFORM HIS
18 OR HER DUTIES UNDER THIS ACT, MALFEASANCE, MISFEASANCE, OR
19 NONFEASANCE IN OFFICE, OR OTHER GOOD CAUSE.

20 (7) MEMBERS SHALL RECEIVE TRAINING ON MATTERS RELEVANT TO THE
21 WORK OF THE TRIBUNAL, INCLUDING, BUT NOT LIMITED TO, PROPER
22 COURTROOM PROCEDURES, STATE AND LOCAL TAX ISSUES, ACCEPTED
23 APPRAISAL PRACTICES, AND PROPER ASSESSING PRACTICES.

24 Sec. 22. (1) ALL OF THE FOLLOWING APPLY TO TRIBUNAL
25 MEMBERSHIP:

26 (A) ~~(1)~~—The members of the tribunal shall be citizens of the
27 United States and residents of this state.

1 **(B)** At least 2 members shall be attorneys admitted to practice
2 in this state who have been engaged for at least 5 years
3 immediately preceding the appointment in active government,
4 corporate, or private practice dealing with federal and state or
5 local tax matters, including property taxes, or in the discharge of
6 a judicial or quasi-judicial office.

7 **(C)** At least 1 member shall be a certified assessor holding
8 the highest level of certification granted by the state ~~assessors~~
9 ~~board.~~ **TAX COMMISSION.**

10 **(D)** At least 1 member shall be a professional real estate
11 appraiser holding a recognized certification indicating competence
12 in the valuation of complex income producing and residential
13 property of the type subject to property taxation, with a
14 certification having required a review of sample appraisals and 5
15 years of experience as an appraiser.

16 **(E)** At least 1 member shall be a certified public accountant
17 with 5 years of experience in state or local tax matters.

18 **(F)** Appointees who are not attorneys, certified assessors,
19 professional real estate appraisers, or certified public
20 accountants shall have at least 5 years of experience in state or
21 local tax matters.

22 (2) Each member shall take and subscribe to the constitutional
23 oath of office before entering on the discharge of his or her
24 duties.

25 (3) Each member shall ~~devote his or her entire time to, and~~
26 personally perform the duties of ~~his or her office, and shall not~~
27 ~~engage in other business or professional activity for~~

~~remuneration.~~ INCLUDING, BUT NOT LIMITED TO, THE MAINTENANCE OF HIS OR HER DOCKET AS ASSIGNED AND DIRECTED BY THE CHAIRPERSON AND IN ACCORDANCE WITH RULES PRESCRIBED UNDER SECTION 32. EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION, A MEMBER SHALL NOT ENGAGE IN ANY OTHER GAINFUL EMPLOYMENT OR BUSINESS OR PROFESSIONAL ACTIVITY FOR REMUNERATION, OR HOLD ANY OTHER OFFICE IN OR ENGAGE IN ANY OTHER PROFITABLE UNDERTAKING WITH ANY GOVERNMENTAL ENTITY OF THIS STATE, ANOTHER STATE, OR THE UNITED STATES. ADDITIONALLY, A MEMBER SHALL NOT ACT AS AN ATTORNEY, REPRESENTATIVE, OR ACCOUNTANT FOR OTHERS IN A MATTER INVOLVING ANY TAX IMPOSED OR LEVIED BY THIS STATE OR ANY OF ITS POLITICAL SUBDIVISIONS. HOWEVER, A MEMBER MAY DO ANY OF THE FOLLOWING:

(A) OWN PASSIVE INTERESTS IN BUSINESS ENTITIES.

(B) EARN INCOME FROM INCIDENTAL TEACHING OR SCHOLARLY ACTIVITIES.

(C) RECEIVE COMPENSATION FOR EXTRAJUDICIAL ACTIVITIES DESCRIBED IN CANON 4 OF THE MICHIGAN CODE OF JUDICIAL CONDUCT IF THE RECEIPT OF THAT COMPENSATION DOES NOT CREATE AN APPEARANCE OF IMPROPRIETY, INCLUDING, BUT NOT LIMITED TO, AN APPEARANCE THAT THE SOURCE OF THAT COMPENSATION INFLUENCED THE MEMBER IN THE PERFORMANCE OF HIS OR HER DUTIES.

(D) ACT PROFESSIONALLY ON HIS OR HER OWN BEHALF, INCLUDING, BUT NOT LIMITED TO, AS HIS OR HER OWN ATTORNEY OR ACCOUNTANT.

(E) PROVIDE PROFESSIONAL SERVICES TO FAMILY MEMBERS, INCLUDING, BUT NOT LIMITED TO, LEGAL, ACCOUNTING, AND TAX SERVICES, SO LONG AS HE OR SHE IS NOT PAID FOR THOSE SERVICES.

(4) ~~Each~~ BEFORE OCTOBER 1, 2017, EACH member shall receive an

1 annual salary as determined by law. ~~and~~ AFTER SEPTEMBER 30, 2017,
2 EACH MEMBER WHO WORKS FOR THE TRIBUNAL FULL TIME, AS DETERMINED BY
3 THE DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS, SHALL RECEIVE
4 AN ANNUAL SALARY NOT LESS THAN THE MAXIMUM SALARY PAID TO AN
5 ADMINISTRATIVE LAW MANAGER OR EQUIVALENT CIVIL SERVICE
6 CLASSIFICATION. EACH MEMBER WHO WORKS FOR THE TRIBUNAL PART TIME,
7 AS DETERMINED BY THE DEPARTMENT OF LICENSING AND REGULATORY
8 AFFAIRS, SHALL RECEIVE AN ANNUAL PRO RATA SALARY PROPORTIONATE TO
9 THE SALARY OF A MEMBER WHO WORKS FULL TIME. IN ADDITION TO HIS OR
10 HER ANNUAL SALARY, EACH MEMBER shall be reimbursed for his or her
11 actual and necessary expenses at the rate determined by the
12 administrative board. AS USED IN THIS SUBSECTION, "ACTUAL AND
13 NECESSARY EXPENSES" INCLUDES, BUT IS NOT LIMITED TO, FEES INCURRED
14 FOR THE RENEWAL OF RELEVANT AND APPROPRIATE PROFESSIONAL LICENSES
15 AND MEMBERSHIPS IN ASSOCIATIONS LOCATED IN THIS STATE.

16 (5) THE GOVERNOR MAY, WITH THE ADVICE AND CONSENT OF THE
17 SENATE, APPOINT NOT MORE THAN 3 MEMBERS OF THE TRIBUNAL PRO TEMPORE
18 IF IT APPEARS TO THE GOVERNOR THAT THE SERVICES OF AN ADDED MEMBER
19 OR MEMBERS ARE ADVISABLE. A PRO TEMPORE MEMBER SHALL BE QUALIFIED
20 FOR MEMBERSHIP UNDER THIS SECTION AND IS SUBJECT TO THE DUTIES AND
21 LIMITATIONS OF A MEMBER OF THE TRIBUNAL UNDER THIS ACT. A PRO
22 TEMPORE MEMBER SHALL BE APPOINTED FOR NOT MORE THAN 12 MONTHS, ON A
23 FULL- OR PART-TIME BASIS, UNLESS REAPPOINTED BY THE GOVERNOR. PRO
24 TEMPORE MEMBERS APPOINTED UNDER THIS SUBSECTION DO NOT COUNT TOWARD
25 THE NUMBER OF MEMBERS APPOINTED UNDER SECTION 21.

26 (6) ON MOTION OF A PARTY TO A PROCEEDING OR A TRIBUNAL MEMBER
27 ASSIGNED TO THE PROCEEDING, OR BY ORDER OF THE CHAIRPERSON, A

MEMBER ASSIGNED TO THE PROCEEDING MAY BE DISQUALIFIED FOR ANY REASON LISTED IN MCR 2.003(C)(1). A MOTION FOR DISQUALIFICATION BY A PARTY TO THE PROCEEDING SHALL BE REVIEWED AND EITHER APPROVED OR DENIED BY THE TRIBUNAL MEMBER PRESIDING OVER THE PROCEEDING. IF THE MOTION IS DENIED, THE MOVING PARTY MAY APPEAL TO THE CHAIRPERSON UNLESS THE CHAIRPERSON IS PRESIDING OVER THE PROCEEDING. IF THE CHAIRPERSON IS PRESIDING OVER THE PROCEEDING, AN APPEAL SHALL INSTEAD BE RANDOMLY ASSIGNED TO ANOTHER MEMBER WHO IS QUALIFIED UNDER SECTION 22 AS AN ATTORNEY. A MOTION FOR DISQUALIFICATION BY A PARTY TO A PROCEEDING MUST BE FILED NOT LATER THAN 14 DAYS IMMEDIATELY SUCCEEDING THE DISCOVERY OF THE GROUNDS FOR DISQUALIFICATION. HOWEVER, IF A TRIAL IS SCHEDULED ON A DATE THAT IS LESS THAN 15 DAYS AFTER THE DISCOVERY, THE MOTION MUST BE MADE AS FAR IN ADVANCE OF THAT TRIAL DATE AS IS REASONABLY POSSIBLE. DISQUALIFICATION MAY BE WAIVED WITH THE CONSENT OF ALL PARTIES AND SHALL BE IN WRITING OR PLACED ON THE RECORD.

(1) The principal office of the tribunal and its chief clerk shall be in the city of Lansing. ~~and the department of administration~~ **IN ADDITION, THE TRIBUNAL MAY OPERATE SUCH REGIONAL OFFICES ACROSS THIS STATE AS THE CHAIRPERSON CONSIDERS NECESSARY. THE DEPARTMENT OF TECHNOLOGY, MANAGEMENT, AND BUDGET shall furnish suitable accommodations and equipment there.** **IN THESE PRINCIPAL AND REGIONAL OFFICES.**

14 assessable property is filed under section 19 of the general
15 property tax act, 1893 PA 206, MCL 211.19, prior to the

18 that is subject to taxation under 1974 PA 198, MCL 207.551 to

4 (5) For a dispute regarding a determination of a claim of
5 exemption of a principal residence or qualified agricultural

7 has authority to determine a claim of exemption for a principal
8 residence or qualified agricultural property, the claim of
9 exemption shall be presented to either the July or December board
10 of review before the tribunal acquires jurisdiction of the dispute.

23 as to property classified under section 34c of the general property
24 tax act, 1893 PA 206, MCL 211.34c, as agricultural real property,
25 residential real property, timber-cutover real property, or
26 agricultural personal property is invoked by a party in interest,
27 as petitioner, filing a written petition on or before July 31 of

1 the tax year involved. In all other matters, the jurisdiction of
2 the tribunal is invoked by a party in interest, as petitioner,
3 filing a written petition within 35 days after the final decision,
4 ruling, or determination **OR, AFTER SEPTEMBER 30, 2017, IF THE FINAL**
5 **DECISION, RULING, OR DETERMINATION IS ONE FOR WHICH THE TRIBUNAL'S**
6 **JURISDICTION IS CONCURRENT WITH THE COURT OF CLAIMS, WITHIN 90 DAYS**
7 **AFTER THE FINAL DECISION, RULING, OR DETERMINATION.** An appeal of a
8 contested tax bill shall be made within 60 days after mailing by
9 the assessment district treasurer and the appeal is limited solely
10 to correcting arithmetic errors or mistakes and is not a basis of
