SUBSTITUTE FOR HOUSE BILL NO. 4584

A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 5822.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 5822. (1) UPON RECEIPT OF A POSITIVE PRENATAL OR
- 2 POSTNATAL TEST RESULT OR DIAGNOSIS OF SPINA BIFIDA, A HEALTH
- 3 FACILITY OR AGENCY LICENSED UNDER ARTICLE 17 OR A PHYSICIAN, HEALTH
- 4 CARE PROVIDER, NURSE MIDWIFE, OR GENETIC COUNSELOR THAT RENDERS
- 5 PRENATAL CARE, POSTNATAL CARE, OR GENETIC COUNSELING, SHALL GIVE
- 6 THE EXPECTANT OR NEW PARENT THE INFORMATION PROVIDED BY THE
- 7 DEPARTMENT AND DESCRIBED IN SUBSECTION (2).
- 8 (2) THE DEPARTMENT SHALL MAKE AVAILABLE TO ANY PERSON WHO
- 9 RENDERS PRENATAL CARE, POSTNATAL CARE, OR GENETIC COUNSELING TO
- 10 PARENTS WHO RECEIVE A PRENATAL OR POSTNATAL DIAGNOSIS OF SPINA

- EDUCATIONAL, AND PSYCHOSOCIAL OUTCOMES, LIFE EXPECTANCY, CLINICAL
- 7 COURSE, INTELLECTUAL AND FUNCTIONAL DEVELOPMENT, AND TREATMENT
- 8 OPTIONS. THE DEPARTMENT MAY MAKE THE INFORMATION DESCRIBED IN THIS
- SUBDIVISION AVAILABLE BY POSTING IT ON THE DEPARTMENT'S WEBSITE. 9
- (B) CONTACT INFORMATION REGARDING SUPPORT PROGRAMS AND 10
- 11 SERVICES THAT MAY BE AVAILABLE TO EXPECTANT AND NEW PARENTS OF
- CHILDREN WITH SPINA BIFIDA, INCLUDING INFORMATION HOTLINES SPECIFIC 12
- TO SPINA BIFIDA, RESOURCE CENTERS OR CLEARINGHOUSES, AND NATIONAL 13
- 14 AND LOCAL SPINA BIFIDA ORGANIZATIONS.
 - [(C) IT IS HIGHLY RECOMMENDED THAT A PERSON WHO HAS RECEIVED A POSITIVE TEST RESULT FROM A TEST FOR SPINA BIFIDA TAKE ANOTHER TEST TO CONFIRM THAT THE PERSON DID NOT RECEIVE A FALSE POSITIVE TEST RESULT.]
- 15 (3) THE DEPARTMENT SHALL POST LINKS TO CREDIBLE SOURCES OF

- (4) AS USED IN THIS SECTION, "SPINA BIFIDA" MEANS A CONGENITAL 19
- MALFORMATION OF THE BONE IN THE VERTEBRAL COLUMN THAT EXPOSES THE 20
- 21 SPINAL CORD, WHICH IS CAUSED BY INCOMPLETE CLOSING OF THE EMBRYONIC
- 22 NEURAL TUBE.
- 23 Enacting section 1. This amendatory act takes effect 90 days
- 24 after the date it is enacted into law.
