## SUBSTITUTE FOR

## HOUSE BILL NO. 4699

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 803f (MCL 257.803f), as amended by 1998 PA 68.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 803f. (1) A person who is a totally disabled veteran with
- 2 an honorable discharge from the armed services may make an
- 3 application to the secretary of state if he or she owns a private
- 4 passenger motor vehicle, and the secretary of state may issue a-1
- 5 OF THE FOLLOWING:
- 6 (A) A special registration plate which shall be inscribed with
- 7 special identification numbers preceded by the letters "DV" and
- 8 shall have the words "disabled veteran" inscribed beneath the
- 9 registration number. For the purposes of this section, "private

- 1 passenger motor vehicle" means a motor vehicle which is personally
- 2 owned by the disabled veteran and is used for the primary purpose
- 3 of transporting the disabled veteran and family members of the
- 4 disabled veteran, but does not include a motor home.
- 5 (B) A STANDARD OR COMMEMORATIVE ISSUE PLATE ISSUED UNDER
- 6 SECTION 224.
- 7 (C) A VETERAN OR MILITARY SERVICE PLATE ISSUED UNDER SECTION
- 8 803I, 803J, 803K, 803l, 803N, OR 803O.
- 9 (D) A SPECIAL REGISTRATION PLATE ISSUED UNDER SECTION 803D.
- 10 (2) Application for the A special registration plate ISSUED
- 11 UNDER THIS SECTION shall be on a form prescribed by the secretary
- 12 of state, and, EXCEPT AS OTHERWISE PROVIDED IN THIS ACT, shall be
- 13 accompanied by a service fee of \$5.00 and proof that the applicant
- 14 was honorably discharged from the armed services and either 1 of
- 15 the following:
- 16 (a) That the applicant has been determined by the veterans'
- 17 administration VETERANS' ADMINISTRATION of the federal government
- 18 to have a service-connected total or permanent total disability
- 19 rating for compensation.
- 20 (b) That the applicant has been determined to have a service-
- 21 connected total or permanent total disability rating and is
- 22 receiving disability retirement pay from a branch of the uniformed
- 23 armed services.
- 24 (3) A special registration issued under this section is exempt
- 25 from payment of the tax provided in section 801.
- 26 (4) The A special registration plate shall expire ISSUED UNDER
- 27 THIS SECTION EXPIRES on the birthday of the disabled veteran in a

- 1 year in which new plates are issued by the secretary of state.
- 2 Application EXCEPT AS OTHERWISE PROVIDED IN THIS ACT, APPLICATION
- 3 for renewal of the special registration plate shall be accompanied
- 4 by a \$5.00 service fee. The applicant shall—IS not be required to
- 5 furnish the proof provided in subsection (2).
- **6** (5) The secretary of state may issue to a disabled person who
- 7 has been issued a special registration plate under this section a
- 8 tab for persons with disabilities. The tab for persons with
- 9 disabilities shall be an adhesive tab displaying the international
- 10 wheelchair symbol or a reasonable facsimile of that symbol. The tab
- 11 for persons with disabilities may be attached only to the A special
- 12 registration plate issued to the disabled person under this
- 13 section.
- 14 (6) An application for a tab for persons with disabilities
- 15 shall be on a form prescribed by the secretary of state. The
- 16 secretary of state shall require the same proof that the applicant
- 17 is a disabled person as is required for issuance of a permanent
- 18 windshield placard under section 675.
- 19 (7) The tab for persons with disabilities shall be issued free
- 20 of charge.
- 21 (8) When a disabled person who has been issued a tab for
- 22 persons with disabilities renews his or her special registration
- 23 plate under this section, the secretary of state shall issue a new
- 24 tab for persons with disabilities to the disabled person, free of
- 25 charge. The disabled person shall not be required to again furnish
- 26 the proof required under subsection (6).
- 27 (9) The use of the—A special registration plate ISSUED UNDER

- THIS SECTION or a tab for persons with disabilities on a motor 1
- 2 vehicle other than the motor vehicle for which the special
- registration plate is issued, or by a person who does not qualify 3
- 4 under this section, is a misdemeanor.
- (10) AS USED IN THIS SECTION, "PRIVATE PASSENGER MOTOR 5
- VEHICLE" MEANS A MOTOR VEHICLE WHICH IS PERSONALLY OWNED BY THE
- DISABLED VETERAN AND IS USED FOR THE PRIMARY PURPOSE OF 7
- TRANSPORTING THE DISABLED VETERAN AND FAMILY MEMBERS OF THE 8
- DISABLED VETERAN, BUT DOES NOT INCLUDE A MOTOR HOME.
- 10 Enacting section 1. This amendatory act takes effect August 1,
- 11 2019.
