SUBSTITUTE FOR

HOUSE BILL NO. 4748

A bill to amend 1954 PA 116, entitled "Michigan election law,"

by amending section 349 (MCL 168.349), as amended by 2012 PA 276.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 349. (1) To obtain the printing of the name of a person
- 2 as a candidate for nomination by a political party for a township
- 3 office under the particular party heading upon the official primary
- 4 ballots, there shall MUST be filed with the township clerk
- 5 nominating petitions signed by a number of qualified and registered
- 6 electors residing within the township as determined under section
- 7 544f. Nominating petitions shall MUST be in the form prescribed in
- 8 section 544c. Until December 31, 2013, the township clerk shall
- 9 receive nominating petitions up to 4 p.m. of the twelfth Tuesday
- 10 before the August primary. Beginning January 1, 2014, the THE

- 1 township clerk shall receive nominating petitions up to 4 p.m. of
- 2 the fifteenth Tuesday before the August primary.
- 3 (2) TO OBTAIN THE PRINTING OF THE NAME OF A CANDIDATE OF A
- 4 POLITICAL PARTY UNDER THE PARTICULAR PARTY'S HEADING UPON THE
- 5 PRIMARY ELECTION BALLOTS IN THE VARIOUS VOTING PRECINCTS OF THE
- 6 TOWNSHIP, THERE MAY BE FILED BY THE CANDIDATE, IN LIEU OF FILING
- 7 NOMINATING PETITIONS, A NONREFUNDABLE FILING FEE OF \$100.00 TO BE
- 8 PAID TO THE TOWNSHIP CLERK. PAYMENT OF THE FEE AND CERTIFICATION OF
- 9 THE CANDIDATE'S NAME PAYING THE FEE ARE GOVERNED BY THE SAME
- 10 PROVISIONS AS IN THE CASE OF NOMINATING PETITIONS. THE FEE MUST BE
- 11 DEPOSITED IN THE GENERAL FUND OF THE TOWNSHIP.
- 12 (3) (2) Within 4 days after the last day for filing nominating
- 13 petitions OR A NONREFUNDABLE FILING FEE, the township clerk shall
- 14 deliver to the county clerk a list setting forth the name, address,
- 15 and political affiliation and office sought of each candidate who
- 16 has qualified for a position on the primary ballot.
- 17 Enacting section 1. This amendatory act takes effect 90 days
- 18 after the date it is enacted into law.
- 19 Enacting section 2. This amendatory act does not take effect
- 20 unless all of the following bills of the 99th Legislature are
