

**SUBSTITUTE FOR  
HOUSE BILL NO. 5045**

A bill to amend 2008 PA 23, entitled  
"Enhanced driver license and enhanced official state personal  
identification card act,"  
by amending section 4 (MCL 28.304).

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 4. (1) The secretary of state may issue an enhanced  
2 driver's license or enhanced official state personal identification  
3 card to an applicant who provides satisfactory proof of his or her  
4 full legal name, United States citizenship, identity, date of  
5 birth, ~~social security~~ **SOCIAL SECURITY** number, residence address,  
6 and a photographic identity document. An applicant may choose to  
7 apply for a standard driver license or standard official state  
8 personal identification card or an enhanced driver license or  
9 enhanced state personal identification card.  
10       (2) An enhanced driver license or enhanced official state

1 personal identification card shall include reasonable security  
2 measures to protect against unauthorized disclosure of personal  
3 information regarding residents of this state that is contained in  
4 the enhanced driver license or enhanced official state personal  
5 identification card.

6 (3) An enhanced driver license or enhanced official state  
7 personal identification card may include radio frequency  
8 identification technology that is limited to a randomly assigned  
9 number, which shall be encrypted if agreed to by the ~~department of~~  
10 ~~homeland security,~~ **DEPARTMENT OF HOMELAND SECURITY**, and does not  
11 include biometric data. The secretary of state shall ensure that  
12 the radio frequency identification technology is secure from  
13 unauthorized data access and includes reasonable security measures  
14 to protect against unauthorized disclosure of personal information.  
15 An applicant ~~shall be required to~~ **MUST** sign a declaration  
16 acknowledging his or her understanding of the radio frequency  
17 identification technology before he or she is issued an enhanced  
18 driver license or enhanced official state personal identification  
19 card.

20 (4) The requirements of this act are in addition to the  
21 requirements otherwise imposed on individuals who apply for a  
22 standard driver license or standard official state personal  
23 identification card.

24 (5) The holder of an enhanced driver license issued under this  
25 act is subject to every licensing sanction provided under the  
26 Michigan vehicle code, 1949 PA 300, MCL 257.1 to 257.923. As used  
27 in this subsection, "licensing sanction" means the restriction,

1 suspension, revocation, or denial of a driver license; the addition  
2 of points to a driving record; **UNTIL OCTOBER 1, 2018**, the  
3 assessment of a driver responsibility fee; the assessment of a  
4 civil fine or criminal penalty resulting from a conviction; a civil  
5 infraction determination; the imposition of probationary terms and  
6 conditions; or any other penalty provided under the Michigan  
7 vehicle code, 1949 PA 300, MCL 257.1 to 257.923.
