HOUSE BILL NO. 5046

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 304 (MCL 257.304), as amended by 2016 PA 32.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 304. (1) Except as provided in subsection (3), the
- 2 secretary of state shall issue a restricted license to a person
- 3 whose license was suspended or restricted under section 319 or
- 4 revoked or denied under section 303 based on either of the
- 5 following:
- **6** (a) Two or more convictions for violating section 625(1) or
- 7 (3) or a local ordinance of this state substantially corresponding
- 8 to section 625(1) or (3).
- **9** (b) One conviction for violating section 625(1) or (3) or a
- 10 local ordinance of this state substantially corresponding to

- 1 section 625(1) or (3), preceded by 1 or more convictions for
- 2 violating a local ordinance or law of another state substantially
- 3 corresponding to section 625(1), (3), or (6), or a law of the
- 4 United States substantially corresponding to section 625(1), (3),
- **5** or (6).
- 6 (2) A restricted license issued under subsection (1) shall not
- 7 be issued until after the person's operator's or chauffeur's
- 8 license has been suspended or revoked for 45 days and the judge
- 9 assigned to a DWI/sobriety court certifies to the secretary of
- 10 state that both of the following conditions have been met:
- 11 (a) The person has been admitted into a DWI/sobriety court
- 12 program.
- 13 (b) An ignition interlock device approved, certified, and
- 14 installed as required under sections 625k and 625l has been
- 15 installed on each motor vehicle owned or operated, or both, by the
- 16 individual.
- 17 (3) A restricted license shall not be issued under subsection
- 18 (1) if the person is otherwise ineligible for an operator's or
- 19 chauffeur's license under this act, unless the person's
- 20 ineligibility is based on 1 or more of the following:
- 21 (a) Section 303(1)(i) or (l).
- 22 (b) Section 303(2)(c)(i) or (iii).
- 23 (c) Section 303(2)(g)(i) or (iii).
- 24 (d) Section 319(4), (5), (6), (7), (8)(a) to (e), or (9).
- **25** (e) Section 319e(2)(a) or (b).
- **26** (f) Section 320(1)(d).
- **27** (g) Section 321a(1), (2), or (3).

- 1 (h) Section 323c.
- **2** (i) Section 625f.
- 3 (j) Section 732a(5).
- **4** (k) Section 904(10).
- (l) Section 82105a(2) of the natural resources and
- 6 environmental protection act, 1994 PA 451, MCL 324.82105a.
- 7 (m) Section 3177 of the insurance code of 1956, 1956 PA 218,
- **8** MCL 500.3177.
- 9 (n) Section 10 of the motor vehicle claims act, 1965 PA 198,
- **10** MCL 257.1110.
- 11 (4) A restricted license issued under subsection (1) permits
- 12 the person to whom it is issued to operate only the vehicle
- 13 equipped with an ignition interlock device described in subsection
- 14 (2) (b), to take any driving skills test required by the secretary
- 15 of state, and to drive to and from any combination of the following
- 16 locations or events:
- 17 (a) In the course of the person's employment or occupation if
- 18 the employment or occupation does not require a commercial driver
- 19 license.
- 20 (b) To and from any combination of the following:
- 21 (i) The person's residence.
- 22 (ii) The person's work location.
- 23 (iii) An alcohol, drug, or mental health education and
- 24 treatment as ordered by the court.
- 25 (iv) Alcoholics anonymous, narcotics anonymous, ANONYMOUS,
- 26 NARCOTICS ANONYMOUS, or other court-ordered self-help programs.
- (v) Court hearings and probation appointments.

- 1 (vi) Court-ordered community service.
- (vii) An educational institution at which the person is
- 3 enrolled as a student.
- 4 (viii) A place of regularly occurring medical treatment for a
- 5 serious condition or medical emergency for the person or a member
- 6 of the person's household or immediate family.
- 7 (ix) Alcohol or drug testing as ordered by the court.
- 8 (x) Ignition interlock service provider as required.
- **9** (5) While driving with a restricted license, the person shall
- 10 carry proof of his or her destination and the hours of any
- 11 employment, class, or other reason for traveling and shall display
- 12 that proof upon a peace officer's request.
- 13 (6) Except as otherwise provided in this section, a restricted
- 14 license issued under subsection (1) is effective until a hearing
- 15 officer orders an unrestricted license under section 322. Subject
- 16 to subsection (7), the hearing officer shall not order an
- 17 unrestricted license until the later of the following events
- 18 occurs:
- 19 (a) The court notifies the secretary of state that the person
- 20 has successfully completed the DWI/sobriety court program.
- 21 (b) The minimum period of license sanction that would have
- 22 been imposed under section 303 or 319 but for this section has been
- 23 completed.
- 24 (c) The person demonstrates that he or she has operated with
- 25 an ignition interlock device for not less than 1 year.
- 26 (d) The person satisfies the requirements of section 303 and R
- 27 257.313 of the Michigan administrative code. ADMINISTRATIVE CODE.

- 1 (7) A hearing officer shall not issue an unrestricted license
- 2 for at least 1 year if either of the following applies:
- 3 (a) The hearing officer determines that the person consumed
- 4 any alcohol during the period that his or her license was
- 5 restricted under this section, as determined by breath, blood,
- 6 urine, or transdermal testing unless a second test, administered
- 7 within 5 minutes after administering the first test, showed an
- 8 absence of alcohol.
- **9** (b) The hearing officer determines that the person consumed or
- 10 otherwise used any controlled substance during the period that his
- 11 or her license was restricted under this section, except as
- 12 lawfully prescribed.
- 13 (8) In determining whether to order an unrestricted license
- 14 under subsection (6), the successful completion of the DWI/sobriety
- 15 court program and a certificate from the DWI/sobriety court judge
- 16 shall be considered positive evidence of the petitioner's
- 17 abstinence while the petitioner participated in the DWI/sobriety
- 18 court program. This subsection does not apply to a determination
- 19 made under subsection (7). As used in this subsection,
- 20 "certificate" includes, but is not limited to, a statement that the
- 21 participant has maintained a period of abstinence from alcohol for
- 22 not less than 6 months at the time the participant completed the
- 23 DWI/sobriety court program.
- 24 (9) If the secretary of state receives a notification from the
- 25 DWI/sobriety court under section 1084(6) of the revised judicature
- 26 act of 1961, 1961 PA 236, MCL 600.1084, the secretary of state
- 27 shall summarily impose 1 of the following license sanctions, as

- 1 applicable:
- 2 (a) Suspension for the full length of time provided under
- 3 section 319(8). However, a restricted license shall not be issued
- 4 as provided under section 319(8). This subdivision applies if the
- 5 underlying conviction or convictions would have subjected the
- 6 person to a license sanction under section 319(8) if this section
- 7 did not apply.
- 8 (b) A license revocation and denial for the full length of
- 9 time provided under section 303. The minimum period of license
- 10 revocation and denial imposed shall be the same as if this section
- 11 did not apply. This subdivision applies if the underlying
- 12 conviction or convictions would have caused a license revocation
- 13 and denial under section 303 if this section did not apply.
- 14 (10) After the person completes the DWI/sobriety court
- 15 program, the following apply:
- 16 (a) The secretary of state shall postpone considering the
- 17 issuance of an unrestricted license under section 322 for a period
- 18 of 3 months for each act that would be a minor violation if the
- 19 person's license had been issued under section 322(6). As used in
- 20 this subdivision, "minor violation" means that term as defined in R
- 21 257.301a of the Michigan administrative code. ADMINISTRATIVE CODE.
- 22 (b) The restricted license issued under this section shall be
- 23 suspended or revoked or denied as provided in subsection (9),
- 24 unless set aside under section 322(5), if any of the following
- 25 events occur:
- 26 (i) The person operates a motor vehicle without an ignition
- 27 interlock device that meets the criteria under subsection (2)(b).

- $\mathbf{1}$ (ii) The person removes, or causes to be removed, an ignition
- 2 interlock device from a vehicle he or she owns or operates unless
- 3 the secretary of state has authorized its removal under section
- **4** 322a.
- 5 (iii) The person commits any other act that would be a major
- 6 violation if the person's license had been issued under section
- 7 322(6). As used in this subparagraph, "major violation" means that
- 8 term as defined in R 257.301a of the Michigan administrative
- 9 code. ADMINISTRATIVE CODE.
- 10 (iv) The person is arrested for a violation of any of the
- 11 following:
- 12 (A) Section 625.
- 13 (B) A local ordinance of this state or another state
- 14 substantially corresponding to section 625.
- 15 (C) A law of the United States substantially corresponding to
- **16** section 625.
- 17 (c) If the person is convicted of or found responsible for any
- 18 offense that requires the suspension, revocation, denial, or
- 19 cancellation of the person's operator's or chauffeur's license, the
- 20 restricted license issued under this section shall be suspended
- 21 until the requisite period of license suspension, revocation,
- 22 denial, or cancellation, as appropriate, has elapsed.
- 23 (d) If the person has failed to pay any court-ordered fines or
- 24 costs that resulted from the operation of a vehicle, the restricted
- 25 license issued under this section shall be suspended pending
- 26 payment of those fines and costs.
- 27 (11) All driver responsibility fees required to be assessed by

- 1 the secretary of state under section 732a for the conviction or
- 2 convictions that led to the restricted license under this section
- 3 shall be held in abeyance as follows:
- 4 (a) The fees shall be held in abeyance during the time the
- 5 person has a restricted license under this section and is
- 6 participating in the DWI/sobriety court program.
- 7 (b) At EXCEPT AS OTHERWISE PROVIDED IN THIS SUBDIVISION, AT
- 8 the end of the person's participation in the DWI/sobriety court
- 9 program, the driver responsibility fees shall be assessed and paid
- 10 under the payment schedule described in section 732a. IF THE
- 11 PERSON'S PARTICIPATION IN THE DWI/SOBRIETY COURT PROGRAM IS
- 12 COMPLETED ON OR AFTER OCTOBER 1, 2018, THE DRIVER RESPONSIBILITY
- 13 FEES ARE WAIVED AND SHALL NOT BE COLLECTED.
- 14 (12) The vehicle of an individual admitted to the DWI/sobriety
- 15 court program whose vehicle would otherwise be subject to
- 16 immobilization or forfeiture under this act is exempt from both
- 17 immobilization and forfeiture under sections 625n and 904d if both
- 18 of the following apply:
- 19 (a) The person is a DWI/sobriety court program participant in
- 20 good standing or the person successfully satisfactorily completes
- 21 the DWI/sobriety court program.
- 22 (b) The person does not subsequently violate a law of this
- 23 state for which vehicle immobilization or forfeiture is a sanction.
- 24 (13) This section only applies to individuals arrested for a
- 25 violation of section 625 on or after January 1, 2011.
- 26 (14) As used in this section:
- 27 (a) "DWI/sobriety court" means that term as defined in section

- 1 1084 of the revised judicature act of 1961, 1961 PA 236, MCL
- 2 600.1084.
- (b) "DWI/sobriety court program" means "program" as that term 3
- is defined in section 1084 of the revised judicature act of 1961,
- 1961 PA 236, MCL 600.1084. 5
