SUBSTITUTE FOR HOUSE BILL NO. 5257

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 409b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 409B. (1) A PERSON SHALL NOT KNOWINGLY POSSESS RANSOMWARE
- 2 WITH THE INTENT TO USE OR EMPLOY THAT RANSOMWARE FOR THE PURPOSE OF
- 3 INTRODUCTION INTO THE COMPUTER, COMPUTER DATA, COMPUTER SYSTEM, OR
- 4 COMPUTER NETWORK OF ANOTHER PERSON, WITHOUT AUTHORIZATION OF THE
- 5 OTHER PERSON. A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A
- 6 FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 3 YEARS.
- 7 (2) AS USED IN THIS SECTION, "RANSOMWARE" MEANS A COMPUTER OR
- 8 DATA CONTAMINANT, ENCRYPTION, OR LOCK THAT HAS THE ABILITY TO BE
- 9 PLACED OR INTRODUCED WITHOUT AUTHORIZATION INTO A COMPUTER,

- COMPUTER SYSTEM, OR COMPUTER NETWORK AND THAT RESTRICTS ACCESS BY 1
- 2 AN AUTHORIZED PERSON TO A COMPUTER, COMPUTER DATA, COMPUTER SYSTEM,
- OR COMPUTER NETWORK IN A MANNER THAT ENABLES THE PERSON RESPONSIBLE 3
- FOR THE PLACEMENT OR INTRODUCTION OF THE RANSOMWARE TO DEMAND
- PAYMENT OF MONEY OR OTHER CONSIDERATION TO REMOVE THE COMPUTER 5
- CONTAMINANT, RESTORE ACCESS TO THE COMPUTER, COMPUTER SYSTEM,
- COMPUTER NETWORK, OR DATA, OR OTHERWISE REMEDIATE THE IMPACT OF THE 7
- COMPUTER CONTAMINANT OR LOCK. RANSOMWARE DOES NOT INCLUDE 8
- 9 AUTHENTICATION REQUIRED TO UPGRADE OR ACCESS PURCHASED CONTENT.
- 10 Enacting section 1. This amendatory act takes effect 90 days
- 11 after the date it is enacted into law.
