## HOUSE SUBSTITUTE FOR SENATE BILL NO. 22

A bill to amend 1953 PA 232, entitled "Corrections code of 1953,"

(MCL 791.201 to 791.285) by adding section 62d.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 62D. (1) THE DEPARTMENT SHALL DEVELOP REHABILITATION
- 2 PLANS FOR PRISONERS IN THE CUSTODY OF THE DEPARTMENT WHO ARE
- 3 APPROXIMATELY 18 TO 22 YEARS OF AGE THAT SPECIFICALLY TAKE THE
- 4 PRISONER'S AGE INTO CONSIDERATION.
- 5 (2) THE DEPARTMENT SHALL PROVIDE, TO THE EXTENT IT IS ABLE TO
- 6 DO SO, PROGRAMMING DESIGNED FOR YOUTH REHABILITATION FOR PRISONERS
- 7 IN THE CUSTODY OF THE DEPARTMENT WHO ARE APPROXIMATELY 18 TO 22
- 8 YEARS OF AGE. THE DEPARTMENT SHALL CONSULT WITH THE ADMINISTRATORS
- 9 OF THE FAMILY DIVISIONS OF THE CIRCUIT COURTS IN THIS STATE AND
- 10 SEEK RECOMMENDATIONS REGARDING THE SELECTION OF PROGRAMMING

- 1 DESIGNED FOR YOUTH REHABILITATION.
- 2 (3) THE PROGRAMMING UNDER SUBSECTION (2) MAY INCLUDE, BUT NOT
- 3 BE LIMITED TO, BOTH OF THE FOLLOWING:
- 4 (A) MENTORING PROGRAMS PROVIDED BY INDIVIDUALS WITH NO
- 5 MISDEMEANOR OR FELONY CONVICTIONS.
- 6 (B) CAREER SKILLS EVALUATION AND CAREER COUNSELING.
- 7 (4) THE DEPARTMENT SHALL SUBMIT AN ANNUAL REPORT TO THE SENATE
- 8 AND HOUSE COMMITTEES RESPONSIBLE FOR LEGISLATION CONCERNING
- 9 CORRECTIONS ISSUES DETAILING ALL OF THE FOLLOWING REGARDING
- 10 PRISONERS IN THE CUSTODY OF THE DEPARTMENT WHO ARE APPROXIMATELY 18
- 11 TO 22 YEARS OF AGE:
- 12 (A) THE NUMBER OF THESE PRISONERS WHO ARE IN THE CUSTODY OF
- 13 THE DEPARTMENT, AND THE SECURITY CLASSIFICATION AT WHICH EACH OF
- 14 THESE PRISONERS IS HOUSED.
- 15 (B) THE NUMBER OF THESE PRISONERS HOUSED AT EACH CORRECTIONAL
- 16 FACILITY IN THIS STATE.
- 17 (C) THE NUMBER, IF ANY, OF THESE PRISONERS WHO HAVE BEEN MOVED
- 18 FROM 1 CORRECTIONAL FACILITY TO ANOTHER IN A MANNER THAT
- 19 INTERRUPTED THE PRISONER'S PROGRAMMING.
- 20 (D) THE NUMBER OF THESE PRISONERS WHO HAVE COMPLETED
- 21 PROGRAMMING, AND IF SO, WHAT SPECIFIC PROGRAMMING WAS COMPLETED BY
- 22 THE PRISONERS.
- 23 (5) AS USED IN THIS SECTION, "CORRECTIONAL FACILITY" MEANS A
- 24 FACILITY OPERATED BY THE DEPARTMENT, OR BY A PRIVATE ENTITY UNDER
- 25 CONTRACT WITH THE DEPARTMENT, THAT HOUSES PRISONERS UNDER THE
- 26 JURISDICTION OF THE DEPARTMENT.
- 27 Enacting section 1. This amendatory act takes effect 90 days

1 after the date it is enacted into law.
