HOUSE SUBSTITUTE FOR SENATE BILL NO. 478

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 321a (MCL 257.321a), as amended by 2012 PA 13.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 321a. (1) A person who fails to answer a citation, or a
- 2 notice to appear in court for a violation reportable to the
- 3 secretary of state under section 732 or a local ordinance
- 4 substantially corresponding to a violation of a law of this state
- 5 reportable to the secretary of state under section 732, or for any
- 6 matter pending, or who fails to comply with an order or judgment of
- 7 the court, including, but not limited to, paying all fines, costs,
- 8 fees, and assessments, is guilty of a misdemeanor punishable by
- 9 imprisonment for not more than 93 days or a fine of not more than
- 10 \$100.00, or both. A violation of this subsection or failure to
- 11 answer a citation or notice to appear for a violation of section

- 1 33b(1) of former 1933 (Ex Sess) PA 8, section 703(1) of the
- 2 Michigan liquor control code of 1998, 1998 PA 58, MCL 436.1703, or
- 3 a local ordinance substantially corresponding to either of those
- 4 sections shall not be considered a violation for any purpose under
- 5 section 320a.
- 6 (2) Except as provided in subsection (3), 28 days or more
- 7 after a person fails to answer a citation, or a notice to appear in
- 8 court for a violation reportable to the secretary of state under
- 9 section 732 or a local ordinance substantially corresponding to a
- 10 violation of a law of this state reportable to the secretary of
- 11 state under section 732, or for any matter pending, or fails to
- 12 comply with an order or judgment of the court, including, but not
- 13 limited to, paying all fines, costs, fees, and assessments, the
- 14 court shall give notice by mail at the last known address of the
- 15 person that if the person fails to appear or fails to comply with
- 16 the order or judgment within 14 days after the notice is issued,
- 17 the secretary of state shall suspend the person's operator's or
- 18 chauffeur's license. If the person fails to appear or fails to
- 19 comply with the order or judgment within the 14-day period, the
- 20 court shall, within 14 days, inform the secretary of state, who
- 21 shall immediately suspend the license of the person. The secretary
- 22 of state shall immediately notify the person of the suspension by
- 23 regular mail at the person's last known address.
- 24 (3) If the person is charged with, or convicted of, a
- 25 violation of section 625 or a local ordinance substantially
- **26** corresponding to section 625(1), (2), (3), (6), or (8) and the
- 27 person fails to answer a citation or a notice to appear in court,

- 1 or for any matter pending, or fails to comply with an order or
- 2 judgment of the court, including, but not limited to, paying all
- 3 fines, costs, and crime victim rights assessments, the court shall
- 4 immediately give notice by first-class mail sent to the person's
- 5 last known address that if the person fails to appear within 7 days
- 6 after the notice is issued, or fails to comply with the order or
- 7 judgment of the court, including, but not limited to, paying all
- 8 fines, costs, and crime victim rights assessments, within 14 days
- 9 after the notice is issued, the secretary of state shall suspend
- 10 the person's operator's or chauffeur's license. If the person fails
- 11 to appear within the 7-day period, or fails to comply with the
- 12 order or judgment of the court, including, but not limited to,
- 13 paying all fines, costs, and crime victim rights assessments,
- 14 within the 14-day period, the court shall immediately inform the
- 15 secretary of state who shall immediately suspend the person's
- 16 operator's or chauffeur's license and notify the person of the
- 17 suspension by first-class mail sent to the person's last known
- 18 address.
- 19 (4) If the person is charged with, or convicted of, a
- 20 violation of section 33b(1) of former 1933 (Ex Sess) PA 8, section
- 21 703(1) of the Michigan liquor control code of 1998, 1998 PA 58, MCL
- **22** 436.1703, section 624a, section 624b, or a local ordinance
- 23 substantially corresponding to those sections and the person fails
- 24 to answer a citation or a notice to appear in court issued under
- 25 section 33b of former 1933 (Ex Sess) PA 8, section 703 of the
- 26 Michigan liquor control code of 1998, 1998 PA 58, MCL 436.1703,
- 27 section 624a, section 624b, or a local ordinance substantially

- 1 corresponding to those sections or fails to comply with an order or
- 2 judgment of the court issued under section 33b of former 1933 (Ex
- 3 Sess) PA 8, section 703 of the Michigan liquor control code of
- 4 1998, 1998 PA 58, MCL 436.1703, section 624a, section 624b, or a
- 5 local ordinance substantially corresponding to those sections
- 6 including, but not limited to, paying all fines and costs, the
- 7 court shall immediately give notice by first-class mail sent to the
- 8 person's last known address that if the person fails to appear
- 9 within 7 days after the notice is issued, or fails to comply with
- 10 the order or judgment of the court, including, but not limited to,
- 11 paying all fines and costs, within 14 days after the notice is
- 12 issued, the secretary of state shall suspend the person's
- 13 operator's or chauffeur's license. If the person fails to appear
- 14 within the 7-day period, or fails to comply with the order or
- 15 judgment of the court, including, but not limited to, paying all
- 16 fines and costs, within the 14-day period, the court shall
- 17 immediately inform the secretary of state who shall immediately
- 18 suspend the person's operator's or chauffeur's license and notify
- 19 the person of the suspension by first-class mail sent to the
- 20 person's last known address.
- 21 (5) A suspension imposed under subsection (2) or (3) remains
- 22 in effect until both of the following occur:
- 23 (a) The secretary of state is notified by each court in which
- 24 the person failed to answer a citation or notice to appear or
- 25 failed to pay a fine or cost that the person has answered that
- 26 citation or notice to appear or paid that fine or cost.
- 27 (b) The person has paid to the court a \$45.00 driver license

- 1 clearance fee for each failure to answer a citation or failure to
- 2 pay a fine or cost.
- 3 (6) The court shall not notify the secretary of state, and the
- 4 secretary of state shall not suspend the person's license, if the
- 5 person fails to appear in response to a citation issued for, or
- 6 fails to comply with an order or judgment involving 1 or more of
- 7 the following infractions:
- 8 (a) The parking or standing of a vehicle.
- 9 (b) A pedestrian, passenger, or bicycle violation, other than
- 10 a violation of section 33b(1) or (2) of former 1933 (Ex Sess) PA 8,
- 11 section 703(1) or (2) of the Michigan liquor control code of 1998,
- 12 1998 PA 58, MCL 436.1703, section 624a or 624b, or a local
- 13 ordinance substantially corresponding to section 33b(1) or (2) of
- 14 former 1933 (Ex Sess) PA 8, section 703(1) or (2) of the Michigan
- 15 liquor control code of 1998, 1998 PA 58, MCL 436.1703, or section
- **16** 624a or 624b.
- 17 (7) The court may notify a person who has done either of the
- 18 following, that if the person does not appear within 10 days after
- 19 the notice is issued, the court will inform the secretary of state
- 20 of the person's failure to appear:
- 21 (a) Failed to answer 2 or more parking violation notices or
- 22 citations for violating a provision of this act or an ordinance
- 23 substantially corresponding to a provision of this act pertaining
- 24 to parking for persons with disabilities.
- 25 (b) Failed to answer 3 or more parking violation notices or
- 26 citations regarding illegal parking. or, beginning January 1, 2018,
- 27 failed to answer 6 or more parking violation notices or citations

- 1 regarding illegal parking.
- 2 (8) The secretary of state, upon being informed of the failure
- 3 of a person to appear or comply as provided in subsection (7),
- 4 shall not issue a license to the person or renew a license for the
- 5 person until both of the following occur:
- **6** (a) The court informs the secretary of state that the person
- 7 has resolved all outstanding matters regarding the notices or
- 8 citations.
- 9 (b) The person has paid to the court a \$45.00 driver license
- 10 clearance fee. If the court determines that the person is
- 11 responsible for only 1 parking violation under subsection (7)(a) or
- 12 less FEWER than 3 parking violations under subsection (7)(b), or,
- 13 beginning January 1, 2018, less than 6 parking violations under
- 14 subsection (7) (b), for which the person's license was not issued or
- 15 renewed under this subsection, the court may waive payment of the
- **16** fee.
- 17 (9) Not less than 28 days after a person fails to appear in
- 18 response to a citation issued for, or fails to comply with an order
- 19 or judgment involving, a state civil infraction described in
- 20 chapter 88 of the revised judicature act of 1961, 1961 PA 236, MCL
- 21 600.8801 to 600.8835, the court shall give notice by ordinary mail,
- 22 addressed to the person's last known address, that if the person
- 23 fails to appear or fails to comply with the order or judgment
- 24 described in this subsection within 14 days after the notice is
- 25 issued, the court will give to the secretary of state notice of
- 26 that failure. Upon receiving notice of that failure, the secretary
- 27 of state shall not issue or renew an operator's or chauffeur's

- 1 license for the person until both of the following occur:
- 2 (a) The court informs the secretary of state that the person
- 3 has resolved all outstanding matters regarding each notice or
- 4 citation.
- **5** (b) The person has paid to the court a \$45.00 driver license
- 6 clearance fee. If the court determines that the person is not
- 7 responsible for any violation for which the person's license was
- 8 not issued or renewed under this subsection, the court shall waive
- 9 the fee.
- 10 (10) For the purposes of subsections (5) (a), (8) (a), and
- 11 (9)(a), the court shall give to the person a copy of the
- 12 information being transmitted to the secretary of state. Upon
- 13 showing that copy, the person shall not be arrested or issued a
- 14 citation for driving on a suspended license, on an expired license,
- 15 or without a license on the basis of any matter resolved under
- 16 subsection (5)(a), (8)(a), or (9)(a), even if the information being
- 17 sent to the secretary of state has not yet been received or
- 18 recorded by the department.
- 19 (11) For each fee received under subsection (5)(b), (8)(b), or
- 20 (9) (b), the court shall transmit the following amounts on a monthly
- 21 basis:
- 22 (a) Fifteen dollars to the secretary of state. The funds
- 23 received by the secretary of state under this subdivision shall be
- 24 deposited in the state general fund and shall be used to defray the
- 25 expenses of the secretary of state in processing the suspension and
- 26 reinstatement of driver licenses under this section.
- **27** (b) Fifteen dollars to 1 of the following, as applicable:

- $\mathbf{1}$ (i) If the matter is before the circuit court, to the
- 2 treasurer of the county for deposit in the general fund.
- (ii) If the matter is before the district court, to the
- 4 treasurer of the district funding unit for that court, for deposit
- 5 in the general fund. As used in this section, "district funding
- 6 unit" means that term as defined in section 8104 of the revised
- 7 judicature act of 1961, 1961 PA 236, MCL 600.8104.
- 8 (iii) If the matter is before a municipal court, to the
- 9 treasurer of the city in which the municipal court is located, for
- 10 deposit in the general fund.
- 11 (c) Fifteen dollars to the juror compensation reimbursement
- 12 fund created in section 151d of the revised judicature act of 1961,
- 13 1961 PA 236, MCL 600.151d.
- 14 (12) Section 819 does not apply to a reinstatement fee
- 15 collected for an operator's or chauffeur's license that is not
- 16 issued or renewed under section 8827 of the revised judicature act
- 17 of 1961, 1961 PA 236, MCL 600.8827.
- 18 (13) The secretary of state shall immediately suspend the
- 19 operator's and chauffeur's license of a person licensed to operate
- 20 a commercial motor vehicle, or a person who operates a commercial
- 21 motor vehicle without a license to operate that vehicle, if the
- 22 person fails to answer an out-state citation, or a notice to appear
- 23 in a court or an authorized administrative tribunal for a violation
- 24 reportable to the secretary of state under section 732, or fails to
- 25 comply with an order or judgment of an out-state court or an
- 26 authorized administrative tribunal reportable to the secretary of
- 27 state under section 732, or fails to appear or fails to comply with

- 1 the out-state court or an authorized administrative tribunal order
- 2 or judgment reportable to the secretary of state under section 732,
- 3 including, but not limited to, paying all fines, costs, fees, and
- 4 assessments. For a suspension imposed under this subsection, the
- 5 secretary of state shall immediately notify the person of the
- 6 suspension by regular mail at the person's last known address.
- 7 (14) A suspension imposed under subsection (13) remains in
- 8 effect until the secretary of state is notified by the court or
- 9 authorized administrative tribunal of the other state in which the
- 10 person failed to answer a citation, or notice to appear, or failed
- 11 to pay a fine or cost, that the person has answered that citation
- 12 or notice to appear or has paid the fine or cost.
- 13 (15) The secretary of state shall not suspend the person's
- 14 license under subsection (13) if the person fails to appear in
- 15 response to a citation issued for, or fails to comply with an order
- 16 or judgment involving, the parking or standing of a vehicle.
- 17 (16) The secretary of state, upon being informed of the
- 18 failure of a person to appear or comply as provided in subsection
- 19 (13), shall not issue a license to the person or renew a license
- 20 for the person until the court or authorized administrative
- 21 tribunal of the other state informs the secretary of state that the
- 22 person has resolved all outstanding matters regarding the notices,
- 23 orders, or citations.
