## HOUSE SUBSTITUTE FOR SENATE BILL NO. 548

A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1210.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1210. (1) FOR A SCHOOL DISTRICT, INTERMEDIATE SCHOOL
- 2 DISTRICT, OR PUBLIC SCHOOL ACADEMY TO BE ELIGIBLE TO RECEIVE FUNDS
- 3 FROM THE ENHANCED MICHIGAN EDUCATION SAVINGS ACCOUNTS UNDER THE
- 4 ENHANCED MICHIGAN EDUCATION SAVINGS PROGRAM ACT, PART 2 OF 2000 PA
- 5 161, MCL 390.1487 TO 390.1499, NOT LATER THAN MARCH 1, 2018 AND
- 6 THEREAFTER, AT LEAST 6 MONTHS BEFORE THE START OF EACH SCHOOL YEAR,
- 7 THE BOARD OF A SCHOOL DISTRICT OR INTERMEDIATE SCHOOL DISTRICT OR
- 8 BOARD OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY SHALL SUBMIT TO THE
- 9 DEPARTMENT AND THE DEPARTMENT OF TREASURY, IN THE FORM AND MANNER

- 1 PRESCRIBED BY THE DEPARTMENT AND THE DEPARTMENT OF TREASURY, ALL OF
- 2 THE FOLLOWING INFORMATION:
- 3 (A) A COMPLETE LISTING OF ALL SERVICES TO BE PROVIDED TO
- 4 PUPILS BY THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR
- 5 PUBLIC SCHOOL ACADEMY, BROKEN DOWN BY SUBJECT-SPECIFIC CORE
- 6 INSTRUCTIONAL COURSES AND SERVICES, NONCORE INSTRUCTIONAL COURSES
- 7 AND SERVICES, EXTRACURRICULAR ACTIVITIES, SUPPORT ACTIVITIES, COSTS
- 8 AND FEES, AND COURSE MATERIALS. THE BOARD OR BOARD OF DIRECTORS, OR
- 9 ITS DESIGNEE, SHALL MAP EACH OF THE SERVICES TO THE FUNDING SOURCES
- 10 FOR THE SERVICE.
- 11 (B) A BREAKDOWN OF THE DIRECT COSTS AND FULLY BURDENED COSTS
- 12 TO THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC
- 13 SCHOOL ACADEMY FOR PROVIDING EACH OF THE SERVICES LISTED IN
- 14 SUBDIVISION (A).
- 15 (C) ANY OTHER INFORMATION REQUESTED BY THE DEPARTMENT OF
- 16 TREASURY RELATED TO SERVICES PROVIDED TO PUPILS BY THE SCHOOL
- 17 DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY.
- 18 (2) THE DEPARTMENT AND A SCHOOL DISTRICT, INTERMEDIATE SCHOOL
- 19 DISTRICT, OR PUBLIC SCHOOL ACADEMY THAT IS ELIGIBLE TO RECEIVE
- 20 FUNDS FROM THE ENHANCED MICHIGAN EDUCATION SAVINGS ACCOUNTS UNDER
- 21 SUBSECTION (1) SHALL ENSURE THAT PARENTS HAVE ACCESS TO INFORMATION
- 22 ON THE DIRECT COSTS AND FULLY BURDENED COSTS OF EACH SERVICE.
- 23 (3) AT LEAST 6 MONTHS BEFORE THE START OF EACH SCHOOL YEAR, A
- 24 SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL
- 25 ACADEMY THAT IS ELIGIBLE TO RECEIVE FUNDS FROM THE ENHANCED
- 26 MICHIGAN EDUCATION SAVINGS ACCOUNTS UNDER SUBSECTION (1) SHALL
- 27 PROVIDE TO PARENTS CLEAR INFORMATION ON WHICH ELIGIBLE SERVICES ARE

- AVAILABLE FROM THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, 1
- 2 OR PUBLIC SCHOOL ACADEMY.
- (4) AS USED IN THIS SECTION, "ELIGIBLE SERVICE" MEANS A 3
- SERVICE THAT MAY BE PURCHASED USING AN ENHANCED MICHIGAN EDUCATION
- SAVINGS ACCOUNT, AS PRESCRIBED BY THE DEPARTMENT UNDER THE ENHANCED 5
- MICHIGAN EDUCATION SAVINGS PROGRAM ACT, PART 2 OF 2000 PA 161, MCL
- 390.1487 TO 390.1499. 7
