HOUSE SUBSTITUTE FOR SENATE BILL NO. 654

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding part 26.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 PART 26. ENVIRONMENTAL SCIENCE ADVISORY BOARD
- 2 SEC. 2601. AS USED IN THIS PART, "BOARD" MEANS THE
- 3 ENVIRONMENTAL SCIENCE BOARD CREATED IN SECTION 2603.
- 4 SEC. 2603. (1) THE ENVIRONMENTAL SCIENCE ADVISORY BOARD IS
- 5 CREATED IN THE DEPARTMENT OF TECHNOLOGY, MANAGEMENT, AND BUDGET.
- 6 (2) THE BOARD SHALL CONSIST OF 9 INDIVIDUALS APPOINTED BY THE
- 7 GOVERNOR WHO HAVE EXPERTISE IN 1 OR MORE OF THE FOLLOWING AREAS:
- 8 (A) ENGINEERING.
- 9 (B) ENVIRONMENTAL SCIENCE.
- 10 (C) ECONOMICS.

- 1 (D) CHEMISTRY.
- 2 (E) GEOLOGY.
- 3 (F) PHYSICS.
- 4 (G) BIOLOGY.
- 5 (H) HUMAN MEDICINE.
- 6 (I) STATISTICS.
- 7 (J) RISK ASSESSMENT.
- 8 (K) OTHER DISCIPLINES THAT THE GOVERNOR CONSIDERS APPROPRIATE.
- 9 (3) A CURRENT LEGISLATOR OR A CURRENT EMPLOYEE OF ANY OFFICE,
- 10 DEPARTMENT, OR AGENCY OF THIS STATE OR OF THE FEDERAL GOVERNMENT IS
- 11 NOT ELIGIBLE TO SERVE AS A MEMBER OF THE BOARD.
- 12 SEC. 2605. (1) A MEMBER OF THE BOARD SHALL SERVE FOR A TERM OF
- 13 3 YEARS, EXCEPT THAT OF THE MEMBERS FIRST APPOINTED, 3 SHALL SERVE
- 14 FOR A TERM OF 2 YEARS AND 3 SHALL SERVE FOR A TERM OF 1 YEAR.
- 15 (2) A MEMBER OF THE BOARD SERVES AT THE PLEASURE OF THE
- 16 GOVERNOR. THE GOVERNOR MAY REMOVE A MEMBER AT ANY TIME, WITH OR
- 17 WITHOUT CAUSE, AND WITH OR WITHOUT PRIOR NOTICE. THE GOVERNOR SHALL
- 18 FILL ANY VACANCIES ON THE BOARD.
- 19 (3) IF A VACANCY OCCURS ON THE BOARD, THE GOVERNOR SHALL MAKE
- 20 AN APPOINTMENT FOR THE UNEXPIRED TERM.
- 21 (4) THE GOVERNOR SHALL APPOINT A MEMBER OF THE BOARD AS
- 22 CHAIRPERSON. THE GOVERNOR MAY APPOINT OTHER MEMBERS OF THE BOARD TO
- 23 OTHER BOARD OFFICES. OFFICERS OF THE BOARD SERVE AT THE PLEASURE OF
- 24 THE GOVERNOR.
- 25 (5) MEMBERS OF THE BOARD SHALL SERVE WITHOUT COMPENSATION BUT
- 26 MAY BE REIMBURSED BY THIS STATE FOR ACTUAL AND NECESSARY EXPENSES
- 27 INCURRED IN THE PERFORMANCE OF THEIR OFFICIAL DUTIES AS MEMBERS.

- 1 (6) A MAJORITY OF THE MEMBERS OF THE BOARD CONSTITUTE A QUORUM
- 2 FOR THE TRANSACTION OF BUSINESS AT A MEETING OF THE BOARD. A
- 3 MAJORITY OF THE MEMBERS OF THE BOARD PRESENT AND SERVING ARE
- 4 REQUIRED FOR OFFICIAL ACTION OF THE BOARD.
- 5 (7) THE BUSINESS THAT THE BOARD MAY PERFORM SHALL BE CONDUCTED
- 6 AT A PUBLIC MEETING OF THE BOARD, RESPECTIVELY, HELD IN COMPLIANCE
- 7 WITH THE OPEN MEETINGS ACT, 1976 PA 267, MCL 15.261 TO 15.275.
- 8 (8) A WRITING PREPARED, OWNED, USED, IN THE POSSESSION OF, OR
- 9 RETAINED BY THE BOARD IN THE PERFORMANCE OF AN OFFICIAL FUNCTION IS
- 10 SUBJECT TO THE FREEDOM OF INFORMATION ACT, 1976 PA 442, MCL 15.231
- 11 TO 15.246.
- 12 (9) THE BOARD MAY ADOPT OPERATING PROCEDURES THAT ARE
- 13 CONSISTENT WITH THIS PART.
- 14 (10) THE BOARD MAY INCUR EXPENSES NECESSARY TO CARRY OUT ITS
- 15 DUTIES UNDER THIS PART.
- 16 SEC. 2607. IF REQUESTED BY THE BOARD, A DEPARTMENT, AGENCY, OR
- 17 OFFICE OF STATE GOVERNMENT MAY PROVIDE ADMINISTRATIVE, TECHNICAL,
- 18 OR LEGAL STAFF TO ASSIST THE BOARD IN THE PERFORMANCE OF ITS
- 19 DUTIES.
- 20 SEC. 2609. (1) THE BOARD SHALL ADVISE THE GOVERNOR AND ANY
- 21 STATE OFFICE, AGENCY, OR DEPARTMENT SPECIFIED BY THE GOVERNOR ON
- 22 ISSUES AFFECTING THE PROTECTION OF THE ENVIRONMENT OR THE
- 23 MANAGEMENT OF NATURAL RESOURCES OF THIS STATE. THE BOARD'S DUTY TO
- 24 PROVIDE ADVICE IS LIMITED TO THE SPECIFIC ADVICE REQUESTED FROM
- 25 TIME TO TIME BY THE GOVERNOR. ANY ADVICE PROVIDED BY THE BOARD IS
- 26 NOT LEGALLY BINDING ON OR ENFORCEABLE AGAINST ANY INDIVIDUAL,
- 27 GOVERNMENTAL ENTITY, PRIVATE ENTITY, OR OTHER PERSON.

- 1 (2) THE BOARD SHALL NOT REVIEW OR ADVISE ON ANY APPLICATION,
- 2 RECOMMENDATION, OR DECISION REGARDING A PERMIT, LICENSE, OR
- 3 ENVIRONMENTAL IMPACT STATEMENT.
- 4 (3) ADVICE PROVIDED BY THE BOARD SHALL BE BASED ON THE
- 5 FOLLOWING FACTORS:
- 6 (A) OBJECTIVE REASONING.
- 7 (B) SOUND SCIENCE.
- 8 (C) ALL OF THE FOLLOWING FACTORS TO THE EXTENT THE GOVERNOR
- 9 SPECIFIES IN THE REQUEST UNDER SECTION 2611 THAT THESE FACTORS ARE
- 10 RELEVANT TO THE DECISION FOR WHICH THE BOARD'S ADVICE IS SOUGHT:
- 11 (i) RELATIVE AND REALISTIC RISK TO HUMAN HEALTH AND THE
- 12 ENVIRONMENT.
- 13 (ii) ANALOGOUS PRACTICES USED OR POSITIONS TAKEN BY THE
- 14 FEDERAL GOVERNMENT AND REGULATORY BODIES IN OTHER STATES.
- 15 (iii) ECONOMIC REASONABLENESS.
- 16 (D) OTHER RELEVANT FACTORS AS SPECIFIED BY THE GOVERNOR IN THE
- 17 REQUEST.
- 18 SEC. 2611. (1) UPON RECEIPT OF A REQUEST FROM THE GOVERNOR TO
- 19 PROVIDE ADVICE ON A PARTICULAR ISSUE, THE CHAIRPERSON OF THE BOARD
- 20 SHALL CONVENE A COMMITTEE OF THE BOARD CONSISTING OF MEMBERS WITH
- 21 RELEVANT EXPERTISE. THE COMMITTEE SHALL DEVELOP A PLAN FOR
- 22 FORMULATING RECOMMENDATIONS AND MAKE RECOMMENDATIONS ON THE ISSUE
- 23 TO THE BOARD.
- 24 (2) THE BOARD SHALL DELIBERATE ON THE RECOMMENDATIONS MADE
- 25 UNDER SUBSECTION (1) AND PROVIDE WRITTEN ADVICE TO THE GOVERNOR
- 26 REGARDING THE GOVERNOR'S REQUEST.
- 27 (3) THE BOARD OR ANY COMMITTEE OF THE BOARD MAY MAKE

- INQUIRIES, DEVELOP STUDIES, HOLD HEARINGS, RECEIVE COMMENTS FROM 1
- 2 THE PUBLIC, AND CALL UPON EXPERTS WHO ARE NOT MEMBERS OF THE BOARD
- TO ASSIST THE BOARD IN ITS DELIBERATIONS UNDER THIS PART. 3
- 4 (4) ALL DEPARTMENTS, AGENCIES, OFFICES, OFFICERS, EMPLOYEES,
- OR CONTRACTORS OF THIS STATE, OR ANY POLITICAL SUBDIVISION OF THIS 5
- 6 STATE, MAY COOPERATE WITH THE BOARD OR ANY COMMITTEE OF THE BOARD,
- 7 INCLUDING, BUT NOT LIMITED TO, THE FOLLOWING AS REQUESTED BY THE
- BOARD OR A COMMITTEE OF THE BOARD: 8
- 9 (A) PARTICIPATING IN MEETINGS.
- 10 (B) PARTICIPATING IN INQUIRIES OR HEARINGS.
- 11 (C) PROVIDING ANY INFORMATION.
- 12 (D) PROVIDING ACCESS TO DOCUMENTS, BOOKS, RECORDS, DATABASES,
- OR OTHER INFORMATION. 13
- 14 (E) ANY OTHER ASSISTANCE REASONABLY NECESSARY AND RELATED TO
- THE BOARD'S DELIBERATIONS AND DUTIES UNDER THIS PART. 15
- 16 Enacting section 1. This amendatory act takes effect 90 days
- after the date it is enacted into law. 17
- 18 Enacting section 2. This amendatory act does not take effect
- 19 unless all of the following bills of the 99th Legislature are
