SUBSTITUTE FOR

SENATE BILL NO. 702

A bill to amend 2017 PA 98, entitled "Educational instruction access act," by amending section 5 (MCL 123.1045); and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 5. (1) Except as otherwise provided in this subsection, a
- 2 local governmental body shall not adopt, enforce, IMPOSE, or
- 3 administer an ordinance, local policy, or local resolution that
- 4 prohibits property sold, leased, or transferred by the local
- 5 governmental body from being used for any lawful educational
- 6 purpose by an educational institution or private school. This
- 7 subsection does not apply to either of the following:
- 8 (a) A zoning ordinance adopted by the local governmental body
- 9 under the Michigan zoning enabling act, 2006 PA 110, MCL 125.3101

- 1 to 125.3702.
- 2 (b) The administrative review of a site plan as provided in
- 3 section 1263(4) of the revised school code, 1976 PA 451, MCL
- 4 380.1263.
- 5 (2) A local governmental body shall not impose, ENFORCE, OR
- 6 APPLY any deed restriction that EXPRESSLY, OR BY ITS OPERATION,
- 7 prohibits property sold, leased, or transferred by the local
- 8 governmental body from being used for any lawful educational
- 9 purpose by an educational institution or private school. ANY DEED
- 10 RESTRICTION OR AFFIRMATIVE USE DEED RESTRICTION THAT AFFIRMATIVELY
- 11 ALLOWS FOR ONLY 1 OR MORE SPECIFIED USES OR PURPOSES THAT DO NOT
- 12 INCLUDE AN EDUCATIONAL USE OR PURPOSE IS PROHIBITED UNDER THIS
- 13 SUBSECTION. Any such—deed restriction OR AFFIRMATIVE USE DEED
- 14 RESTRICTION in effect on the effective date of this subsection THE
- 15 AMENDATORY ACT THAT AMENDED THIS SECTION THAT PROHIBITS OR DOES NOT
- 16 PERMIT PROPERTY PREVIOUSLY USED FOR AN EDUCATIONAL PURPOSE FROM
- 17 BEING USED FOR ANY FUTURE EDUCATIONAL PURPOSE is void.
- 18 (3) If a local governmental body offers property of the local
- 19 governmental body for sale, lease, or rent, the local governmental
- 20 body shall not refuse to sell, lease, or rent the property to an
- 21 educational institution or private school solely because the
- 22 educational institution or private school intends to use the
- 23 property for an educational purpose, if the intent of the
- 24 educational institution or private school is to use the property
- 25 for a lawful educational purpose. If a local governmental body
- 26 offers property of the local governmental body for sale, lease, or
- 27 rent, the local governmental body is not required to sell, lease,

- 1 or rent the property to an educational institution or private
- 2 school solely because the educational institution or private school
- 3 intends to use the property for an educational purpose. This
- 4 subsection does not require a local governmental body to do either
- 5 of the following:
- 6 (a) Provide special notice of property offers to an
- 7 educational institution or a private school.
- 8 (b) Provide a right of first refusal to an educational
- 9 institution or a private school.
- 10 Enacting section 1. Section 1260 of the revised school code,
- 11 1976 PA 451, MCL 380.1260, is repealed.
