SENATE BILL NO. 181

A bill to amend 1973 PA 116, entitled

"An act to provide for the protection of children through the licensing and regulation of child care organizations; to provide for the establishment of standards of care for child care organizations; to prescribe powers and duties of certain departments of this state and adoption facilitators; to provide penalties; and to repeal acts and parts of acts,"

- 2 (A) "CHILD CARE STAFF MEMBER" MEANS AN INDIVIDUAL WHO IS 18
- 3 YEARS OF AGE OR OLDER TO WHOM 1 OR MORE OF THE FOLLOWING APPLIES:
- 4 (i) THE INDIVIDUAL IS EMPLOYED BY A CHILD CARE CENTER, GROUP
- 5 CHILD CARE HOME, OR FAMILY CHILD CARE HOME FOR COMPENSATION,
- 6 INCLUDING A CONTRACT EMPLOYEE OR A SELF-EMPLOYED INDIVIDUAL.
- 7 (ii) AN INDIVIDUAL WHOSE ACTIVITIES INVOLVE THE UNSUPERVISED
- 8 CARE OR SUPERVISION OF CHILDREN FOR A CHILD CARE CENTER, GROUP
- 9 CHILD CARE HOME, OR FAMILY CHILD CARE HOME.
- 10 (iii) AN INDIVIDUAL WHO HAS UNSUPERVISED ACCESS TO CHILDREN
- 11 WHO ARE CARED FOR OR SUPERVISED BY A CHILD CARE CENTER, GROUP CHILD
- 12 CARE HOME, OR FAMILY CHILD CARE HOME.
- 13 (B) (a)—"Child care organization" means a governmental or

- 1 nongovernmental organization having as its principal function
- 2 receiving minor children for care, maintenance, training, and
- 3 supervision, notwithstanding that educational instruction may be
- 4 given. Child care organization includes organizations commonly
- 5 described as child caring institutions, child placing agencies,
- 6 children's camps, children's campsites, children's therapeutic
- 7 group homes, child care centers, day care centers, nursery schools,
- 8 parent cooperative preschools, foster homes, group homes, or child
- 9 care homes. Child care organization does not include a governmental
- 10 or nongovernmental organization that does either of the following:
- 11 (i) Provides care exclusively to minors who have been
- 12 emancipated by court order under section 4(3) of 1968 PA 293, MCL
- **13** 722.4.
- 14 (ii) Provides care exclusively to persons who are 18 years of
- 15 age or older and to minors who have been emancipated by court order
- 16 under section 4(3) of 1968 PA 293, MCL 722.4, at the same location.
- 17 (C) (b)—"Child caring institution" means a child care facility
- 18 that is organized for the purpose of receiving minor children for
- 19 care, maintenance, and supervision, usually on a 24-hour basis, in
- 20 buildings maintained by the child caring institution for that
- 21 purpose, and operates throughout the year. An educational program
- 22 may be provided, but the educational program shall not be the
- 23 primary purpose of the facility. Child caring institution includes
- 24 a maternity home for the care of unmarried mothers who are minors
- 25 and an agency group home, that is described as a small child caring
- 26 institution, owned, leased, or rented by a licensed agency
- 27 providing care for more than 4 but less than 13 minor children.

- 1 Child caring institution also includes institutions for
- 2 developmentally disabled or emotionally disturbed minor children.
- 3 Child caring institution does not include a hospital, nursing home,
- 4 or home for the aged licensed under article 17 of the public health
- 5 code, 1978 PA 368, MCL 333.20101 to 333.22260, a boarding school
- 6 licensed under section 1335 of the revised school code, 1976 PA
- 7 451, MCL 380.1335, a hospital or facility operated by the state or
- 8 licensed under the mental health code, 1974 PA 258, MCL 330.1001 to
- 9 330.2106, or an adult foster care family home or an adult foster
- 10 care small group home licensed under the adult foster care facility
- 11 licensing act, 1979 PA 218, MCL 400.701 to 400.737, in which a
- 12 child has been placed under section 5(6).
- (D) (c) "Child placing agency" means a governmental
- 14 organization or an agency organized under the nonprofit corporation
- 15 act, 1982 PA 162, MCL 450.2101 to 450.3192, for the purpose of
- 16 receiving children for placement in private family homes for foster
- 17 care or for adoption. The function of a child placing agency may
- 18 include investigating applicants for adoption and investigating and
- 19 certifying foster family homes and foster family group homes as
- 20 provided in this act. The function of a child placing agency may
- 21 also include supervising children who are at least 16 but less than
- 22 21 years of age and who are living in unlicensed residences as
- provided in section 5(4).
- 24 (E) (d) "Children's camp" means a residential, day, troop, or
- 25 travel camp that provides care and supervision and is conducted in
- 26 a natural environment for more than 4 children, apart from the
- 27 children's parents, relatives, or legal guardians, for 5 or more

- 1 days in a 14-day period.
- 2 (F) (e)—"Children's campsite" means the outdoor setting where
- 3 a children's residential or day camp is located.
- 4 (G) (f)—"Children's therapeutic group home" means a child
- 5 caring institution receiving not more than 6 minor children who are
- 6 diagnosed with a developmental disability as defined in section
- 7 100a of the mental health code, 1974 PA 258, MCL 330.1100a, or a
- 8 serious emotional disturbance as defined in section 100d of the
- 9 mental health code, 1974 PA 258, MCL 330.1100d, and that meets all
- 10 of the following requirements:
- 11 (i) Provides care, maintenance, and supervision, usually on a
- 12 24-hour basis.
- 13 (ii) Complies with the rules for child caring institutions,
- 14 except that behavior management rooms, personal restraint,
- 15 mechanical restraint, or seclusion, which is allowed in certain
- 16 circumstances under licensing rules, are prohibited in a children's
- 17 therapeutic group home.
- 18 (iii) Is not a private home.
- 19 (iv) Is not located on a campus with other licensed
- 20 facilities.
- 21 (H) (g) "Child care center" or "day care center" means a
- 22 facility, other than a private residence, receiving 1 or more
- 23 preschool or school age children UNDER 13 YEARS OF AGE for care for
- 24 periods of less than 24 hours a day, where the parents or guardians
- 25 are not immediately available to the child. Child care center or
- 26 day care center includes a facility that provides care for not less
- 27 than 2 consecutive weeks, regardless of the number of hours of care

- 1 per day. The facility is generally described as a child care
- 2 center, day care center, day nursery, nursery school, parent
- 3 cooperative preschool, play group, before- or after-school program,
- 4 or drop-in center. Child care center or day care center does not
- 5 include any of the following:
- 6 (i) A Sunday school, a vacation bible school, or a religious
- 7 instructional class that is conducted by a religious organization
- 8 where children are attending for not more than 3 hours per day for
- 9 an indefinite period or for not more than 8 hours per day for a
- 10 period not to exceed 4 weeks during a 12-month period.
- 11 (ii) A facility operated by a religious organization where
- 12 children are in the religious organization's care for not more than
- 13 3 hours while persons responsible for the children are attending
- 14 religious services.
- 15 (iii) A program that is primarily supervised, school-age-
- 16 child-focused training in a specific subject, including, but not
- 17 limited to, dancing, drama, music, or religion. This exclusion
- 18 applies only to the time a child is involved in supervised, school-
- 19 age-child-focused training.
- 20 (iv) A program that is primarily an incident of group athletic
- 21 or social activities for school-age children sponsored by or under
- 22 the supervision of an organized club or hobby group, including, but
- 23 not limited to, youth clubs, scouting, and school-age recreational
- 24 or supplementary education programs. This exclusion applies only to
- 25 the time the school-age child is engaged in the group athletic or
- 26 social activities and if the school-age child can come and go at
- 27 will.

- 1 (v) A PROGRAM THAT PRIMARILY PROVIDES THERAPEUTIC SERVICES TO
- 2 A CHILD.
- 3 (I) "CONVICTION" MEANS A FINAL CONVICTION, THE PAYMENT OF A
- 4 FINE, A PLEA OF GUILTY OR NOLO CONTENDERE IF ACCEPTED BY THE COURT,
- 5 A FINDING OF GUILT FOR A CRIMINAL LAW VIOLATION OR A JUVENILE
- 6 ADJUDICATION OR DISPOSITION BY THE JUVENILE DIVISION OF PROBATE
- 7 COURT OR FAMILY DIVISION OF CIRCUIT COURT FOR A VIOLATION THAT IF
- 8 COMMITTED BY AN ADULT WOULD BE A CRIME, OR A CONVICTION IN A TRIBAL
- 9 COURT OR A MILITARY COURT.
- 10 (J) "CRIMINAL HISTORY CHECK" MEANS A FINGERPRINT-BASED
- 11 CRIMINAL HISTORY RECORD INFORMATION BACKGROUND CHECK THROUGH THE
- 12 DEPARTMENT OF STATE POLICE AND THE FEDERAL BUREAU OF INVESTIGATION.
- 13 (K) "CRIMINAL HISTORY RECORD INFORMATION" MEANS THAT TERM AS
- 14 DEFINED IN SECTION 1A OF 1925 PA 289, MCL 28.241A.
- 15 (1) (h) "Department" means the department of **HEALTH AND** human
- 16 services AND THE DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS or
- 17 a successor agency or department responsible for licensure and
- 18 registration under this act. THE DEPARTMENT OF LICENSING AND
- 19 REGULATORY AFFAIRS IS RESPONSIBLE FOR LICENSING AND REGULATORY
- 20 MATTERS FOR CHILD CARE CENTERS, GROUP CHILD CARE HOMES, FAMILY
- 21 CHILD CARE HOMES, CHILDREN'S CAMPS, AND CHILDREN'S CAMPSITES. THE
- 22 DEPARTMENT OF HEALTH AND HUMAN SERVICES IS RESPONSIBLE FOR
- 23 LICENSING AND REGULATORY MATTERS FOR CHILD CARING INSTITUTIONS,
- 24 CHILD PLACING AGENCIES, CHILDREN'S THERAPEUTIC GROUP HOMES, FOSTER
- 25 FAMILY HOMES, AND FOSTER FAMILY GROUP HOMES.
- 26 (M) "ELIGIBLE" MEANS THAT THE INDIVIDUAL OBTAINED THE CHECKS
- 27 AND CLEARANCES DESCRIBED IN SECTIONS 5N AND 5Q AND IS CONSIDERED

- 1 APPROPRIATE TO OBTAIN A LICENSE, TO BE A MEMBER OF THE HOUSEHOLD OF
- 2 A GROUP CHILD CARE HOME OR FAMILY CHILD CARE HOME, OR TO BE A CHILD
- 3 CARE STAFF MEMBER.
- 4 (N) "INELIGIBLE" MEANS THAT THE INDIVIDUAL OBTAINED THE CHECKS
- 5 AND CLEARANCES AS DESCRIBED IN SECTIONS 5N AND 5Q AND IS NOT
- 6 CONSIDERED APPROPRIATE TO OBTAIN A LICENSE, TO BE A MEMBER OF THE
- 7 HOUSEHOLD OF A GROUP CHILD CARE HOME OR FAMILY CHILD CARE HOME, OR
- 8 TO BE A CHILD CARE STAFF MEMBER DUE TO VIOLATION OF SECTION 5N, 5Q,
- 9 OR 5R.
- 10 (0) (i) "Private home" means a private residence in which the
- 11 licensee or registrant permanently resides, as a member of the
- 12 household, which residency is not contingent upon caring for
- 13 children or employment by a licensed or approved child placing
- 14 agency. Private home includes a full-time foster family home, a
- 15 full-time foster family group home, a group child care home, or a
- 16 family child care home, as follows:
- 17 (i) "Foster family home" means a private home in which 1 but
- 18 not more than 4 minor children, who are not related to an adult
- 19 member of the household by blood or marriage, or who are not placed
- 20 in the household under the Michigan adoption code, chapter X of the
- 21 probate code of 1939, 1939 PA 288, MCL 710.21 to 710.70, are given
- 22 care and supervision for 24 hours a day, for 4 or more days a week,
- 23 for 2 or more consecutive weeks, unattended by a parent, legal
- 24 quardian, or legal custodian.
- 25 (ii) "Foster family group home" means a private home in which
- 26 more than 4 but fewer than 7 minor children, who are not related to
- 27 an adult member of the household by blood or marriage, or who are

- 1 not placed in the household under the Michigan adoption code,
- 2 chapter X of the probate code of 1939, 1939 PA 288, MCL 710.21 to
- 3 710.70, are provided care for 24 hours a day, for 4 or more days a
- 4 week, for 2 or more consecutive weeks, unattended by a parent,
- 5 legal guardian, or legal custodian.
- 6 (iii) "Family child care home" means a private home in which 1
- 7 but fewer than 7 minor children are received for care and
- 8 supervision for compensation for periods of less than 24 hours a
- 9 day, unattended by a parent or legal guardian, except children
- 10 related to an adult member of the family HOUSEHOLD by blood,
- 11 marriage, or adoption. Family child care home includes a home in
- 12 which care is given to an unrelated minor child for more than 4
- 13 weeks during a calendar year. A family child care home does not
- 14 include an individual providing babysitting services for another
- 15 individual. As used in this subparagraph, "providing babysitting
- 16 services" means caring for a child on behalf of the child's parent
- 17 or guardian when the annual compensation for providing those
- 18 services does not equal or exceed \$600.00 or an amount that would
- 19 according to the internal revenue code of 1986 obligate the child's
- 20 parent or guardian to provide a form 1099-MISC to the individual
- 21 for compensation paid during the calendar year for those services.
- 22 (iv) "Group child care home" means a private home in which
- 23 more than 6 but not more than 12 minor children are given care and
- 24 supervision for periods of less than 24 hours a day unattended by a
- 25 parent or legal guardian, except children related to an adult
- 26 member of the family HOUSEHOLD by blood, marriage, or adoption.
- 27 Group child care home includes a home in which care is given to an

- 1 unrelated minor child for more than 4 weeks during a calendar year.
- 2 (P) (j)—"Legal custodian" means an individual who is at least
- 3 18 years of age in whose care a minor child remains or is placed
- 4 after a court makes a finding under section 13a(5) of chapter XIIA
- 5 of the probate code of 1939, 1939 PA 288, MCL 712A.13a.
- 6 (Q) (k) "Licensee" means a person, partnership, firm,
- 7 corporation, association, nongovernmental organization, or local or
- 8 state government child care organization that has been issued a
- 9 license under this act to operate a child care organization.
- 10 (R) "LISTED OFFENSE" MEANS THAT TERM AS DEFINED IN SECTION 2
- 11 OF THE SEX OFFENDERS REGISTRATION ACT, 1994 PA 295, MCL 28.722.
- 12 (S) "MEMBER OF THE HOUSEHOLD" MEANS ANY INDIVIDUAL WHO RESIDES
- 13 IN A FAMILY CHILD CARE HOME, GROUP CHILD CARE HOME, FOSTER FAMILY
- 14 HOME, OR FOSTER FAMILY GROUP HOME ON AN ONGOING BASIS, OR WHO HAS A
- 15 RECURRENT PRESENCE IN THE HOME, INCLUDING, BUT NOT LIMITED TO,
- 16 OVERNIGHT STAYS. FOR FOSTER FAMILY HOMES AND FOSTER FAMILY GROUP
- 17 HOMES, A MEMBER OF THE HOUSEHOLD DOES NOT INCLUDE A FOSTER CHILD.
- 18 FOR GROUP CHILD CARE HOMES AND FAMILY CHILD CARE HOMES, A MEMBER OF
- 19 THE HOUSEHOLD DOES NOT INCLUDE A CHILD TO WHOM CHILD CARE IS BEING
- 20 PROVIDED.
- 21 (T) "ORIGINAL LICENSE" MEANS A LICENSE ISSUED TO A CHILD CARE
- 22 ORGANIZATION DURING THE FIRST 6 MONTHS OF OPERATION INDICATING THAT
- 23 THE ORGANIZATION IS IN COMPLIANCE WITH ALL RULES PROMULGATED BY THE
- 24 DEPARTMENT UNDER THIS ACT.
- 25 (U) (I)—"Provisional license" means a license issued to a
- 26 child care organization that is temporarily unable to conform to
- 27 all of the rules promulgated under this act.

- 1 (V) (m) "Regular license" means a license issued to a child
- 2 care organization indicating that the organization is in
- 3 SUBSTANTIAL compliance with all rules promulgated under this act
- 4 AND, IF THERE IS A DEFICIENCY, HAS ENTERED INTO A CORRECTIVE ACTION
- 5 PLAN.
- 6 (W) $\frac{(n)}{(n)}$ "Guardian" means the guardian of the person.
- 7 (X) (o) "Minor child" means any of the following:
- 8 (i) A person less than 18 years of age.
- 9 (ii) A person who is a resident in a child caring institution,
- 10 foster family home, or foster family group home, who is at least 18
- 11 but less than 21 years of age, and who meets the requirements of
- 12 the young adult voluntary foster care act, 2011 PA 225, MCL 400.641
- 13 TO 400.671.
- 14 (iii) A person who is a resident in a child caring
- 15 institution, children's camp, foster family home, or foster family
- 16 group home; who becomes 18 years of age while residing in a child
- 17 caring institution, children's camp, foster family home, or foster
- 18 family group home; and who continues residing in a child caring
- 19 institution, children's camp, foster family home, or foster family
- 20 group home to receive care, maintenance, training, and supervision.
- 21 A minor child under this subparagraph does not include a person 18
- 22 years of age or older who is placed in a child caring institution,
- 23 foster family home, or foster family group home under an
- 24 adjudication under section 2(a) of chapter XIIA of the probate code
- 25 of 1939, 1939 PA 288, MCL 712A.2, or under section 1 of chapter IX
- 26 of the code of criminal procedure, 1927 PA 175, MCL 769.1. This
- 27 subparagraph applies only if the number of those residents who

- 8 (iv) A person 18 years of age or older who is placed in an
- 9 unlicensed residence under section 5(4) or a foster family home
- 10 under section 5(7).
- 11 (p) "Registrant" means a person who has been issued a
- 12 certificate of registration under this act to operate a family
- 13 child care home.
- 14 (q) "Registration" means the process by which the department
- 15 regulates family child care homes, and includes the requirement
- 16 that a family child care home certify to the department that the
- 17 family child care home has complied with and will continue to
- 18 comply with the rules promulgated under this act.
- 19 (r) "Certificate of registration" means a written document
- 20 issued under this act to a family child care home through
- 21 registration.
- 22 (Y) (s) "Related" means in the relationship of parent,
- 23 grandparent, brother, sister, stepparent, stepsister, stepbrother,
- 24 uncle, aunt, cousin, great aunt, great uncle, or stepgrandparent by
- 25 marriage, blood, or adoption.BY BLOOD, MARRIAGE, OR ADOPTION, AS
- 26 PARENT, GRANDPARENT, GREAT-GRANDPARENT, GREAT-GRANDPARENT,
- 27 AUNT OR UNCLE, GREAT-AUNT OR GREAT-UNCLE, GREAT-GREAT-AUNT OR

- 1 GREAT-GREAT-UNCLE, SIBLING, STEPSIBLING, NEPHEW OR NIECE, FIRST
- 2 COUSIN OR FIRST COUSIN ONCE REMOVED, AND THE SPOUSE OF ANY OF THE
- 3 INDIVIDUALS DESCRIBED IN THIS DEFINITION, EVEN AFTER THE MARRIAGE
- 4 HAS ENDED BY DEATH OR DIVORCE.
- 5 (Z) (t)—"Religious organization" means a church,
- 6 ecclesiastical corporation, or group, not organized for pecuniary
- 7 profit, that gathers for mutual support and edification in piety or
- 8 worship of a supreme deity.
- 9 (AA) (u) "School-age child" means a child who is eligible to
- 10 be enrolled in ATTEND a grade of kindergarten or above, HIGHER, but
- 11 is less than 13 years of age. A CHILD IS CONSIDERED TO BE A SCHOOL-
- 12 AGE CHILD ON THE FIRST DAY OF THE SCHOOL YEAR IN WHICH HE OR SHE IS
- 13 ELIGIBLE TO ATTEND SCHOOL.
- 14 (BB) "SEVERE PHYSICAL INJURY" MEANS THAT TERM AS DEFINED IN
- 15 SECTION 8 OF THE CHILD PROTECTION LAW, 1975 PA 238, MCL 722.628.
- 16 (CC) (v) "Licensee designee" means the individual designated
- 17 in writing by the board of directors of the corporation or by the
- 18 owner or person with legal authority to act on behalf of the
- 19 company or organization on licensing matters. THE INDIVIDUAL MUST
- 20 AGREE IN WRITING TO BE DESIGNATED AS THE LICENSEE DESIGNEE. All
- 21 license applications must be signed by the licensee in the case of
- 22 the individual or by a member of the corporation, company, or
- 23 organization.
- 24 (2) A facility or program for school-age children that is
- 25 currently operated and has been in operation and licensed or
- 26 approved as provided in this act for a minimum of 2 years may apply
- 27 to the department to be exempt from inspections and on-site visits

- 1 required under section 5. The department shall respond to a
- 2 facility or program requesting exemption from inspections and on-

- 16 adopts a resolution supporting the application for exemption from
- 17 inspections and on-site visits required under section 5 as provided
- 18 for in this subsection.
- 19 (3) A facility or program granted exemption from inspections
- 20 and on-site visits required under section 5 as provided under
- 21 subsection (2) is required to maintain status as a licensed or
- 22 approved program under this act and must continue to meet the
- 23 requirements of this act, the rules promulgated under this act, or
- 24 the terms of a license or approval under this act. A facility or
- 25 program granted exemption from inspections and on site visits
- 26 required under section 5 as provided under subsection (2) is
- 27 subject to an investigation by the department if a violation of

- 3 (4) A facility or program granted exemption from inspections
- 4 and on-site visits required under section 5 as provided under

- 19 organizations covered by this act and for the promulgation of these

- 6 (7) An order for personal restraint or seclusion shall only be
- 7 written by a licensed practitioner.
- 8 (8) A licensed practitioner shall order the least restrictive
- 9 emergency safety intervention measure that is most likely to be
- 10 effective in resolving the emergency safety situation based on
- 11 consultation with staff. Consideration of less restrictive
- 12 emergency safety intervention measures shall be documented in the
- 13 minor child's record.
- 14 (9) If the order for personal restraint or seclusion is
- 15 verbal, it must be received by a child caring institution staff
- 16 member who is 1 of the following:
- 17 (a) A licensed practitioner.
- 18 (b) A social services supervisor. as described in R 400.4118
- 19 of the Michigan administrative code.
- 20 (c) A supervisor of direct care workers. as described in R
- 21 400.4120 of the Michigan administrative code.
- 22 (d) A practical nurse licensed under article 15 of the public
- 23 health code, 1978 PA 368, MCL 333.16101 to 333.18838.
- 24 (10) A verbal order must be received while personal restraint
- 25 or seclusion is being initiated by child caring institution staff
- 26 or immediately after the emergency safety situation begins. The
- 27 licensed practitioner shall be available to staff for consultation,

- 1 at least by telephone, throughout the period of personal restraint
- 2 or seclusion. The licensed practitioner shall verify the verbal
- 3 order in signed written form in the minor child's record.

- 1 (14) A face-to-face assessment shall be conducted if the

- 14 (d) A registered nurse licensed under article 15 of the public
- 15 health code, 1978 PA 368, MCL 333.16101 to 333.18838.
- 16 (15) The face-to-face assessment shall be conducted within 1
- 17 hour of the onset of the emergency safety intervention and
- 18 immediately after the minor child is removed from personal
- 19 restraint or seclusion. The face-to-face assessment of the physical
- 20 and psychological well-being of the minor child shall include, but
- 21 is not limited to, all of the following:
- 22 (a) The minor child's physical and psychological status.
- 23 (b) The minor child's behavior.
- 24 (c) The appropriateness of the intervention measures.
- 25 (d) Any complications resulting from the intervention.
- 26 (16) AS USED IN THIS SECTION:
- 27 (A) "SOCIAL SERVICES SUPERVISOR" MEANS AN INDIVIDUAL WHO

- 1 SUPERVISES A SOCIAL SERVICES WORKER. A SOCIAL SERVICES SUPERVISOR
- 2 MUST POSSESS EITHER A MASTER'S DEGREE IN A HUMAN BEHAVIORAL SCIENCE
- 3 FROM AN ACCREDITED COLLEGE OR UNIVERSITY AND 2 YEARS OF EXPERIENCE
- 4 AS A SOCIAL SERVICES WORKER OR A BACHELOR'S DEGREE IN A HUMAN
- 5 BEHAVIORAL SCIENCE OR ANOTHER MAJOR WITH 25% OF THE CREDITS IN A
- 6 HUMAN BEHAVIORAL SCIENCE FROM AN ACCREDITED COLLEGE OR UNIVERSITY

- 20 UNIVERSITY AND 3 YEARS OF WORK EXPERIENCE IN A CHILD CARING
- 21 INSTITUTION.
- 22 (iii) A HIGH SCHOOL DIPLOMA AND 4 YEARS OF WORK EXPERIENCE IN
- 23 A CHILD CARING INSTITUTION.
- Sec. 2e. (1) A minor child shall be released from personal
- 25 restraint or seclusion whenever the circumstance that justified the
- 26 use of personal restraint or seclusion no longer exists.
- 27 (2) Each instance of personal restraint or seclusion requires

- 1 full justification for its use, and the results of the evaluation
- 2 immediately following the use of personal restraint or seclusion
- 3 shall be placed in the minor child's record.
- 4 (3) Each order for personal restraint or seclusion shall
- 5 include all of the following:
- **6** (a) The name of the licensed practitioner ordering personal
- 7 restraint or seclusion.

- 27 (5) The child caring institution staff trained in the use of

- 1 personal restraint shall continually assess and monitor the
- 2 physical and psychological well-being of the minor child and the
- 3 safe use of personal restraint throughout the duration of its
- 4 implementation.
- 5 (6) The child caring institution staff trained in the use of
- 6 seclusion shall be physically present in or immediately outside the
- 7 seclusion room, continually assessing, monitoring, and evaluating
- 8 the physical and psychological well-being of the minor. Video
- 9 monitoring shall not be exclusively used to meet this requirement.
- 10 (7) The child caring institution staff shall ensure that
- 11 documentation of staff monitoring and observation is entered into
- 12 the minor child's record.
- 13 (8) If the emergency safety intervention continues beyond the
- 14 time limit of the order for use of personal restraint or seclusion,
- 15 child caring institution staff authorized to receive verbal orders
- 16 for personal restraint or seclusion shall immediately contact the
- 17 licensed practitioner to receive further instructions.
- 18 (9) The child caring institution staff shall notify the minor
- 19 child's parent or legal guardian and the appropriate state or local
- 20 government agency that has responsibility for the minor child if
- 21 the minor child is under the supervision of the child caring
- 22 institution as a result of an order of commitment by the family
- 23 division of circuit court to a state institution or otherwise as
- 24 soon as possible after the initiation of personal restraint or
- 25 seclusion. This notification shall be documented in the minor
- 26 child's record, including the date and time of the notification,
- 27 the name of the staff person providing the notification, and the

- 1 name of the person to whom notification of the incident was
- 2 reported. The child caring institution is not required to notify
- 3 the parent or legal guardian as provided in this subsection if the
- 4 minor child is within the care and supervision of the child caring
- 5 institution as a result of an order of commitment of the family

- 7 otherwise, and has been adjudged to be dependent, neglected, or

- 10 treatment plan indicates that the notice would not be in the minor
- 11 child's best interest.
- 12 (10) Within 24 hours after the use of personal restraint or
- 13 seclusion, child caring institution staff involved in the emergency
- 14 safety intervention and the minor child shall have a face-to-face
- 15 debriefing session. The debriefing shall include all staff involved
- 16 in the seclusion or personal restraint except if the presence of a
- 17 particular staff person may jeopardize the well-being of the minor
- 18 child. Other staff members and the minor child's parent or legal
- 19 guardian may participate in the debriefing if it is considered
- 20 appropriate by the child caring institution.
- 21 (11) The child caring institution shall conduct a debriefing
- 22 in a language that is understood by the minor child. The debriefing
- 23 shall provide both the minor child and the staff opportunity to
- 24 discuss the circumstances resulting in the use of personal
- 25 restraint or seclusion and strategies to be used by staff, the
- 26 minor child, or others that could prevent the future use of
- 27 personal restraint or seclusion.

- 1 (12) Within 24 hours after the use of personal restraint or
- 2 seclusion, all child caring institution staff involved in the
- 3 emergency safety intervention, and appropriate supervisory and
- 4 administrative staff, shall conduct a debriefing session that
- 5 includes, at a minimum, all of the following:
- 6 (a) Discussion of the emergency safety situation that required
- 7 personal restraint or seclusion, including a discussion of
- 8 precipitating factors that led up to the situation.
- 9 (b) Alternative techniques that might have prevented the use
- 10 of personal restraint or seclusion.
- 11 (c) The procedures, if any, that child caring institution
- 12 staff are to implement to prevent a recurrence of the use of
- 13 personal restraint or seclusion.
- 14 (d) The outcome of the emergency safety intervention,
- 15 including any injury that may have resulted from the use of
- 16 personal restraint or seclusion.
- 17 (13) The child caring institution staff shall document in the
- 18 minor child's record that both debriefing sessions AS DESCRIBED IN
- 19 SUBSECTIONS (10) AND (12) took place and shall include the names of
- 20 staff who were present for the debriefings, names of staff that
- 21 were excused from the debriefings, and changes to the minor child's
- 22 treatment plan that result from the debriefings.
- 23 (14) Each child caring institution subject to this section and
- 24 sections 2c and 2d shall report each serious occurrence to the
- 25 state agency licensing the child caring institution. DEPARTMENT.
- 26 The state agency licensing the child caring institution DEPARTMENT
- 27 shall make the reports available to the designated state protection

- 1 and advocacy system upon request of the designated state protection
- 2 and advocacy system. Serious occurrences to be reported include a
- 3 minor child's death, a serious injury to a minor child, and a minor

- 11 the number of hours of service performed in connection with the
- 12 adoption, and the total cost of the attorney's services performed

- 17 care service providers with contact information and shall do at

- 23 agency may decide not to accept the referral if the services would
- 24 conflict with the child placing agency's sincerely held religious
- 25 beliefs contained in a written policy, statement of faith, or other
- 26 document adhered to by the child placing agency. Before accepting a
- 27 referral for services under a contract with the department, the

- 1 child placing agency has the sole discretion to decide whether to
- 2 engage in activities and perform services related to that referral.
- 3 The department shall not control the child placing agency's
- 4 decision whether to engage in those activities or perform those
- 5 services. For purposes of this subsection, a child placing agency
- 6 accepts a referral by doing either of the following:
- 7 (a) Submitting to the department a written agreement to
- 8 perform the services related to the particular child or particular
- 9 individuals that the department referred to the child placing
- 10 agency.
- 11 (b) Engaging in any other activity that results in the
- 12 department being obligated to pay the child placing agency for the
- 13 services related to the particular child or particular individuals
- 14 that the department referred to the child placing agency.
- 15 (2) The state or a local unit of government shall not take an
- 16 adverse action against a child placing agency on the basis that the
- 17 child placing agency has decided to accept or not accept a referral
- 18 under subsection (1).
- 19 (3) If a child placing agency decides not to accept a referral
- 20 under subsection (1), that occurrence shall not be a factor in
- 21 determining whether a placement in connection with the referral is
- 22 in the best interest of the child.
- 23 (4) A child placing agency may assert a defense in an
- 24 administrative or judicial proceeding based on this section.
- 25 (5) For the purpose of this section, "adverse action"
- 26 includes, but is not limited to, denying a child placing agency's
- 27 application for funding, refusing to renew the child placing

- 1 agency's funding, canceling the child placing agency's funding,
- 2 declining to enter into a contract with the child placing agency,
- 3 refusing to renew a contract with the child placing agency,
- 4 canceling a contract with the child placing agency, declining to
- 5 issue a license to the child placing agency, refusing to renew the
- 6 child placing agency's license, canceling the child placing
- 7 agency's license, taking an enforcement action against a child
- 8 placing agency, discriminating against the child placing agency in
- 9 regard to participation in a government program, and taking any
- 10 action that materially alters the terms or conditions of the child
- 11 placing agency's funding, contract, or license.
- Sec. 15. (1) Except as provided in subsection (2), a person,
- 13 child care organization, agency, or representative or officer of a
- 14 firm, A corporation, AN association, or AN organization who
- 15 violates this act is guilty of a misdemeanor punishable by the
- 16 following:
- 17 (a) A fine of not less than \$100.00 or more than \$1,000.00 for
- 18 a violation of section 3b, 3c, or 3d.
- 19 (b) For a violation not described in either subdivision (a) or
- 20 subsection (2), a fine of not less than \$100.00 or more than
- 21 \$1,000.00, or imprisonment for not more than 90 days, or both.
- 22 (2) If a person, family child care home, group child care
- 23 home, agency, or representative or officer of a firm, A
- 24 corporation, AN association, or AN organization intentionally
- 25 violates a licensing rule for family and group child care homes
- 26 promulgated under this act and in effect on January 1, 2017, and
- 27 that violation causes the death of a child, the person, family

- 1 child care home, group child care home, agency, or representative
- 2 or officer of a firm, A corporation, AN association, or AN
- 3 organization is guilty of second degree child abuse described in
- 4 section 136b of the Michigan penal code, 1931 PA 328, MCL 750.136b,
- 5 and punishable as provided in that section. In addition to any
- 6 other penalty imposed, its license or certificate of registration
- 7 shall be permanently revoked.
- 8 (3) If a person, child care organization, agency, or
- 9 representative or officer of a firm, A corporation, AN association,

- 9 (5) AS USED IN THIS SECTION, "CERTIFICATE OF REGISTRATION"
- 10 MEANS THE WRITTEN DOCUMENT ISSUED PREVIOUSLY UNDER THIS ACT TO A
- 11 FAMILY CHILD CARE HOME THROUGH REGISTRATION.
