SUBSTITUTE FOR

SENATE BILL NO. 368

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 136.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 136. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A
- 2 PERSON SHALL NOT KNOWINGLY PERFORM A SURGICAL OPERATION TO
- 3 CIRCUMCISE, INCISE, EXCISE, OR INFIBULATE ALL OR ANY PART OF THE
- 4 LABIA MAJORA OR LABIA MINORA, CLITORIS, OR CONTIGUOUSLY SURROUNDING
- 5 TISSUE ON ANOTHER PERSON WHO IS LESS THAN 18 YEARS OF AGE,
- 6 REGARDLESS OF WHETHER THE SURGICAL OPERATION CAUSES PHYSICAL
- 7 DEFORMITY, RESIDUAL PAIN, OR LOSS OF SENSATION.
- 8 (2) A PERSON WHO VIOLATES SUBSECTION (1) IS GUILTY OF A FELONY
- 9 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 15 YEARS.

- 1 (3) A SURGICAL OPERATION IS NOT A VIOLATION OF THIS SECTION IF
- 2 EITHER OF THE FOLLOWING CONDITIONS APPLIES:
- 3 (A) IT IS NECESSARY TO THE HEALTH OF THE PERSON ON WHOM IT IS
- 4 PERFORMED, AND IT IS PERFORMED BY A LICENSED MEDICAL PRACTITIONER.
- 5 (B) IT IS PERFORMED ON A PERSON IN LABOR OR WHO HAS JUST GIVEN
- 6 BIRTH AND IS PERFORMED FOR MEDICAL PURPOSES CONNECTED WITH THAT
- 7 LABOR OR BIRTH BY A LICENSED MEDICAL PRACTITIONER, MIDWIFE, OR
- 8 PERSON IN TRAINING TO BECOME A LICENSED MEDICAL PRACTITIONER OR
- 9 LICENSED MIDWIFE.
- 10 (4) A BELIEF OF A PERSON ON WHOM THE OPERATION IS PERFORMED OR
- 11 IS TO BE PERFORMED, OR OF ANY OTHER PERSON, THAT THE OPERATION IS
- 12 REQUIRED AS A MATTER OF CUSTOM OR RITUAL IS NOT A DEFENSE TO
- 13 PROSECUTION UNDER THIS SECTION.
- 14 (5) A PERSON SHALL NOT KNOWINGLY TRANSPORT A PERSON FROM THIS
- 15 STATE FOR THE PURPOSE OF CONDUCT WITH REGARD TO THAT PERSON THAT
- 16 WOULD BE A VIOLATION OF THIS SECTION IF THE CONDUCT OCCURRED IN
- 17 THIS STATE.
- 18 (6) AS USED IN THIS SECTION:
- 19 (A) "LICENSED MEDICAL PRACTITIONER" MEANS A MEDICAL PHYSICIAN
- 20 OR OSTEOPATHIC PHYSICIAN WHO IS LICENSED UNDER ARTICLE 15 OF THE
- 21 PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.16101 TO 333.18838.
- 22 (B) "LICENSED MIDWIFE" MEANS A MIDWIFE LICENSED UNDER ARTICLE
- 23 15 OF THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.16101 TO
- 24 333.18838.
- 25 (C) "PERSON IN TRAINING" MEANS AN INDIVIDUAL ACTING UNDER THE
- 26 DELEGATORY AUTHORITY AND SUPERVISION OF A PHYSICIAN UNDER SECTION
- 27 16215(2) OF THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.16215.

- PERSON IN TRAINING INCLUDES, BUT IS NOT LIMITED TO, AN INDIVIDUAL 1
- 2 DESCRIBED IN SECTION 16215(3) OF THE PUBLIC HEALTH CODE, 1978 PA
- 368, MCL 333.16215, BUT DOES NOT INCLUDE AN INDIVIDUAL WHOSE 3
- LICENSE HAS BEEN SUSPENDED UNDER ARTICLE 15.
- 5 Enacting section 1. This amendatory act takes effect 90 days
- after the date it is enacted into law.
