SUBSTITUTE FOR

SENATE BILL NO. 520

A bill to amend 1962 PA 174, entitled "Uniform commercial code,"

by amending section 9523 (MCL 440.9523), as added by 2000 PA 348.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 9523. (1) If a person that files a written record
- 2 requests an acknowledgment of the filing, the filing office shall
- 3 send to the person an image of the record showing the number
- 4 assigned to the record pursuant to section 9519(1)(a) and the date
- 5 and time of the filing of the record. However, if the person
- 6 furnishes a copy of the record to the filing office, the filing
- 7 office may instead do both of the following:
- 8 (a) Note upon the copy the number assigned to the record
- 9 pursuant to section 9519(1)(a) and the date and time of the filing
- 10 of the record.

- 1 (b) Send the copy to the person.
- 2 (2) If a person files a record other than a written record,
- 3 the filing office shall communicate to the person an acknowledgment
- 4 that provides all of the following:
- 5 (a) The information in the record.
- 6 (b) The number assigned to the record pursuant to section
- **7** 9519(1)(a).
- 8 (c) The date and time of the filing of the record.
- 9 (3) The filing office shall communicate or otherwise make
- 10 available in a record 1 or more of the following information to any
- 11 person that requests it:
- 12 (a) Whether there is on file on a date and time specified by
- 13 the filing office, but not a date earlier than 3 business days
- 14 before the filing office receives the request, any financing
- 15 statement that meets all of the following:
- 16 (i) Designates a particular debtor or, if the request so
- 17 states, designates a particular debtor at the address specified in
- 18 the request.
- 19 (ii) Has not lapsed under section 9515 with respect to all
- 20 secured parties of record.
- 21 (iii) If the request so states, has lapsed under section 9515
- 22 and a record of which is maintained by the filing office under
- 23 section 9522(1).
- 24 (b) The date and time of filing of each financing statement.
- (c) The information provided in each financing statement.
- 26 (4) In complying with its duty under subsection (3), the
- 27 filing office may communicate information in any medium. However,

- 1 if requested, the filing office shall communicate information by
- 2 issuing its written certificate or another record that can be
- 3 admitted into evidence in the courts of this state without
- 4 extrinsic evidence of its authenticity.
- 5 (5) The filing office shall perform the acts required by
- 6 subsections (1) through (4) at the time and in the manner
- 7 prescribed by filing-office rule, but, in the case of a filing
- 8 office described in section 9501(1)(b), not later than 2 business
- 9 days after the filing office receives the request.
- 10 (6) At least weekly, at the per record rate under section
- 11 9525, the filing office NOT LATER THAN JANUARY 1, 2018, THE
- 12 SECRETARY OF STATE shall offer to sell or license to the public on
- 13 a nonexclusive basis, in bulk, copies BY SUBSCRIPTION, IMAGES of
- 14 all records filed in it under this part EACH MONTH, OR BULK DATA
- 15 FROM THE FILED RECORDS, IN A FORMAT ESTABLISHED BY THE SECRETARY OF
- 16 STATE AND in every medium from time to time 1 OR MORE MEDIUMS
- 17 available to the filing office. SECRETARY OF STATE. THE SECRETARY OF
- 18 STATE SHALL CHARGE A SUBSCRIPTION FEE OF \$500.00 PER MONTH TO A
- 19 PERSON THAT SUBSCRIBES TO RECEIVE IMAGES OR DATA UNDER THIS
- 20 SUBSECTION.
