SUBSTITUTE FOR

HOUSE BILL NO. 5408

A bill to amend 1951 PA 51, entitled

"An act to provide for the classification of all public roads, streets, and highways in this state, and for the revision of that classification and for additions to and deletions from each classification; to set up and establish the Michigan transportation fund; to provide for the deposits in the Michigan transportation fund of specific taxes on motor vehicles and motor vehicle fuels; to provide for the allocation of funds from the Michigan transportation fund and the use and administration of the fund for transportation purposes; to promote safe and efficient travel for motor vehicle drivers, bicyclists, pedestrians, and other legal users of roads, streets, and highways; to set up and establish the truck safety fund; to provide for the allocation of funds from the truck safety fund and administration of the fund for truck safety purposes; to set up and establish the Michigan truck safety commission; to establish certain standards for road contracts for certain businesses; to provide for the continuing review of transportation needs within the state; to authorize the state transportation commission, counties, cities, and villages to borrow money, issue bonds, and make pledges of funds for transportation purposes; to authorize counties to advance funds for the payment of deficiencies necessary for the payment of bonds issued under this act; to provide for the limitations, payment, retirement, and security of the bonds and pledges; to provide for appropriations and tax levies by counties and townships for county roads; to authorize contributions by townships for county roads; to provide for the establishment and administration of the state trunk line

fund, local bridge fund, comprehensive transportation fund, and certain other funds; to provide for the deposits in the state trunk line fund, critical bridge fund, comprehensive transportation fund, and certain other funds of money raised by specific taxes and fees; to provide for definitions of public transportation functions and criteria; to define the purposes for which Michigan transportation funds may be allocated; to provide for Michigan transportation fund grants; to provide for review and approval of transportation programs; to provide for submission of annual legislative requests and reports; to provide for the establishment and functions of certain advisory entities; to provide for conditions for grants; to provide for the issuance of bonds and notes for transportation purposes; to provide for the powers and duties of certain state and local agencies and officials; to provide for the making of loans for transportation purposes by the state transportation department and for the receipt and repayment by local units and agencies of those loans from certain specified sources; and to repeal acts and parts of acts,"

by amending section 9a (MCL 247.659a), as amended by 2012 PA 298.

- 2 (a) "Asset management" means an ongoing process of
- 3 maintaining, PRESERVING, upgrading, and operating physical assets
- 4 cost-effectively, based on a continuous physical inventory and
- 5 condition assessment AND INVESTMENT TO ACHIEVE ESTABLISHED
- 6 PERFORMANCE GOALS.
- 7 (B) "ASSET MANAGEMENT PLAN" MEANS A PLAN CREATED BY THE
- 8 DEPARTMENT OR BY A LOCAL ROAD AGENCY AND APPROVED BY THE LOCAL ROAD
- 9 AGENCY'S GOVERNING BODY THAT INCLUDES PROVISIONS FOR ASSET
- 10 INVENTORY, PERFORMANCE GOALS, RISK OF FAILURE ANALYSIS, ANTICIPATED
- 11 REVENUES AND EXPENSES, PERFORMANCE OUTCOMES, AND COORDINATION WITH
- 12 OTHER INFRASTRUCTURE OWNERS.
- (C) (b)—"Bridge" means a structure including supports erected
- 14 over a depression or an obstruction, such as water, a highway, or a
- 15 railway, for the purposes of carrying traffic or other moving
- 16 loads, and having an opening measuring along the center of the

- 1 roadway of more than 20 feet between undercopings of abutments or
- 2 spring lines of arches, or extreme ends of openings for multiple
- 3 boxes where the clear distance between openings is less than 1/2 of
- 4 the smaller contiguous opening.
- 5 (D) (c) "Central storage data agency" means that AN agency or
- 6 office chosen by the council where the data collected is stored and
- 7 maintained.
- 8 (d) "Council" means the transportation asset management
- 9 council created by this section.
- (e) "Department" means the state transportation department.
- 11 (f) "Federal-aid eligible" means a public road or bridge that
- 12 is eliqible for federal aid to be spent for the construction,
- 13 repair, or maintenance of that road or bridge.
- 14 (g) "Local road agency" means a county road commission or
- 15 designated county road agency or city or village that is
- 16 responsible for the construction or maintenance of public roads
- 17 within the state under this act.
- 18 (H) "MICHIGAN INFRASTRUCTURE COUNCIL" MEANS THE MICHIGAN
- 19 INFRASTRUCTURE COUNCIL CREATED IN SECTION 3 OF THE MICHIGAN
- 20 INFRASTRUCTURE COUNCIL ACT.
- 21 (I) (h)—"Multiyear program" means a compilation of road and
- 22 bridge projects anticipated to be contracted for by the department
- 23 or a local road agency during a 3-year period. The multiyear
- 24 program shall include a listing of each project to be funded in
- 25 whole or in part with state or federal funds.
- 26 (J) "REGION" MEANS THE GEOGRAPHIC JURISDICTION OF ANY OF THE
- 27 FOLLOWING:

- 14 (K) (i) "State planning and development regions" means those
- 15 agencies required by section 134 of title 23 of the United States
- 16 Code, 23 USC 134, and those agencies established by Executive

- 18 (l) "WATER ASSET MANAGEMENT COUNCIL" MEANS THE WATER ASSET
- 19 MANAGEMENT COUNCIL CREATED IN SECTION 5002 OF THE NATURAL RESOURCES
- 20 AND ENVIRONMENTAL PROTECTION ACT, 1994 PA 451, MCL 324.5002.
- 21 (2) In order to provide a coordinated, unified effort by the
- 22 various roadway ROAD agencies within the THIS state, the
- 23 transportation asset management council is hereby created within
- 24 the state transportation commission. and is charged with advising
- 25 UPON CREATION OF THE MICHIGAN INFRASTRUCTURE COUNCIL, THE
- 26 TRANSPORTATION ASSET MANAGEMENT COUNCIL SHALL BE PLACED WITHIN THE
- 27 MICHIGAN INFRASTRUCTURE COUNCIL.

- 1 (3) THE TRANSPORTATION ASSET MANAGEMENT COUNCIL SHALL ADVISE

- 12 (4) The TRANSPORTATION ASSET MANAGEMENT council shall consist
- 13 of 10 voting members appointed by the state transportation
- 14 commission. The TRANSPORTATION ASSET MANAGEMENT council shall
- 15 include 2 members from the county road association COUNTY ROAD
- 16 ASSOCIATION of Michigan, 2 members from the Michigan municipal
- 17 league, MUNICIPAL LEAGUE, 2 members from the state planning and
- 18 development regions, 1 member from the Michigan townships
- 19 association, TOWNSHIPS ASSOCIATION, 1 member from the Michigan
- 20 association ASSOCIATION of counties, COUNTIES, and 2 members from
- 21 the department. Nonvoting members shall include 1 person from the
- 22 agency or office selected as the location for central data storage.
- 23 Each agency with voting rights shall submit a list of 2 nominees to
- 24 the state transportation commission from which the appointments
- 25 shall be made. The Michigan townships association TOWNSHIPS
- 26 ASSOCIATION shall submit 1 name, and the Michigan association
- 27 ASSOCIATION of counties COUNTIES shall submit 1 name. Names shall

- 1 be submitted within 30 days after July 3, 2002. The state
- 2 transportation commission shall make the appointments within 30
- 3 days after receipt of the lists.
- 4 (5) (3) The positions for the department ON THE TRANSPORTATION
- 5 ASSET MANAGEMENT COUNCIL shall be permanent. The position of the
- 6 central data storage agency shall be nonvoting and shall be for as
- 7 long as the agency continues to serve as the data storage
- 8 repository. The member from the Michigan association ASSOCIATION of
- 9 counties COUNTIES shall be initially appointed for 2 years. The
- 10 member from the Michigan townships association TOWNSHIPS
- 11 ASSOCIATION shall be initially appointed for 3 years. Of the
- 12 members first appointed from the county road association COUNTY
- 13 ROAD ASSOCIATION of Michigan, the Michigan municipal league,
- 14 MUNICIPAL LEAGUE, and the state planning and development regions, 1
- 15 member of each group shall be appointed for 2 years and 1 member of
- 16 each group shall be appointed for 3 years. At the end of the
- 17 initial appointment, all terms shall be for 3 years. The
- 18 chairperson shall be selected from among the voting members of the
- 19 TRANSPORTATION ASSET MANAGEMENT council. A MEMBER OF THE
- 20 TRANSPORTATION ASSET MANAGEMENT COUNCIL MAY BE REMOVED FOR
- 21 INCOMPETENCE, DERELICTION OF DUTY, MALFEASANCE DURING HIS OR HER
- 22 TENURE IN OFFICE, OR ANY OTHER CAUSE CONSIDERED APPROPRIATE BY THE
- 23 MICHIGAN INFRASTRUCTURE COUNCIL.
- 24 (6) (4) The department shall provide qualified administrative
- 25 staff and the state planning and development regions shall provide
- 26 qualified technical assistance to the TRANSPORTATION ASSET
- 27 MANAGEMENT council.

(5) The council shall develop and present to the state 1 transportation commission for approval within 90 days after the 2 date of the first meeting the procedures and requirements that are 3 necessary for the administration of the asset management process. 4 5 The procedures and requirements developed and presented by the council shall, at a minimum, include the areas of training, data 6 storage and collection, reporting, development of a multiyear 7 program, budgeting and funding, and other issues related to asset 8 9 management. All quality control standards and protocols shall, at a minimum, be consistent with existing federal requirements and 10 11 regulations and existing government accounting standards. 12 - (6) The council may appoint a technical advisory panel whose 13 members shall be representatives from the transportation construction associations and related transportation road 14 15 interests. The asset management council shall select members to the 16 technical advisory panel from names submitted by the transportation 17 construction associations and related transportation road 18 interests. The technical advisory panel members shall be appointed 19 for 3 years. The asset management council shall determine the 20 research issues and assign projects to the technical advisory panel 21 to assist in the development of statewide policies. The technical advisory panel's recommendations shall be advisory only and are not 22 23 binding on the asset management council. - 5 ESTABLISHED BY THE TRANSPORTATION ASSET MANAGEMENT COUNCIL.

- 7 DESCRIBED IN SUBSECTION (11) (B) SHALL BEGIN SUBMITTING AN ASSET
- 8 MANAGEMENT PLAN TO THE TRANSPORTATION ASSET MANAGEMENT COUNCIL
- 9 ACCORDING TO THE 3-YEAR SCHEDULE DESCRIBED IN SUBSECTION (10). THE
- 10 ASSET MANAGEMENT PLAN SHALL COVER A PERIOD OF AT LEAST 3 YEARS, AND
- 11 SHALL BE CONSISTENT WITH A TEMPLATE PROVIDED BY THE TRANSPORTATION

- 13 ROAD SYSTEM OR CITY MAJOR STREET SYSTEM, AS APPLICABLE, SHALL NOT
- 14 SHIFT FUNDS DISTRIBUTED TO IT UNDER THIS ACT FROM A COUNTY PRIMARY
- 15 ROAD SYSTEM TO A COUNTY LOCAL ROAD SYSTEM OR FROM A CITY MAJOR
- 16 STREET SYSTEM TO A CITY LOCAL STREET SYSTEM, AS APPLICABLE. A LOCAL
- 17 ROAD AGENCY MAY SUBMIT A REVISED ASSET MANAGEMENT PLAN TO THE
- 18 TRANSPORTATION ASSET MANAGEMENT COUNCIL.
- 19 (15) AN ANNUAL REPORT SHALL BE PREPARED BY THE STAFF ASSIGNED
- 20 TO THE TRANSPORTATION ASSET MANAGEMENT COUNCIL REGARDING THE
- 21 RESULTS OF ACTIVITIES CONDUCTED DURING THE PRECEDING YEAR AND THE
- 22 EXPENDITURE OF FUNDS RELATED TO THE PROCESSES AND ACTIVITIES
- 23 IDENTIFIED BY THE MICHIGAN INFRASTRUCTURE COUNCIL. THE REPORT SHALL
- 24 ALSO INCLUDE A SUMMARY ANALYSIS OF THE ASSET MANAGEMENT PLANS AND
- 25 ANNUAL REPORTS RECEIVED FROM LOCAL ROAD AGENCIES, A DETERMINATION
- 26 OF HOW INVESTMENTS ARE ACHIEVING DESIRED LEVELS OF SERVICE AND
- 27 PERFORMANCE GOALS, AN IDENTIFICATION OF ANY ADDITIONAL STEPS THAT

- 1 MAY BE NEEDED TO ACHIEVE DESIRED LEVELS OF SERVICE AND PERFORMANCE
- 2 GOALS, AND AN OVERVIEW OF THE ACTIVITIES IDENTIFIED FOR THE
- 3 SUCCEEDING YEAR. THE TRANSPORTATION ASSET MANAGEMENT COUNCIL SHALL
- 4 SUBMIT THIS REPORT TO THE MICHIGAN INFRASTRUCTURE COUNCIL, THE
- 5 STATE TRANSPORTATION COMMISSION, THE LEGISLATURE, AND THE
- 6 TRANSPORTATION COMMITTEES OF THE HOUSE AND SENATE BY MAY 2 OF EACH
- 7 YEAR.
- 8 (16) (8) Funding necessary to support the activities described
- 9 in this section shall be provided by an annual appropriation from
- 10 the Michigan transportation fund to the state transportation
- 11 commission. BEGINNING ON THE EFFECTIVE DATE OF THE AMENDATORY ACT
- 12 THAT AMENDED THIS SUBSECTION, THE ANNUAL APPROPRIATION PROVIDED FOR
- 13 IN THIS SUBSECTION SHALL BE ALLOCATED TO THE MICHIGAN
- 14 INFRASTRUCTURE COUNCIL AND SHALL BE USED TO SUPPORT THE ACTIVITIES
- 15 DESCRIBED IN THIS SECTION.
- 16 (17) (9) The department and each local road agency shall keep
- 17 accurate and uniform records on all road and bridge work performed
- 18 and funds expended for the purposes of this section, according to
- 19 the procedures developed by the TRANSPORTATION ASSET MANAGEMENT
- 20 council. Each local road agency and the department shall annually
- 21 report to the TRANSPORTATION ASSET MANAGEMENT council the mileage
- 22 and condition of the road and bridge system under their
- 23 jurisdiction and the receipts and disbursements of road and street
- 24 funds in the manner prescribed by the TRANSPORTATION ASSET
- 25 MANAGEMENT council, which shall be consistent with any current
- 26 accounting procedures. An annual report shall be prepared by the
- 27 staff assigned to the council regarding the results of activities

- 1 conducted during the preceding year and the expenditure of funds
- 2 related to the processes and activities identified by the council.
- 3 The report shall also include an overview of the activities
- 4 identified for the succeeding year. The council shall submit this
- 5 report to the state transportation commission, the legislature, and
- 6 the transportation committees of the house and senate by May 2 of
- 7 each year.
- 8 (18) A LOCAL ROAD AGENCY MAY SEEK AND USE FEDERAL GRANTS OR
- 9 LOANS TO ACHIEVE THE GOALS AND MANAGE THE ASSET INVENTORY DESCRIBED
- 10 IN ITS ASSET MANAGEMENT PLAN.
- 11 Enacting section 1. This amendatory act takes effect 90 days
- 12 after the date it is enacted into law.
- 13 Enacting section 2. This amendatory act does not take effect
- 14 unless all of the following bills of the 99th Legislature are
- 15 enacted into law:
