

HOUSE BILL No. 5411

January 16, 2018, Introduced by Rep. Barrett and referred to the Committee on Financial Liability Reform.

A bill to amend 1943 PA 240, entitled

"State employees' retirement act,"

by amending section 45 (MCL 38.45), as amended by 2002 PA 743.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 45. As used in **THIS SECTION AND** sections $45 \pm 6 \pm 46$ **AND** 47:
- 2 (a) "Covered position" means any of the following:
- 3 (i) On or after January 1, 1989, a position in the classified
- 4 civil service with a classification of corrections ANY OF THE

5 FOLLOWING:

- (A) CORRECTIONS officer. ; resident
- (B) RESIDENT unit officer. ; corrections
- (C) CORRECTIONS medical aide. ; corrections
- (D) CORRECTIONS shift supervisor. ; corrections
- (E) CORRECTIONS security specialist; deputy INSPECTOR.

- 1 (F) CORRECTIONS SECURITY REPRESENTATIVE.
- 2 (G) DEPUTY prison warden. ; or departmental
- 3 (H) **DEPARTMENTAL** administrator-prison warden.
- 4 (ii) On or after January 1, 1989, a position that is assigned
- 5 to a work station inside the security perimeter of a state
- 6 correctional facility designated as "medium", "close", or
- 7 "maximum".
- 8 (iii) On or after January 1, 1989, a position within a state
- 9 correctional facility that requires the employee to be in direct
- 10 contact with prisoners for more than 50% of the employee's work
- 11 time performing supervisory or disciplinary duties including 1 or
- 12 more of the following:
- 13 (A) Supervising prisoners in the performance of tasks.
- 14 (B) Supervising prisoners for the purpose of enforcing the
- 15 facility's rules.
- 16 (C) Direct participation in the disciplinary process.
- (iv) On or after January 1, 1989, a position with the center
- 18 for forensic psychiatry that is classified by civil service as
- 19 forensics security aide IIB, forensics security aide IIIB,
- 20 forensics security supervisor IVB, forensics security supervisor
- 21 VB, forensics security supervisor VIB, or forensics supervisor VII.
- (v) A position that was a covered position under this section
- 23 before January 1, 1989, that is excluded by subparagraphs (i) τ
- 24 (ii), (iii), and TO (iv), if and only as long as the person in the
- 25 position on January 1, 1989, continues in the position after
- 26 January 1, 1989.
- 27 (b) "Supplemental member" means a member who is employed in a

- 1 covered position.
- 2 (c) "Covered service" means credited service acquired in a
- 3 covered position.
- 4 (d) "Supplemental final average compensation" means 1/3 of the
- 5 compensation paid a supplemental member during the period of 3
- 6 consecutive years of the member's covered service producing the
- 7 highest average and contained within the member's last 10 years of
- 8 credited service immediately preceding the date the member's
- 9 employment in a covered position last terminates.
- 10 (e) "State correctional facility" means a facility under the
- 11 jurisdiction of the department of corrections that has a
- 12 designation of "maximum", "close", "medium", "minimum", "prison
- 13 camp", or "correction center".
